2.1 RF Output Power

Preliminary tests were performed in different data rate and recorded the RF output power in the following table:

Remark:

1. The data rate was set in 2Mbps for all the test items due to the highest RF output power.
2. The EUT is programmed to transmit signals continuously for all testing.

2.2 Test Mode

The EUT has been associated with peripherals pursuant to ANSI C63.4-2003 and configuration operated in a manner tended to maximize its emission characteristics in a typical application. Frequency range investigated: conduction (150 kHz to 30 MHz), radiation (9 kHz to the 10th harmonic of the highest fundamental frequency or to 40 GHz, whichever is lower).

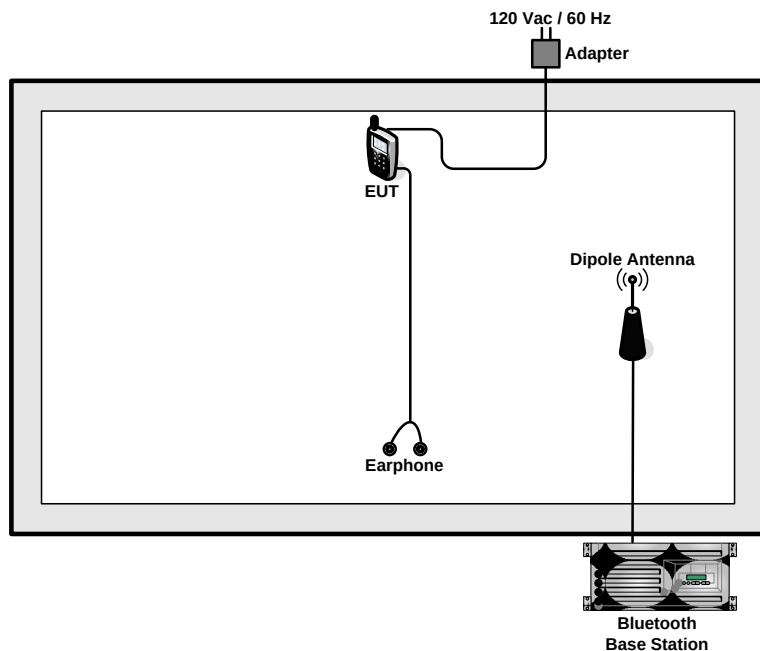
Pre-scanned tests, X, Y, Z in three orthogonal panels, were conducted to determine the final configuration from all possible combinations.

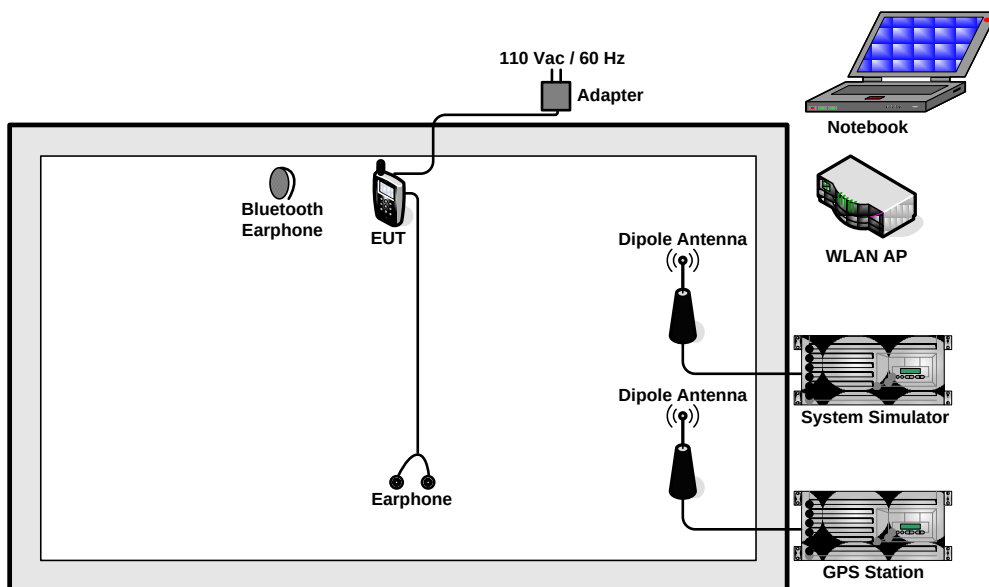

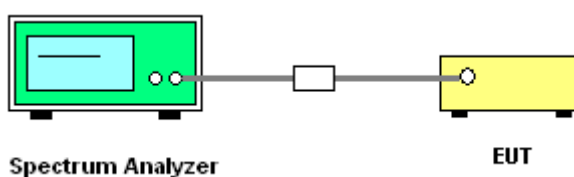

1. The testing follows FCC Public Notice DA 00-705 Measurement Guidelines.
2. The RF output of EUT was connected to the spectrum analyzer by a low loss cable.
3. The modulation types of EUT are irrelevant to number of hopping channels deviation.
4. The EUT must have its hopping function enabled. Use the following spectrum analyzer settings:
Span = the frequency band of operation; $RBW \geq 1\%$ of the span; $VBW \geq RBW$; Sweep = auto;
Detector function = peak; Trace = max hold.
5. The number of hopping frequency used is defined as the device has the numbers of total channel.

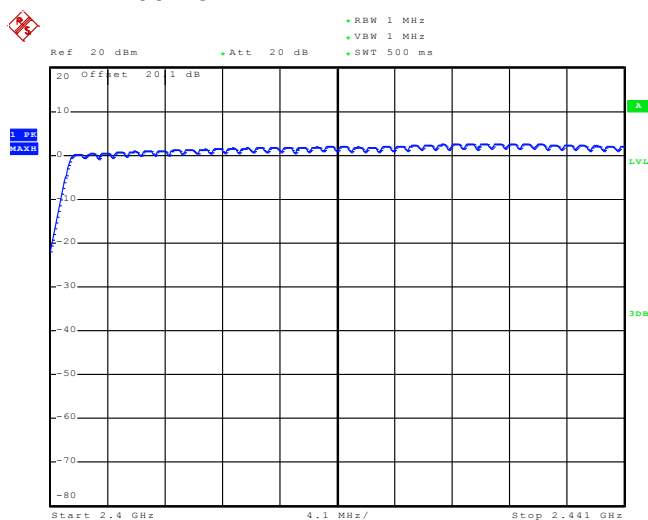

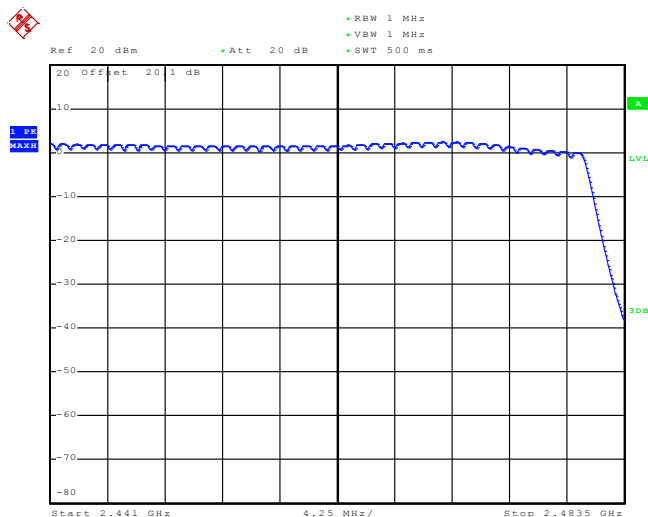

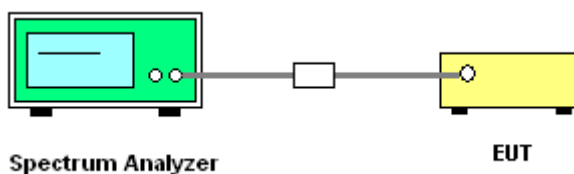

Span = approximately 2 to 3 times the 20 dB bandwidth, centered on a hopping channel;
RBW $\geq$ 1% of the 20 dB bandwidth; VBW $\geq$ RBW; Sweep = auto; Detector function = peak;
Trace = max hold.
5. The marker-delta reading at this point is the 20 dB bandwidth of the emission.

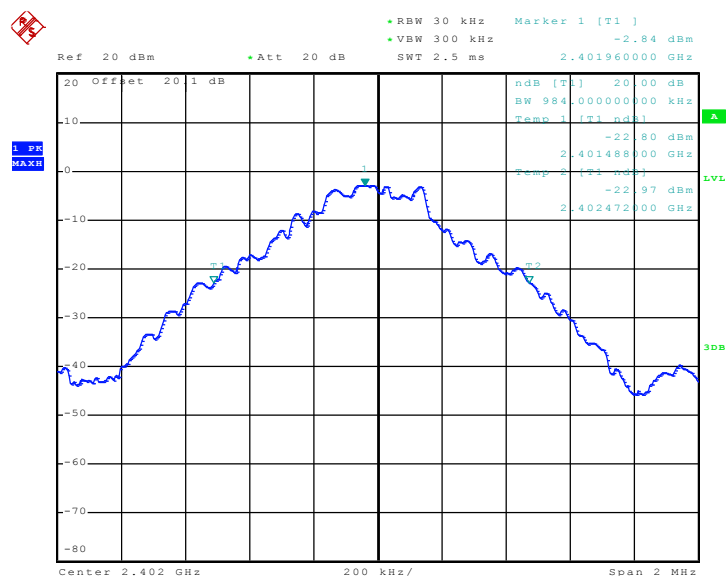

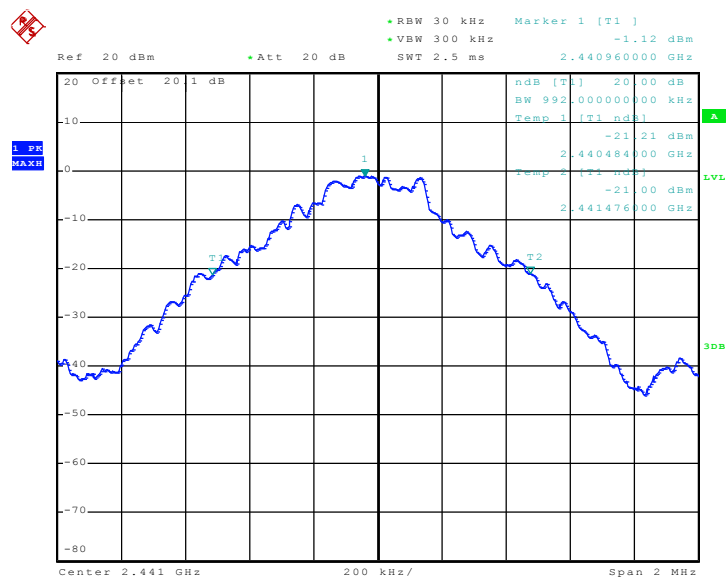
20 dB Bandwidth Plot on Channel 00

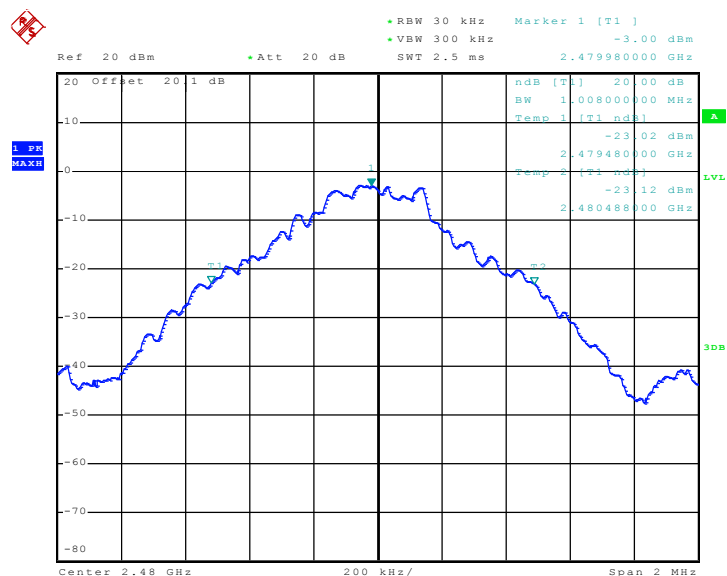


20 dB Bandwidth Plot on Channel 39

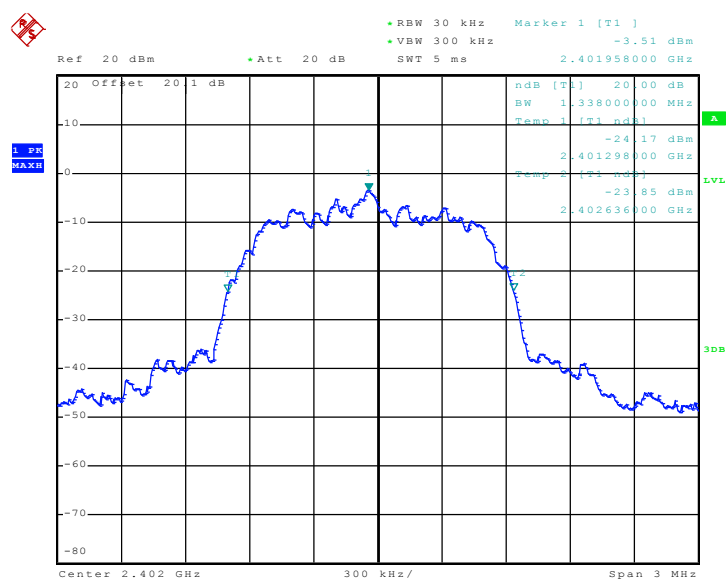
20 dB Bandwidth Plot on Channel 78

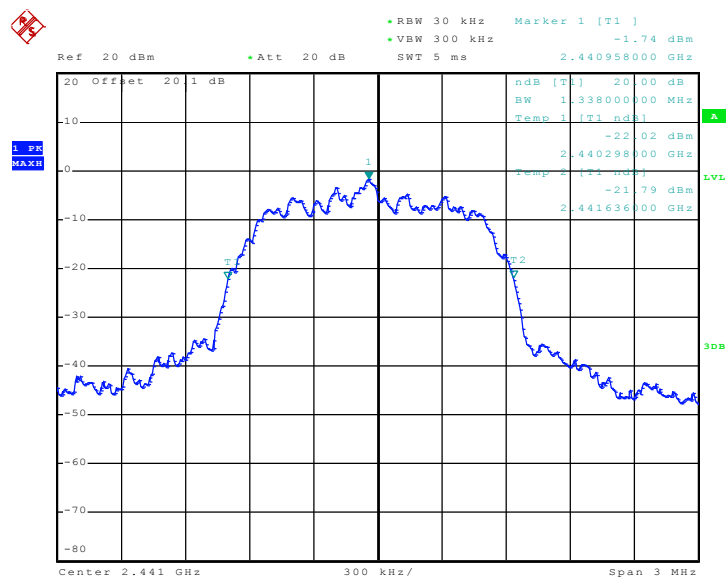

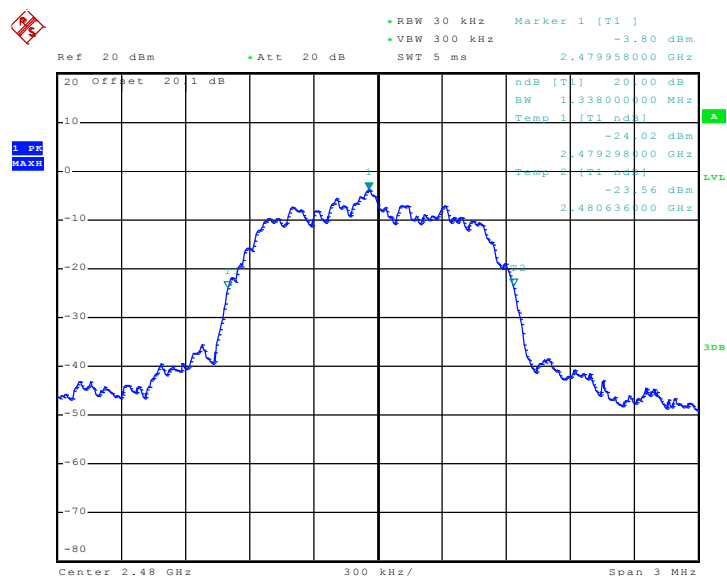


20 dB Bandwidth Plot on Channel 39

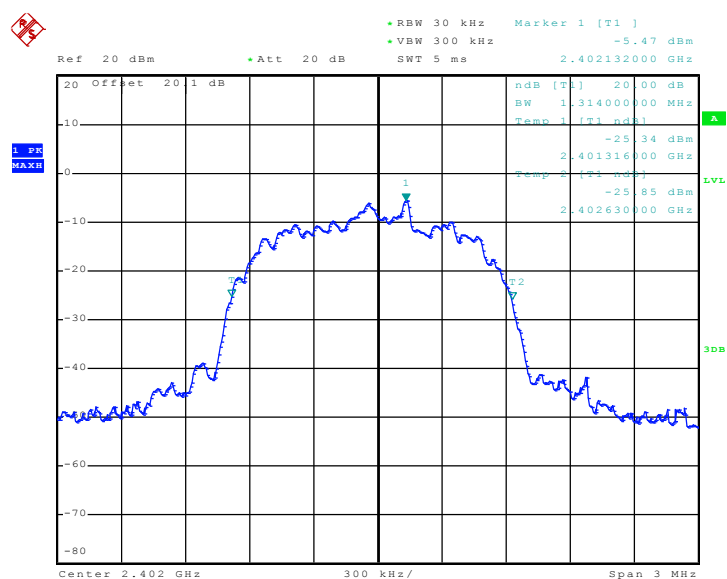
20 dB Bandwidth Plot on Channel 78



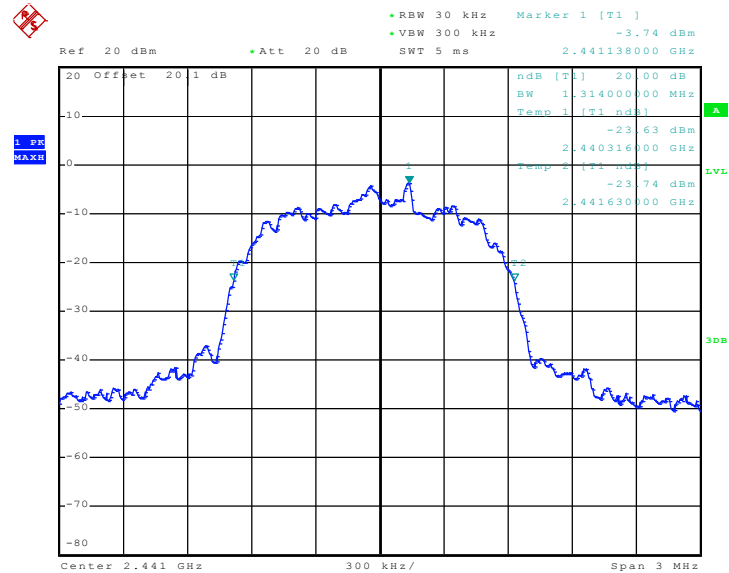

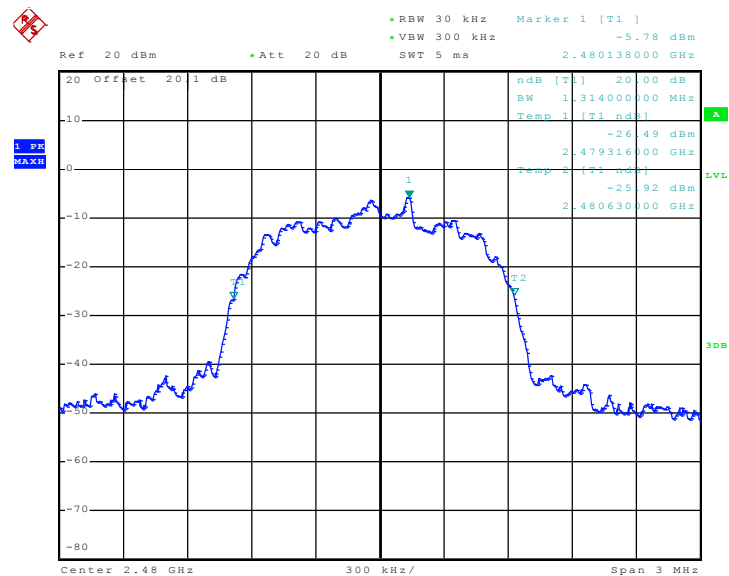

3.3 Hopping Channel Separation Measurement

3.3.1 Limit of Hopping Channel Separation

Frequency hopping systems operating in the 2400-2483.5 MHz band may have hopping channel carrier frequencies that are separated by 25 kHz or two-thirds of the 20 dB bandwidth of the hopping channel, whichever is greater.

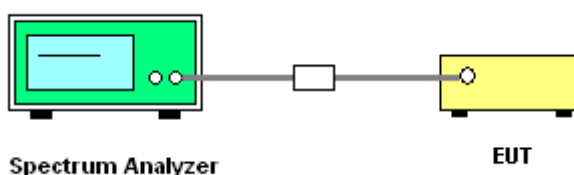

2. The RF output of EUT was connected to the spectrum analyzer by a low loss cable.
3. The EUT should be transmitting at its maximum data rate as the worst cases.
4. Use the following spectrum analyzer settings:
Span = wide enough to capture the peaks of two adjacent channels; RBW $\geq$ 1% of the span;
VBW $\geq$ RBW; Sweep = auto; Detector function = peak; Trace = max hold.
5. Use the marker-delta function to determine the separation between the peaks of the adjacent channels.

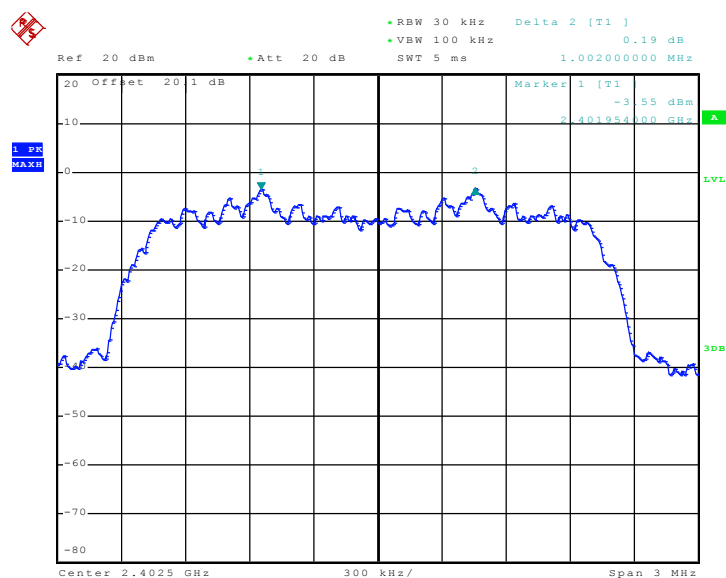

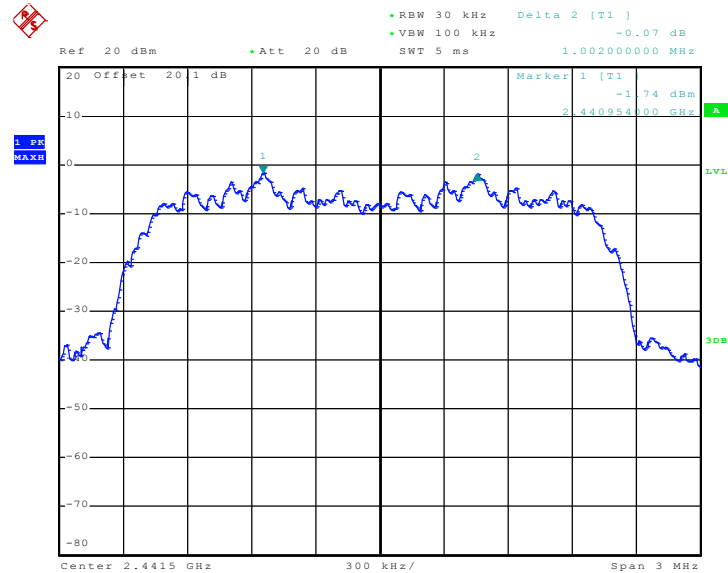

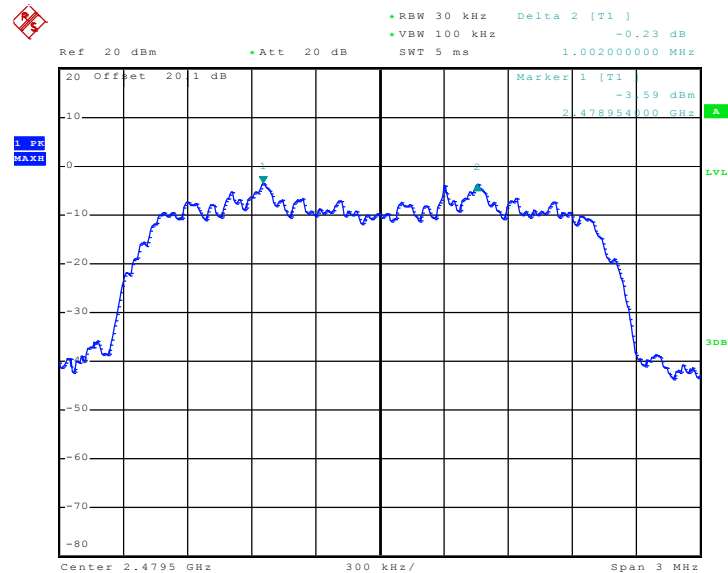
Channel Separation Plot on Channel 00 - 01

The average time of occupancy on any channel shall not be greater than 0.4 seconds within a period of 0.4 seconds multiplied by the number of hopping channels employed.

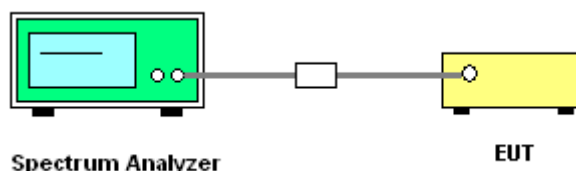

Span = zero span, centered on a hopping channel; RBW = 1 MHz; VBW $\geq$ RBW; Sweep = as necessary to capture the entire dwell time per hopping channel; Detector function = peak; Trace = max hold.
5. Use the marker-delta function to calculate the dwell time.

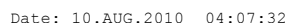

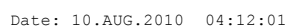

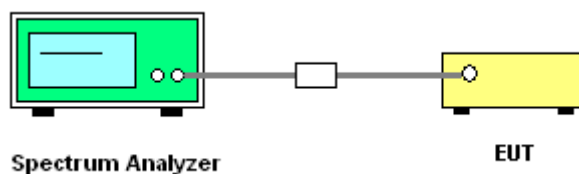

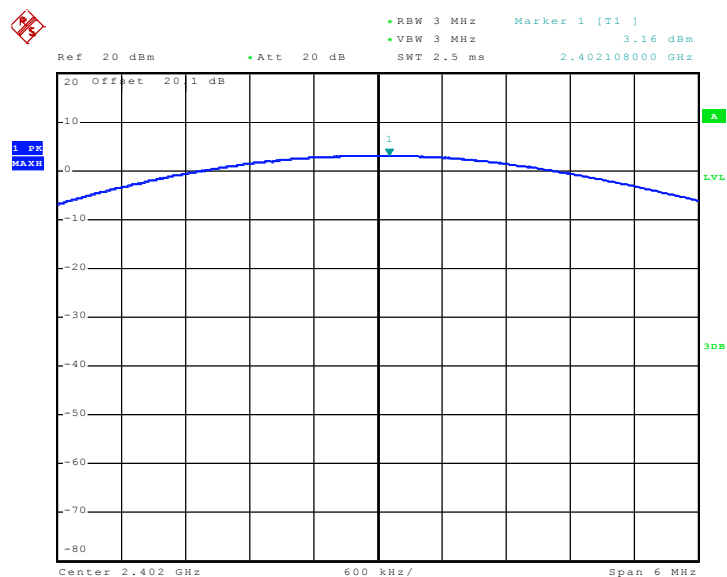

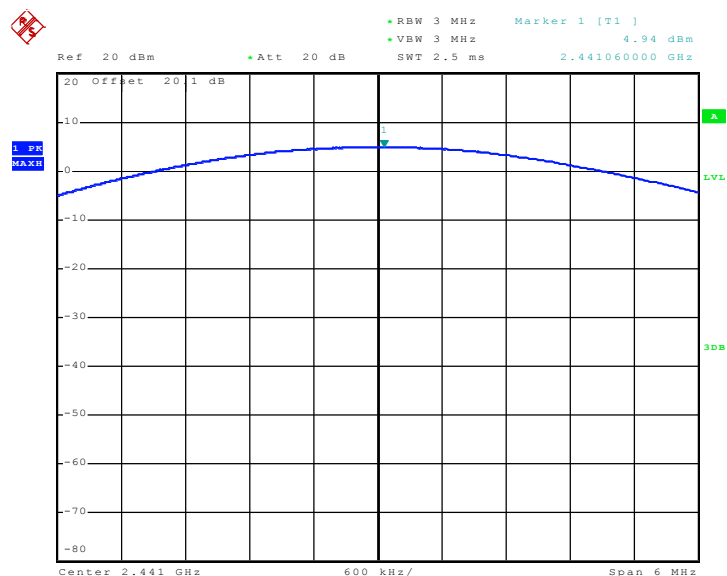

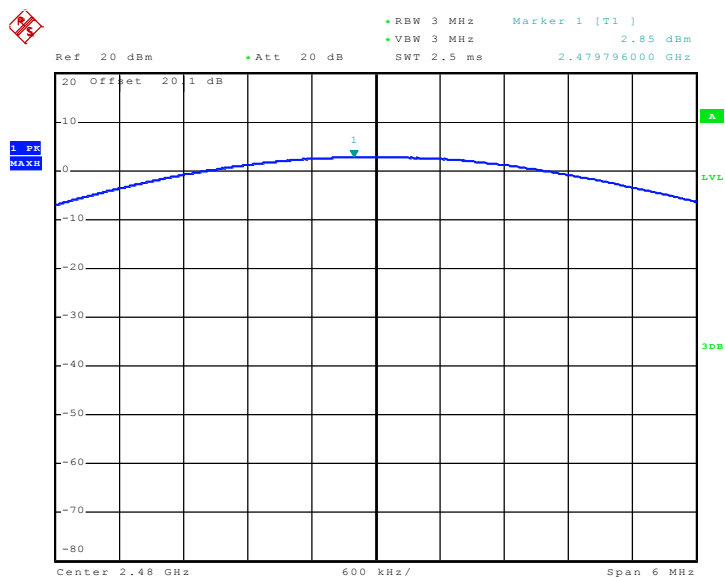
Peak Output Power Plot on Channel 39

3.6 Band Edges Measurement

3.6.1 Limit of Band Edges

In any 100 kHz bandwidth outside the intentional radiation frequency band, the radio frequency power shall be at least 20 dB below the highest level of the radiated power. In addition, radiated emissions which fall in the restricted bands must also comply with the radiated emission limits.

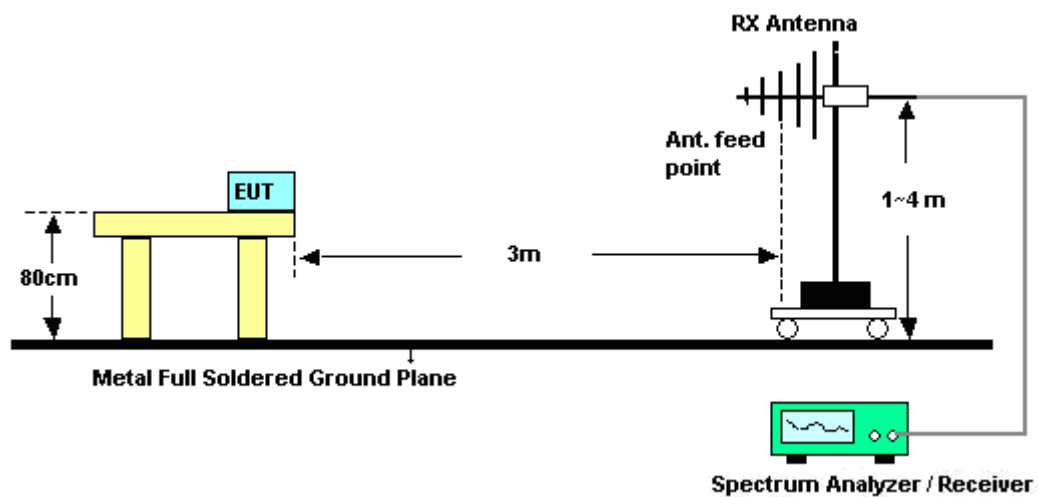

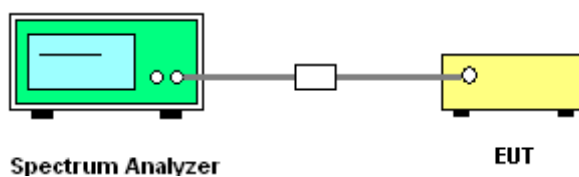
1. The testing follows the guidelines in ANSI C63.4-2003 and FCC Public Notice DA 00-705 Measurement Guidelines.
2. RF antenna conducted test: Set RBW = 300kHz, Video bandwidth (VBW) $\geq$ RBW. Band edge emissions must be at least 20 dB down from the highest emission level within the authorized band as measured with a 300k Hz RBW. Note: If the device complies with the use of power option 2 the attenuation under this paragraph shall be 30 dB instead of 20 dB.
3. Radiated emission test: Applies to band edge emissions that fall in the restricted bands listed in FCC Section 15.205. The maximum permitted average field strength is listed in FCC Section 15.209. A pre-amp is necessary for this measurement. For measurements above 1 GHz, set RBW = 1MHz, VBW = 1MHz, Sweep: Auto for Peak; set RBW = 1MHz, VBW = 10 Hz, Sweep: Auto for Average. If the emission is pulsed, modify the unit for continuous operation; use the settings shown above, then correct the reading by subtracting the peak-average correction factor, derived from the appropriate duty cycle calculation. See FCC Section 15.35(b) and (c).
4. In case the emission is fail due to the used RBW / VBW is too wide, marker-delta method of FCC Public Notice DA 00-705 will be followed.

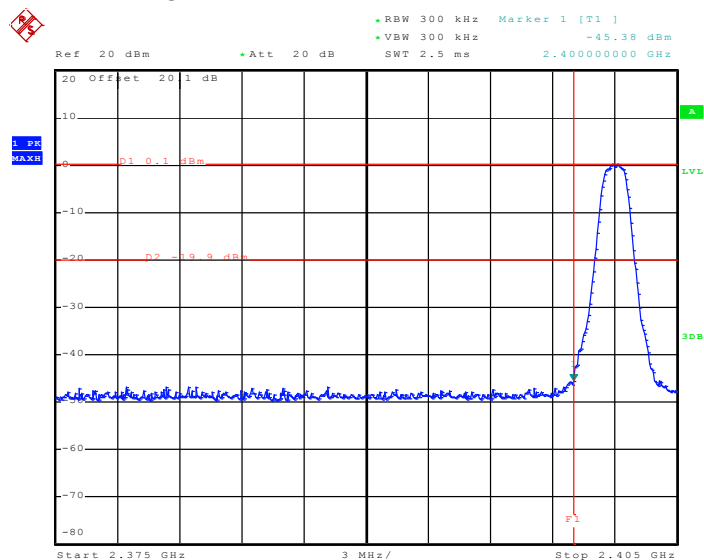

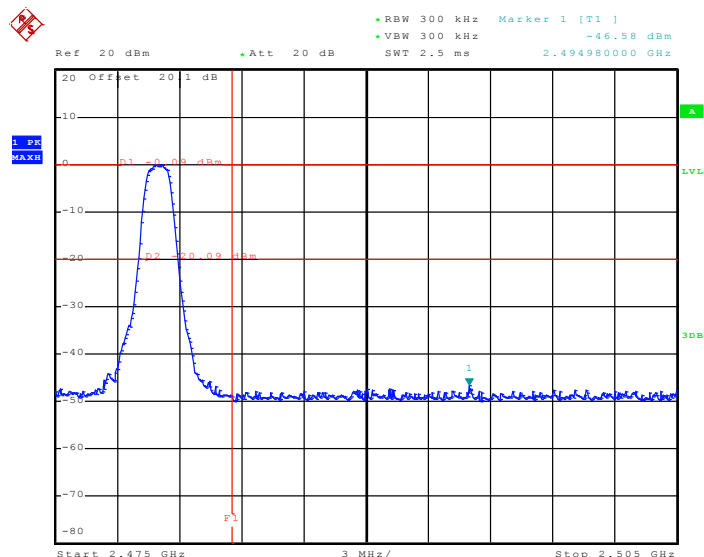

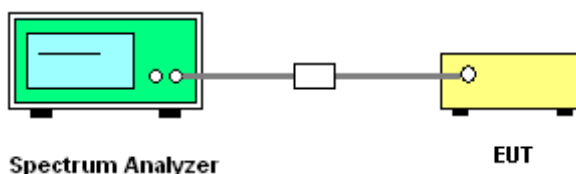

2. Set RBW = 100 kHz, Video bandwidth (VBW) $\geq$ RBW, scan up through 10th harmonic. All harmonics / spurs must be at least 20 dB down from the highest emission level within the authorized band as measured with a 100 kHz RBW.

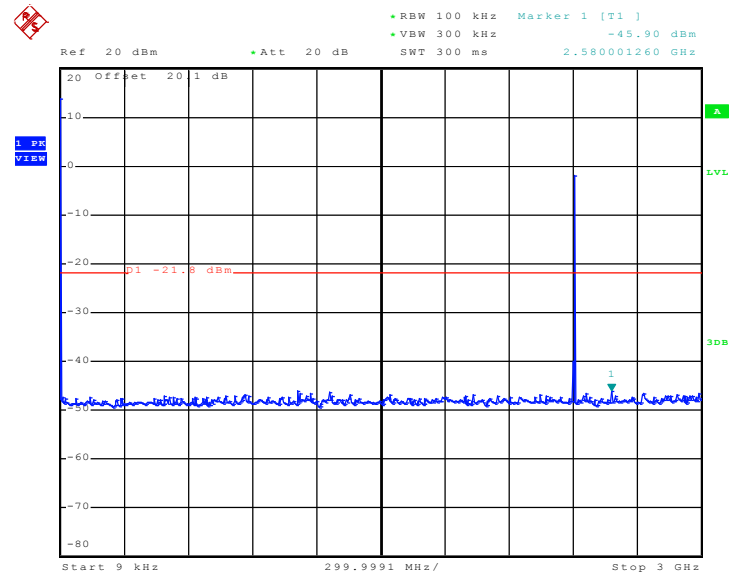

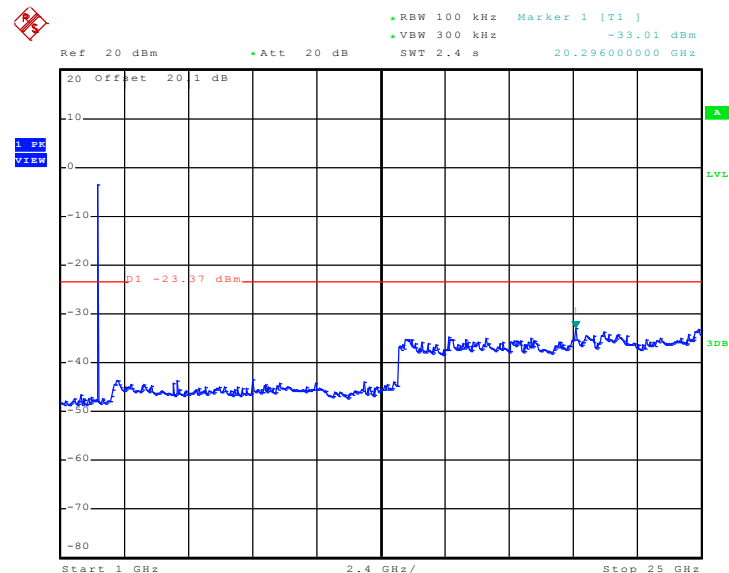

Conducted Spurious Emission Plot between 9 kHz ~ 3 GHz



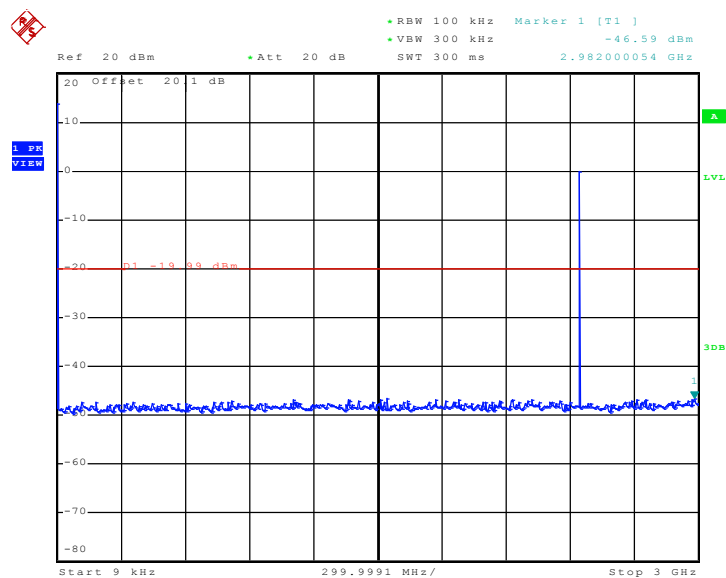

Conducted Spurious Emission Plot between 1 GHz ~ 25 GHz

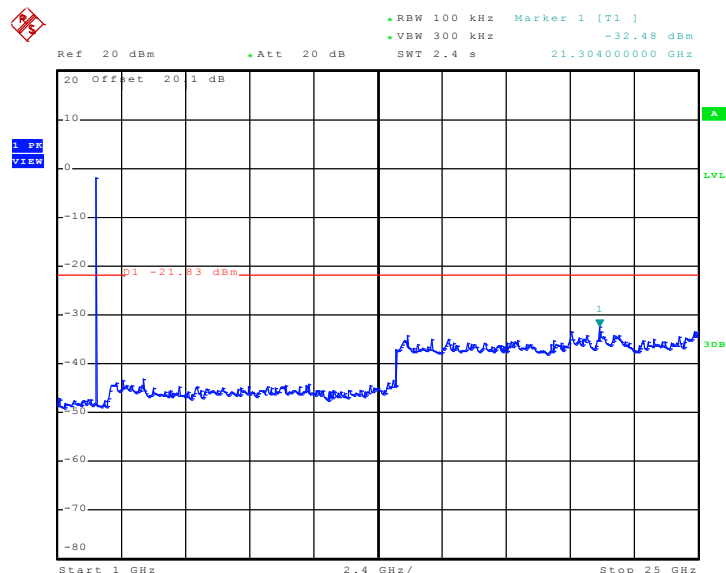

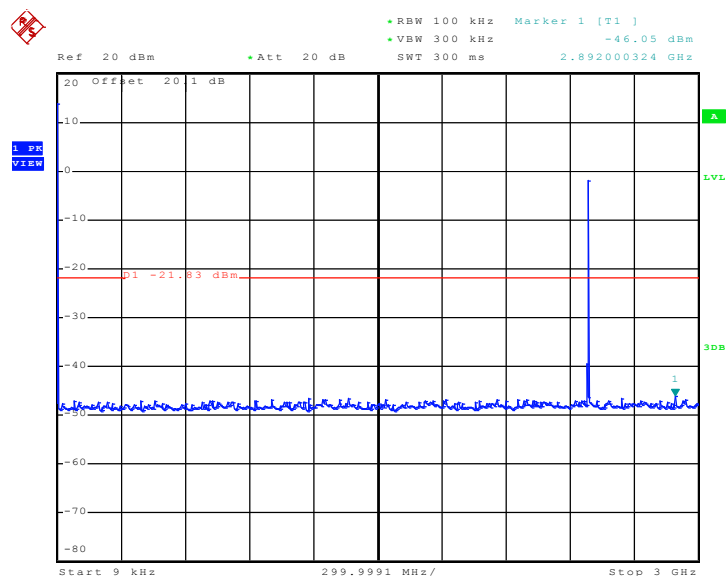
Conducted Spurious Emission Plot between 1 GHz ~ 25 GHz

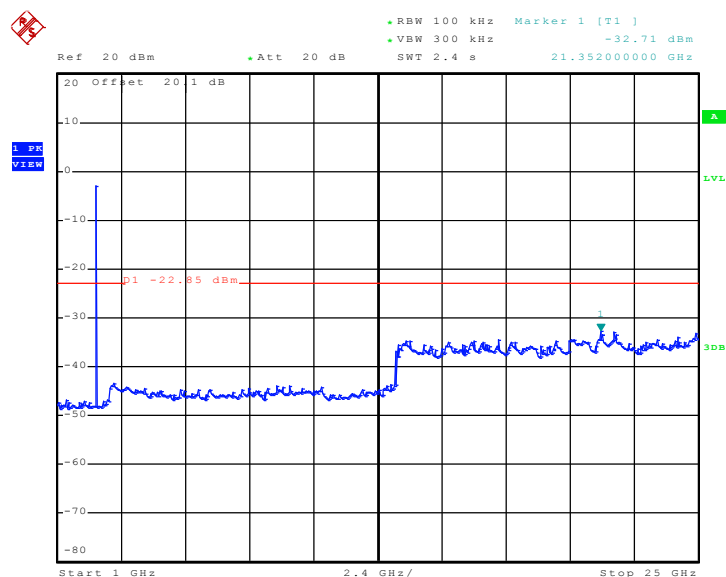

3.8 AC Conducted Emission Measurement

3.8.1 Limit of AC Conducted Emission

For equipment that is designed to be connected to the public utility (AC) power line, the radio frequency voltage that is conducted back onto the AC power line on any frequency or frequencies within the band 150 kHz to 30 MHz shall not exceed the limits in the following table.

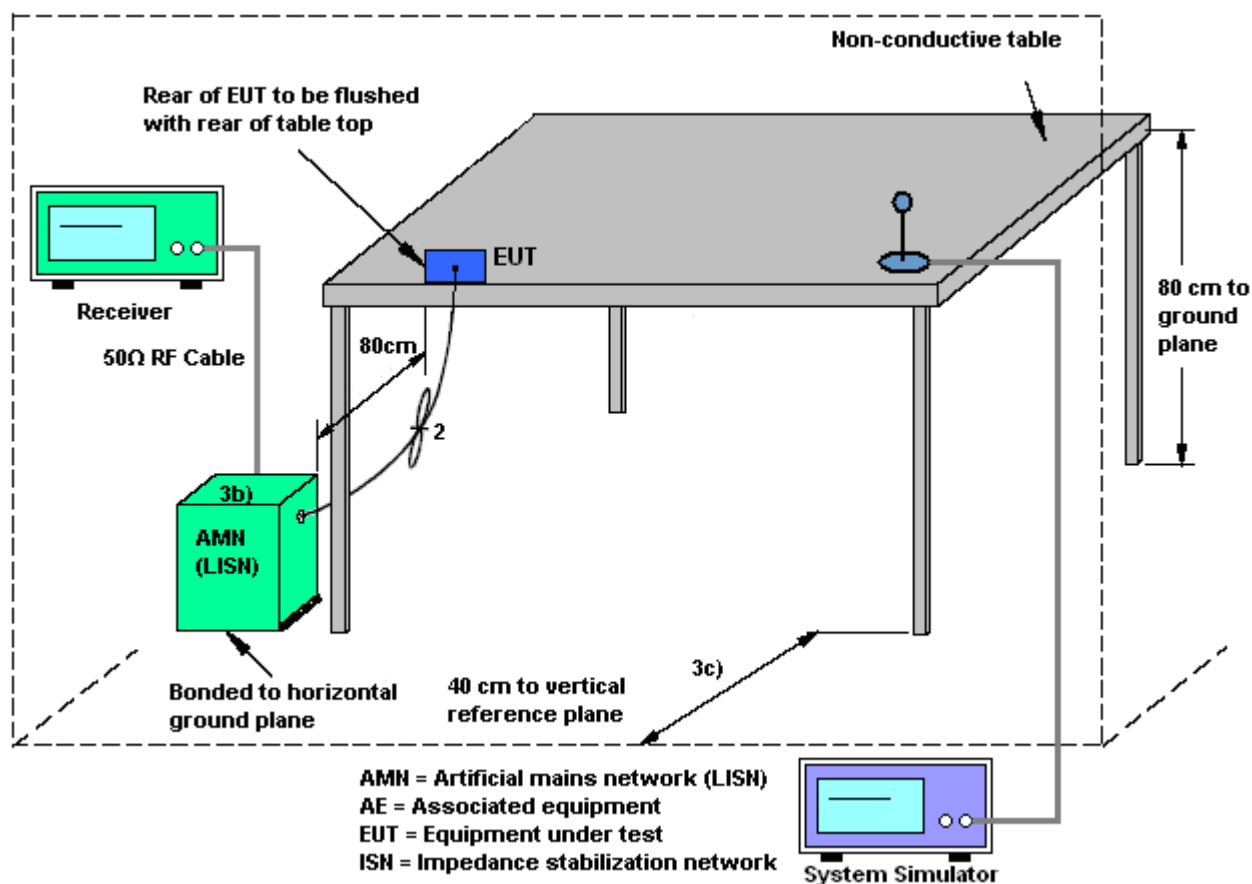

3.8.3 Test Procedures

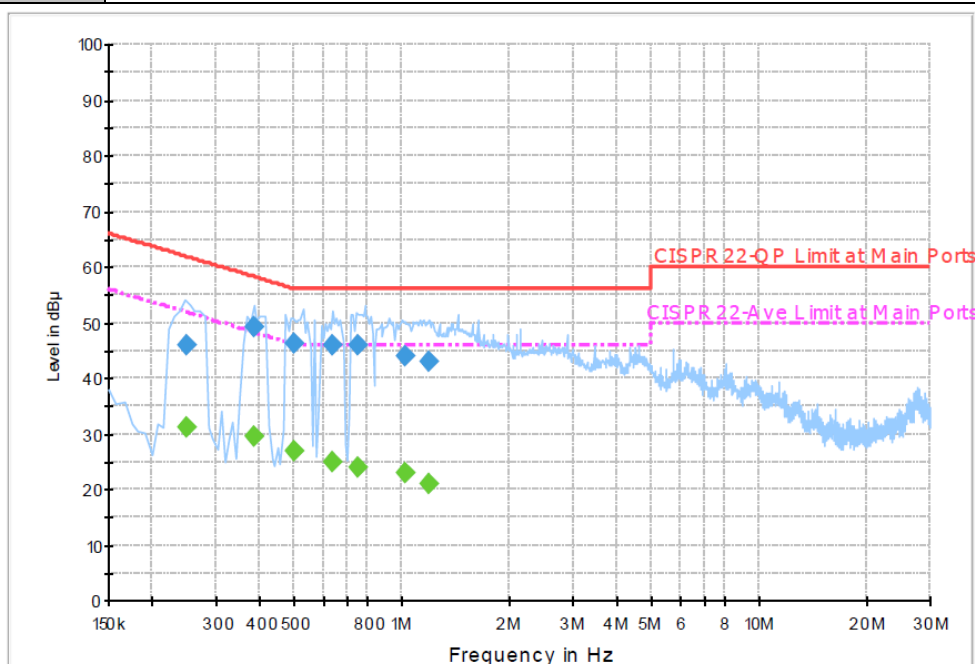
1. Please follow the guidelines in ANSI C63.4-2003.
2. The EUT was placed 0.4 meter from the conducting wall of the shielding room was kept at least 80 centimeters from any other grounded conducting surface.
3. Connect EUT to the power mains through a line impedance stabilization network (LISN).
4. All the support units are connecting to the other LISN.
5. The LISN provides 50 ohm coupling impedance for the measuring instrument.
6. The FCC states that a 50 ohm, 50 microhenry LISN should be used.
7. Both sides of AC line were checked for maximum conducted interference.
8. The frequency range from 150 kHz to 30 MHz was searched.
9. Set the test-receiver system to Peak Detect Function and specified bandwidth with Maximum Hold Mode.

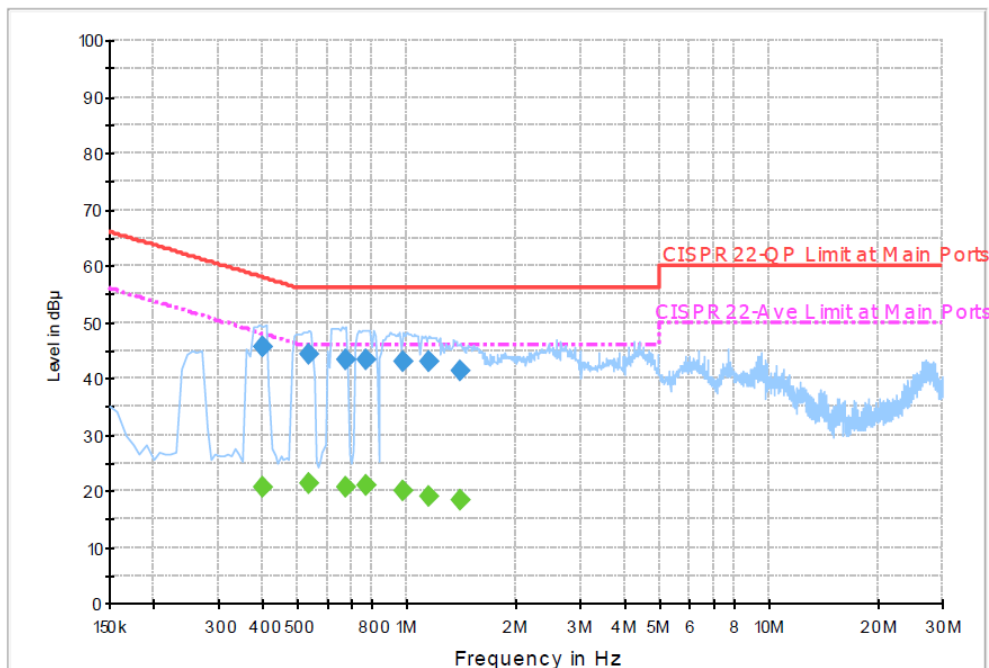

3.9 Radiated Emission Measurement

3.9.1 Limit of Radiated Emission

In any 100 kHz bandwidth outside the intentional radiator frequency band, all harmonics/spurious must be at least 20 dB below the highest emission level within the authorized band. In addition, radiated emissions which fall in the restricted bands must also comply with the FCC section 15.209 limits as below.

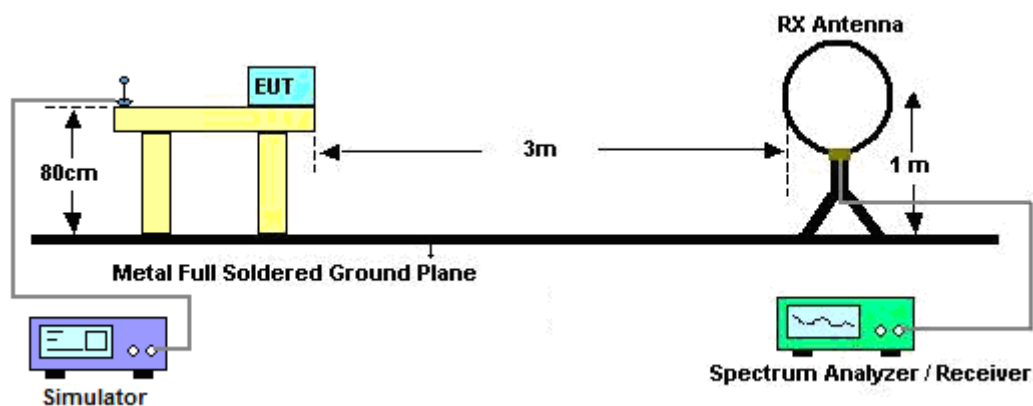

3.9.3 Test Procedures

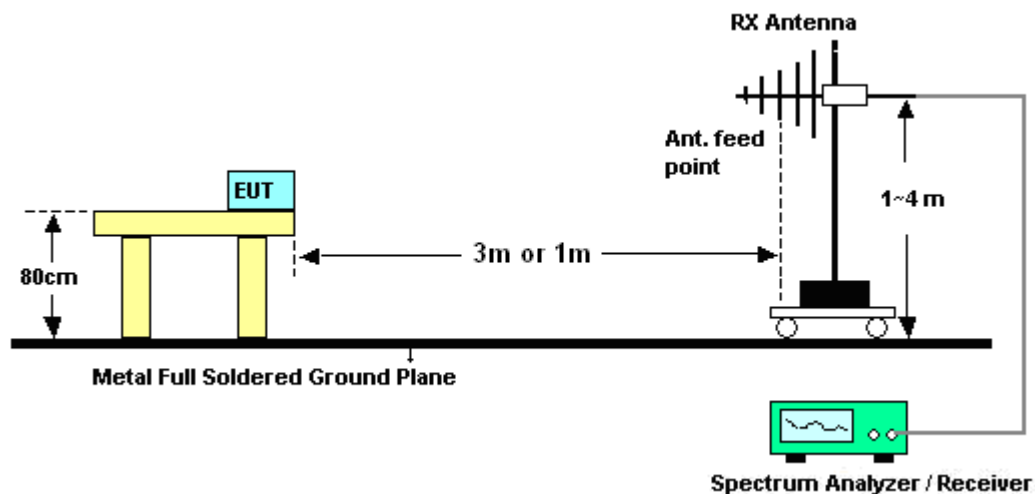
- The testing follows the guidelines in FCC Public Notice DA 00-705 Measurement Guidelines.
- Use the following spectrum analyzer settings:
 - Span = wide enough to fully capture the emission being measured; RBW = 1 MHz for $f \geq 1$ GHz, 100 kHz for $f < 1$ GHz; VBW $\geq$ RBW; Sweep = auto; Detector function = peak; Trace = max hold.
 - Above 18 GHz shall be extrapolated to the specified distance using an extrapolation factor of 20 dB/decade from 3m to 1m.
 Distance extrapolation factor = $20 \log (\text{specific distance [3m]} / \text{test distance [1m]})$ (dB)
- Follow the guidelines in ANSI C63.4-2003 with respect to maximizing the emission by rotating the EUT, measuring the emission for three EUT orthogonal planes, and adjusting the measurement antenna height and polarization. A pre-amp and a high pass filter are used for this test in order to get the good signal level.

3.10 Antenna Requirements

3.10.1 Standard Applicable

If directional gain of transmitting antennas is greater than 6dBi, the power shall be reduced by the same level in dB comparing to gain minus 6dBi. The use of a permanently attached antenna or of an antenna that uses a unique coupling to the intentional radiator shall be considered sufficient to comply with the FCC rule.

3.10.2 Antenna Connected Construction

The antennas type used in this product is PIFA Antenna without connector and it is considered to meet antenna requirement.

3.10.3 Antenna Gain

The antenna peak gain of EUT is less than 6 dBi. Therefore, it is not necessary to reduce maximum peak output power limit.
