2.6 TRANSMIT POWER CONTROL (TPC)

U-NII devices operating in the 5.25-5.35 GHz band and the 5.47-5.725 GHz band shall employ a TPC mechanism. The U-NII device is required to have the capability to operate at least 6 dB below the mean EIRP value of 30 dBm. A TPC mechanism is not required for systems with an e.i.r.p. of less than 500 mW.

Maximum EIRP of this device is 20.37mW which less than 500mW, therefore it's not require TPC function.

2.7 STATEMENT OF MAUNFACTURER

Manufacturer statement confirming that information regarding the parameters of the detected Radar Waveforms is not available to the end user. **And the device doesn't have Ad Hoc mode and hotspot on DFS frequency bands.**

3. U-NII DFS RULE REQUIREMENTS

3.1 WORKING MODES AND REQUIRED TEST ITEMS

The manufacturer shall state whether the UUT is capable of operating as a Master and/or a Client. If the UUT is capable of operating in more than one operating mode then each operating mode shall be tested separately. Note 1: This is the level at the input of the receiver assuming a 0 dBi receive antenna.

Note 2: Throughout these test procedures an additional 1 dB has been added to the amplitude of the test transmission waveforms to account for variations in measurement equipment. This will ensure that the test signal is at or above the detection threshold level to trigger a DFS response.

Note 1: The instant that the Channel Move Time and the Channel Closing Transmission Time begins is as follows:

- For the Short Pulse Radar Test Signals this instant is the end of the Burst.
- For the Frequency Hopping radar Test Signal, this instant is the end of the last radar Burst generated.
- For the Long Pulse Radar Test Signal this instant is the end of the 12 second period defining the Radar Waveform.

Note 2: The Channel Closing Transmission Time is comprised of 200 milliseconds starting at the beginning of the Channel Move Time plus any additional intermittent control signals required to facilitate a Channel move (an aggregate of 60 milliseconds) during the remainder of the 10 second period. The aggregate duration of control signals will not count quiet periods in between transmissions.

Note 3: During the U-NII Detection Bandwidth detection test, radar type 1 is used and for each frequency step the minimum percentage of detection is 90 percent. Measurements are performed with no data traffic.



PARAMETERS OF DFS TEST SIGNALS

Step intervals of 0.1 microsecond for Pulse Width, 1 microsecond for PRI, 1 MHz for chirp width and 1 for the number of pulses will be utilized for the random determination of specific test waveforms.



5. TEST PROCEDURE

5.1 ADT DFS MEASUREMENT SYSTEM:

A complete ADT DFS Measurement System consists of two subsystems: (1) the Radar Signal Generating Subsystem and (2) the Traffic Monitoring Subsystem. The control PC is necessary for generating the Radar waveforms in Table 6, 7 and 8. The traffic monitoring subsystem is specified to the type of unit under test (UUT).

CONDUCTED SETUP CONFIGURATION OF ADT DFS MEASUREMENT SYSTEM




The test transmission will always be from the Master Device to the Client Device. While the Client device is set up to associate with the Master device and play the NTIA DFS MPEG file (6 $\frac{1}{2}$ Magic Hours) from Master device, the designated MPEG test file and instructions are located at:

5.2 CALIBRATION OF DFS DETECTION THRESHOLD LEVEL:

The measured channel is 5500MHz. The radar signal was the same as transmitted channels, and injected into the antenna port of AP (master) or Client Device with Radar Detection, measured the channel closing transmission time and channel move time. The calibrated conducted detection threshold level is set to -60dBm. The tested level is lower than required level hence it provides margin to the limit.

CONDUCTED SETUP CONFIGURATION OF CALIBRATION OF DFS DETECTION THRESHOLD LEVEL




6.2 DETELED TEST RESULTS

6.2.1 TEST MODE: DEVICE OPERATING IN CLIENT WITHOUT RADAR DETECTION MODE.

Client with injection at the Master. (The radar test signals are injected into the Master Device)

DFS DETECTION THRESHOLD

For detection threshold level of -64dBm, the required Radar Signal at antenna port was set to -64dBm + Ant Gain (0 dBi) = -64dBm. The tested level is lower than required level for 1dB, hence it provides margin to the limit.




Radar Signal 1







NOTE: An expanded plot for the device vacates the channel in the required 500ms.


6.2.3 NON-OCCUPANCY PERIOD


- 1) EUT (Client) links with master on 5500MHz.

Waveform of transmission




- 3) Radar signal 1 is applied to the Master device and WiFi traffic signal stop immediately.


