On behalf of Wide Telecom Inc. we hereby submit the following amendment per your e-mail dated April 10, 2001 requesting additional information for the subject application.

1. The submitted users manual is preliminary and therefore does not include the available accessories. Attached is a letter from the applicant confirming the available accessories and their placement in the final version of the users manual. The photo in the users manual is the same phone with a slight variance in the front cosmetic design. We confirm that the submitted preliminary users manual is correct for this phone.
2. We also confirm that the body SAR photographs submitted are correct and do show the back of the phone facing the phantom. Please note that looking at the front of the phone the antenna is on the right of the phone (as shown in the external photographs exhibit and head SAR test photographs), and the ear-mic jack is on the left side of the phone (see external photos and body holster photos). In the body SAR test photographs the antenna side of the phone is facing the back of the DASY3 system, and the ear-mic jack is visibly facing the front of the DASY3 system, which would confirm the back of the phone is facing the phantom in the body SAR test photographs. For future submittals we will make sure the placement of the phone is clearly evident in the test setup photographs.
