## 1.0 **General Description**

### 1.1 Product Description

The GH940X is a 900MHz & 2.4GHz Dualband 50 Channels Analog Modulation Cordless Telephone. The unit is capable of either tone or pulse dialing. The internal power supply's isolation is accomplished through a power transformer having an adequate dielectric rating. The circuit wiring is consistent under the requirement of part 68.

The letter "X" in the model no. GH940X represents integers from 0 to 9. In other words, GH940X denotes a series of cordless telephones. The models are identical to one another as far as hardware, software, features and functionality. Their difference lies in cosmetics only.

The handset unit consists of a keypad with twelve standard keys (0,...9,\*,#), Five function keys Redial, Flash, Memo, Pause & Tone, and one channel switch key. A Talk key is provided to control pick/release telephone line in a toggle base.

The base unit has a page key, which is used to page the handset unit.

Connection between the device and the telephone network is accomplished through the use of USOC RJ11C in the 2-wire loop calling central office line.

### 1.2 Related Submittal(s) Grants

This is an Application for Certification of a cordless telephone system. Two transmitters are included in this Application. This specific report details the emission characteristics of each transmitter. The receivers are subject to the verification authorization process, in accordance with 15.101(b). The emission characteristics of each receivers is also included as additional information. The device is also subject to Part 68 Registration.

### 1.3 Test Methodology

Both AC mains line-conducted and radiated emission measurements were performed according to the procedures in ANSI C63.4 (1992). All measurements were performed in Open Area Test Sites. Preliminary scans were performed in the Open Area Test Sites only to determine worst case modes. For each scan, the procedure for maximizing emissions in Appendices D and E were followed. All Radiated tests were performed at an antenna to EUT distance of 3 meters, unless stated otherwise in the "**Justification Section**" of this Application.

### 1.4 Test Facility

The open area test site and conducted measurement facility used to collect the radiated data is located at Garment Centre, 576 Castle Peak Road, Kowloon, Hong Kong. This test facility and site measurement data have been fully placed on file with the FCC.

### 2.0 System Test Configuration

#### 2.1 Justification

For emission testing, the equipment under test (EUT) was configured for testing in a typical fashion (as a customer would normally use it). During testing, all cables were manipulated to produce worst case emissions. The handset was powered by a fully charged battery.

For the measurements, the EUT is attached to a cardboard box and placed on the wooden turntable. If the base unit attaches to peripherals, they are connected and operational (as typical as possible). The handset is remotely located as far from the antenna and the base as possible to ensure full power transmission from the base. Else, the base is wired to transmit full power without modulation.

The signal is maximized through rotation and placement in the three orthogonal axes. The antenna height and polarization are varied during the search for maximum signal level. The antenna height is varied from 1 to 4 meters. Detector function is in peak mode. Radiated emissions are taken at three meters unless the signal level is too low for measurement at that distance. If necessary, a pre-amplifier is used and/or the test is conducted at a closer distance.

All readings are extrapolated back to the equivalent three meter reading using inverse scaling with distance. Analyzer resolution is 100 kHz or greater. All emissions greater than 20 dB $\mu$ V/m are recorded.

Radiated emission measurement were performed from 30 MHz to tenth harmonics.

#### 2.2 EUT Exercising Software

The EUT exercise program used during radiated and conducted testing was designed to exercise the various system components in a manner similar to a typical use.

For emissions testing, the units were setup to transmit continuously to simplify the measurement methodology. Care was taken to ensure proper power supply voltages during testing.

### 3.0 Emission Results

### 3.1 Field Strength Calculation

The field strength is calculated by adding the Antenna Factor and Cable Factor, and subtracting the Amplifier Gain (if any) from the measured reading. The basic equation with a sample calculation is as follows:

$$FS = RA + AF + CF - AG$$

Assume a receiver reading of  $52.0 \text{ dB}\mu\text{V}$  is obtained. The antenna factor of  $7.4 \text{ dB}$  and cable factor of  $1.6 \text{ dB}$  is added. The amplifier gain of  $29 \text{ dB}$  is subtracted, giving a field strength of  $32 \text{ dB}\mu\text{V/m}$ . This value in  $\text{dB}\mu\text{V/m}$  was converted to its corresponding level in  $\mu\text{V/m}$ .




