


NOTES:

1. PRINT LABEL ON A THERMAL TRANSFER PRINTER SUCH AS A ZEBRA S400 OR EQUIVALENT. USE TDC P/N 044-0017 FOR PRINTER RIBBON.
2. BAR-CODE TO BE CODE 128A WITH A MINIMUM BAR HEIGHT OF 0.14 AND A BAR RATIO OF 3:1.
3. DUE TO CONSTRAINTS RESULTING FROM THE PWA ASSEMBLY AND SERIALIZATION PROCESS THE TAG UNIT SERIALIZATION DOES NOT FOLLOW THE CONCEPT SPECIFIED IN TDC DOCUMENT NUMBER 450-0005 "SERIALIZATION GUIDELINES" WHICH IS TYPICAL FOR TIME DOMAIN ASSEMBLIES. THE PWA IS PROGRAMMED WITH AN 8-DIGIT HEX CHARACTER STRING. THOSE EIGHT CHARACTERS ARE TO PRINTED ON THE SERIAL NUMBER LABEL IN BOTH BAR-CODE AND HUMAN READABLE FORM.
