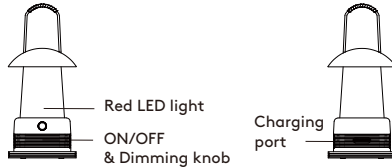


蓝牙版说明书

Bluetooth®LED lantern



Include

- Retro lantern
- Micro USB Charging Cable(Store at the bottom)

Operate

- Press the knob to turn on the lantern
- Rotate the knob to adjust the brightness
- When turned on, the red LED flashes, Use Bluetooth settings on your device to pair with "Hearth & Hand 09"
- The red light will go off once connected successfully

Charging

- Plug micro USB end of charging cable into charging port
- Plug USB end of charging cable into a DC 5V 1A power adaptor
- Full charge requires approximately 4-5 hours
- Charging is complete when solid red light turns off.

Troubleshooting and Tips

- If the device is not working correctly, turn it on/off to reset
- If the device won't turn on, recharge the battery and try again
- If the device won't charge, make sure the supply works is 5V 1A, and not damaged
- If the device makes no sound, Adjust the volume on the phone
- If the device makes no sound or do not show as an available device, make sure it is not paired to another device. If so, unpair the device and re-pair the desired device
- This device does not have a pairing tone. If prompted for one, make sure you are connecting to the correct device. If not, "forget" the device and re-pair with your desired one

NOTE:

- Please keep the distance between the connected devices less than 33 feet to ensure working properly
