

REQUEST FOR SHORT TERM CONFIDENTIALITY

If you do not request for short term confidentiality, your exhibits are visible on the FCC website for everyone from the first day the device is officially listed.

A request for short term confidentiality must be indicated in item 8 of the 731 form and a letter making specific request for short term confidentiality must accompany the application as a separate exhibit. This justification should:

- (a) reference Sections 0.457 and 0.459 which identify the information to be held confidential,
- (b) list the specific attachments to be held confidential, and (c) address why release of the information at the time of grant would be a problem.

Only one type of confidentiality can be applied per attachment exhibit (i.e. Permanent Confidential or Short-Term Confidential).

Only certain exhibits may be held in short term confidence.

- external photos,
- test setup photos,
- user's manual,
- internal photos;

if not included in the "Permanent confidentiality request":

- block diagrams,
- schematics,
- parts list / tune-up procedures,
- operational description

User's manuals will only be held in confidence under certain conditions such as when the manual will only be available to licensed or specially trained personnel. Internal photographs will only be held in confidence if the device is sealed using specially fasteners that cannot be opened using common hand tools or if the PCB's are completely potted.

General rules for short term confidentiality:

- Granted for 45 calendar day increments from the date of grant
- Maximum of four extensions from date of grant (180 days)
- Exhibits automatically released to the public at expiration date
- Release information to the public immediately when marketing begins

The FCC is a federal agency and as such has duties to the public to disclose information made known to it (see 47 CFR 0). The FCC has a procedure to handle short term confidential items and any request will be delivered to the FCC for them to decide if it can be held in confidence.

A request for short term confidentiality does not guarantee that the FCC will grant it.
