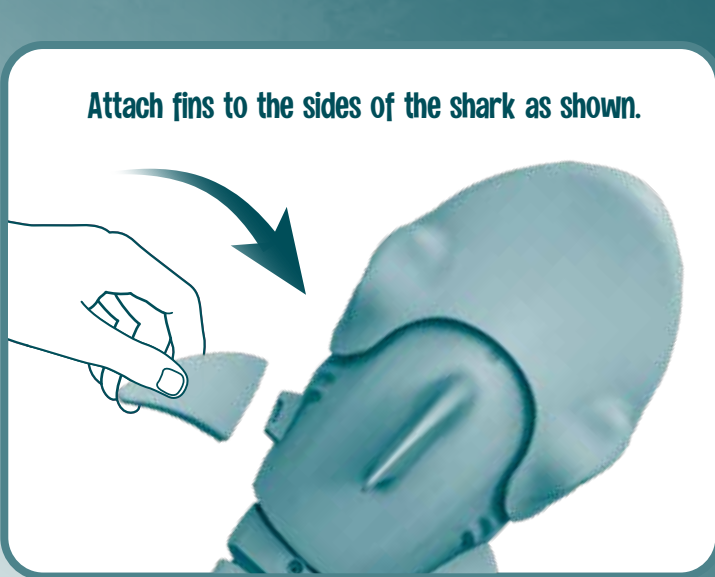


- DO NOT drive the shark into walls, doors or furniture.

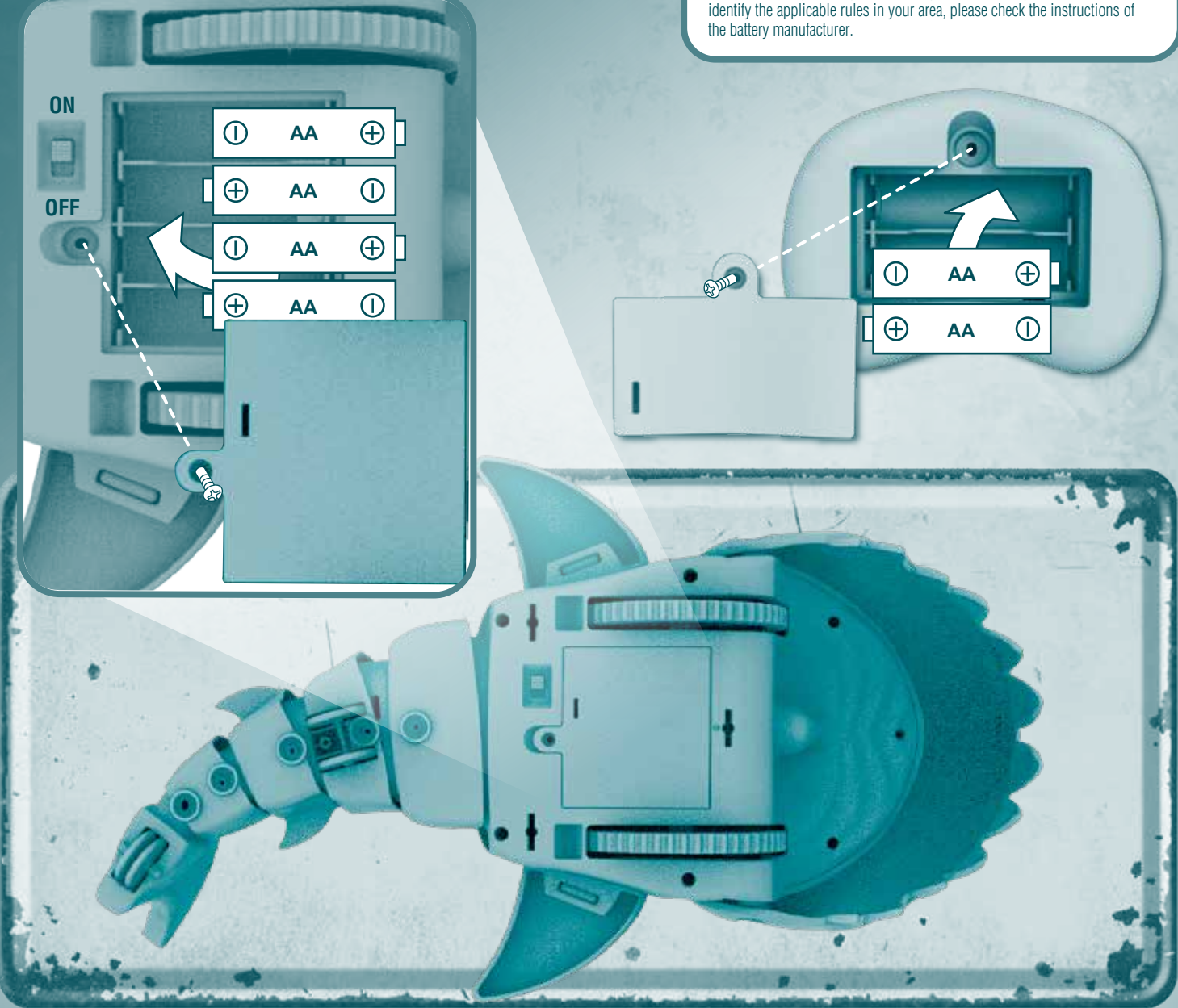

BATTERY SPECIFICATIONS & CAUTIONS

Turn on the shark and remote, then place the shark on the floor in a large open area. The shark is easiest to control when standing behind it. The jaw will automatically chomp as it moves forward.
