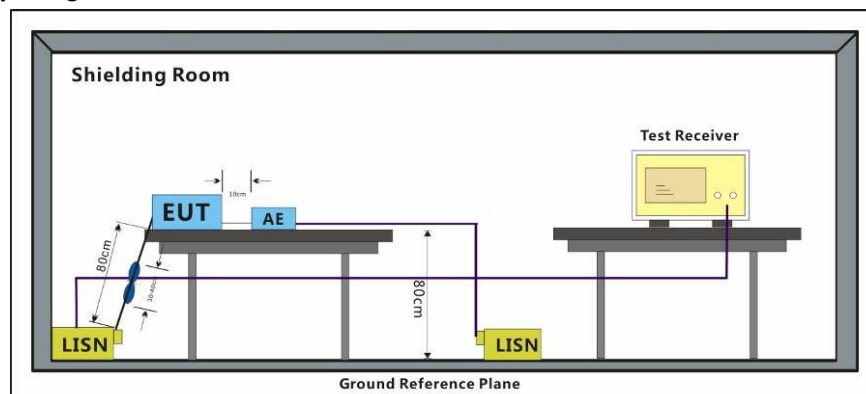

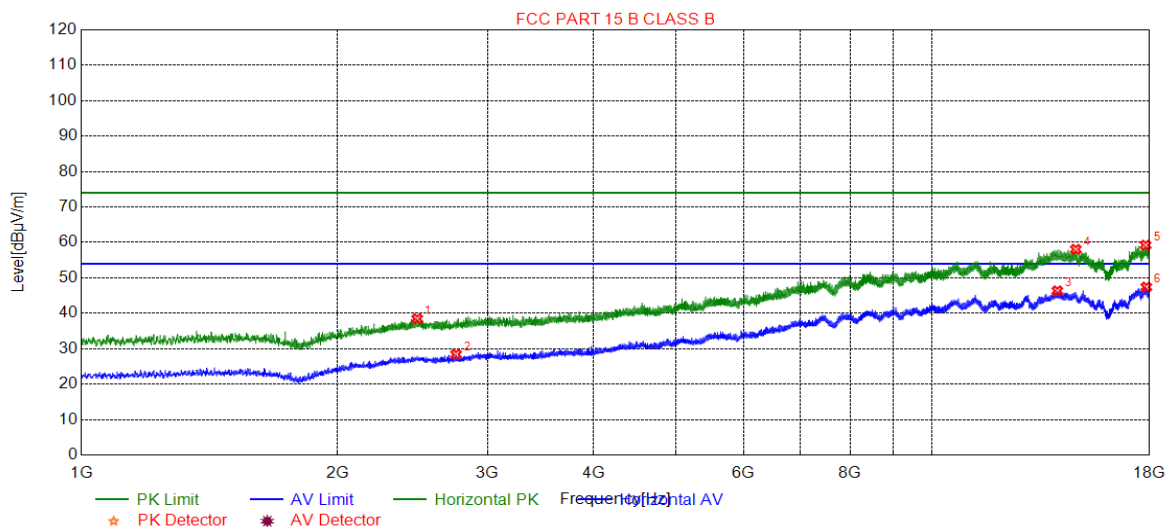
2.1.8 Test Setup Diagram

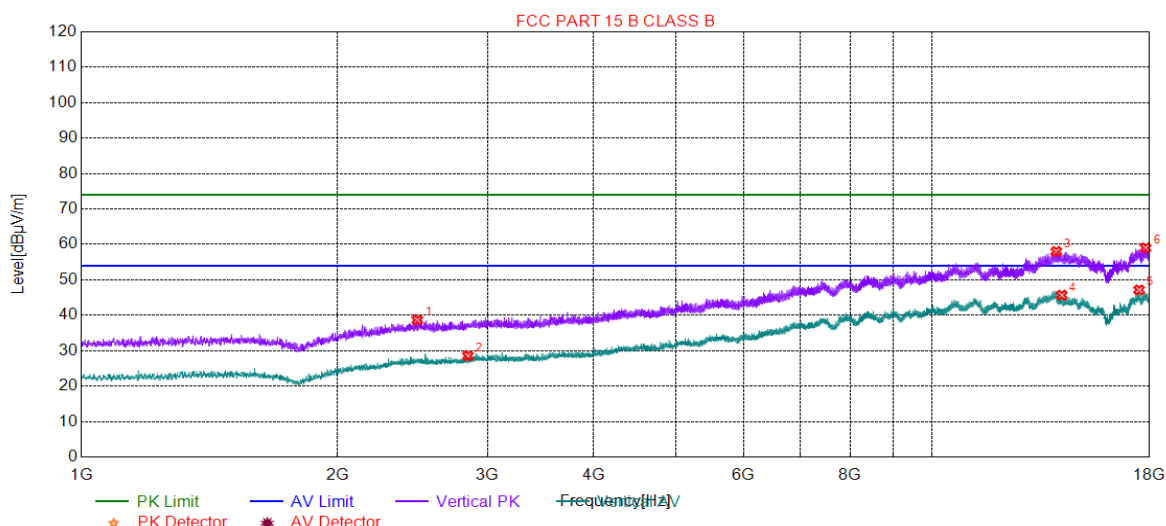
