2.2 Test Mode

- a. The EUT has been associated with peripherals and configuration operated in a manner tended to maximize its emission characteristics in a typical application. Frequency range investigated: conduction emission (150 kHz to 30 MHz), radiation emission (9 kHz to the 10th harmonic of the highest fundamental frequency or to 40 GHz, whichever is lower). For radiated measurement, pre-scanned in three orthogonal panels, X, Y, Z. The worst cases (Xplane) were recorded in this report, and the worst mode of radiated spurious emissions is Bluetooth 1Mbps mode, and recorded in this report.
- b. AC power line Conducted Emission was tested under maximum output power.



2.5 EUT Operation Test Setup

For Bluetooth function, the engineering test program was provided and enabled to make EUT connect with Bluetooth base station to continuous transmit/receive.

For AC power line conducted emissions, the EUT was set to connect with the WLAN AP under large package sizes transmission.

2.6 Measurement Results Explanation Example

For all conducted test items:

The offset level is set in the spectrum analyzer to compensate the RF cable loss and attenuator factor between EUT conducted output port and spectrum analyzer. With the offset compensation, the spectrum analyzer reading level is exactly the EUT RF output level.

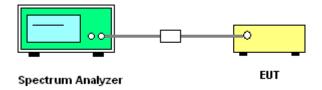





Channel Separation Plot on Channel 39 - 40






Channel Separation Plot on Channel 77 - 78

Channel Separation Plot on Channel 00 - 01







Channel Separation Plot on Channel 39 - 40





High Band Edge Plot on Channel 78








For radiated emissions below 30MHz



3.10 Antenna Requirements




