In the event of a defect in material or workmanship during the warranty period, FID, at its discretion, will repair or replace the defective product when the owner returns the defective product to FID. In no event will FID be liable for any amount greater than the currently suggested retail price.

FID specifically disclaims all other warranties, expressed or implied, including but not limited to implied warranties of merchantability and fitness for a particular purpose with respect to the defects of the products and program license granted herein. With respect to the use of this product, in no event shall FID be liable for any loss of profit or any commercial damage, including but not limited to special, incidental, consequential, or other damages. If FID Customer Service verifies that the product is defective, the Return Materials Authorization Department will issue an RMA number to place on the outer packaging of the product. FID cannot accept any product that does not include an RMA number on the package.
