- 3. Of the three test reports submitted which were tested to "FCC Verification of Conformity", the two that show labels, show labels for FCC DoC and not Verification. Please explain why and how they will be corrected. Also, provide procedures that will be put in place to prevent this in the future.
- 4. The test reports provided identify the authorization type as being FCC VOC in one place and Verification in another. Please modify to remove all references to FCC VOC as it isn't a valid FCC procedure and is confused with FCC DoC.
- 5. In the FCC Part 15 Table provided the first authorization type should be corrected to Verification from FCC VOC. Also, the test firm and approving authority for Verified devices is not limited to 2.948 listed test laboratories.
 6. In the FCC Part 15 Table provided the third authorization type is identified as FCCID but the correct term is Certification. Devices subject to Certification may be tested at a 2.948 listed test firm or an FCC recognized Accredited test firm. These devices may be authorized by the FCC or a Telecommunication Certification Body recognized by the FCC. Please submit a corrected version of the table.
