A. RF POWER OUTPUT

C. OCCUPIED BANDWIDTH

1. a. A spectrum analyzer was used to determine the occupied bandwidth.
 See Figure 1 for test set-up.
- b. Data is presented on Paragraph 5 to Paragraph 8 for Standard primary Input Voltage of 13.6 VDC maintained throughout entire test. The carrier and all detectable sidebands were displayed on the spectrum analyzer and pertinent data concerning amplitude and frequency were read from the screen.
- c. un modulated : Data measured at 435.1MHz. (see Paragraph 5)
- d. Input to transmitter audio circuits: 2500Hz sine wave at a level 16dB greater than that necessary to produce 50% modulation. Data measured at 435.1MHz and is typical of all frequencies. (see Paragraph 6)
- e. Input to transmitter audio circuits: 2500Hz sine wave at a level 16dB greater than that necessary to produce 50% modulation with CTCSS(250.3Hz).
 Data measured at 435.1MHz and is typical of all frequencies.
 (see Paragraph 7)
- f. Input to transmitter audio circuits: 2500Hz sine wave at a level 16dB greater than that necessary to produce 50% modulation with DCS(023).
 Data measured at 435.1MHz and is typical of all frequencies.
 (see Paragraph 8)

The response at 1 kHz tone = 0dB. Curve was taken maintaining constant input at modulation sensitivity. Output of low-pass filter was monitored using Audio Analyzer

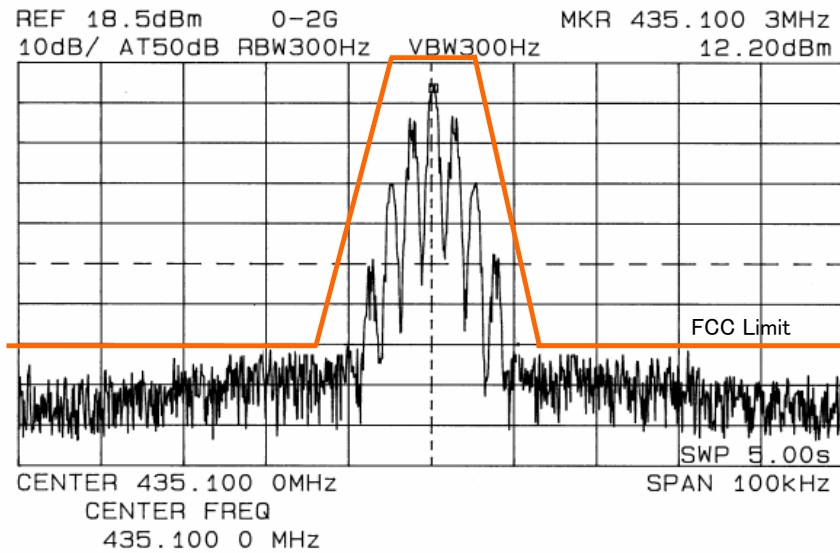
6. Occupied Bandwidth 2500Hz Sine Wave (Paragraph 6)



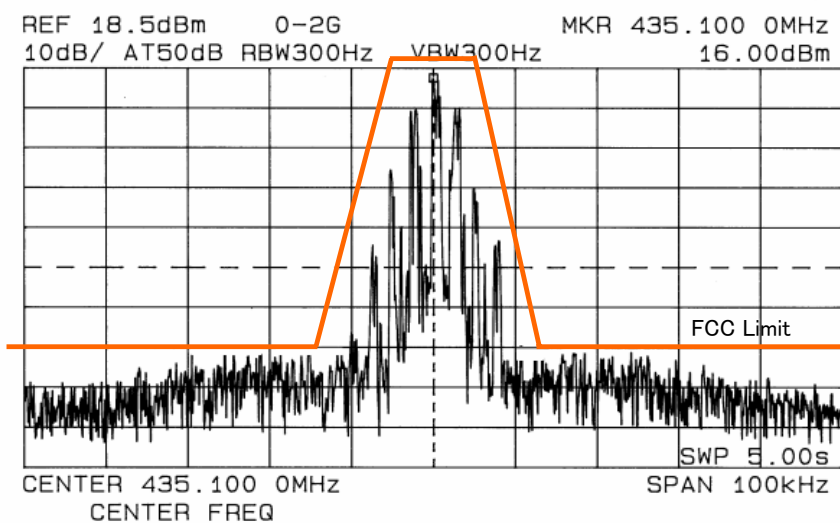

7. Occupied Bandwidth 2500Hz Sine Wave with CTCSS(250.3Hz) (Paragraph 7)



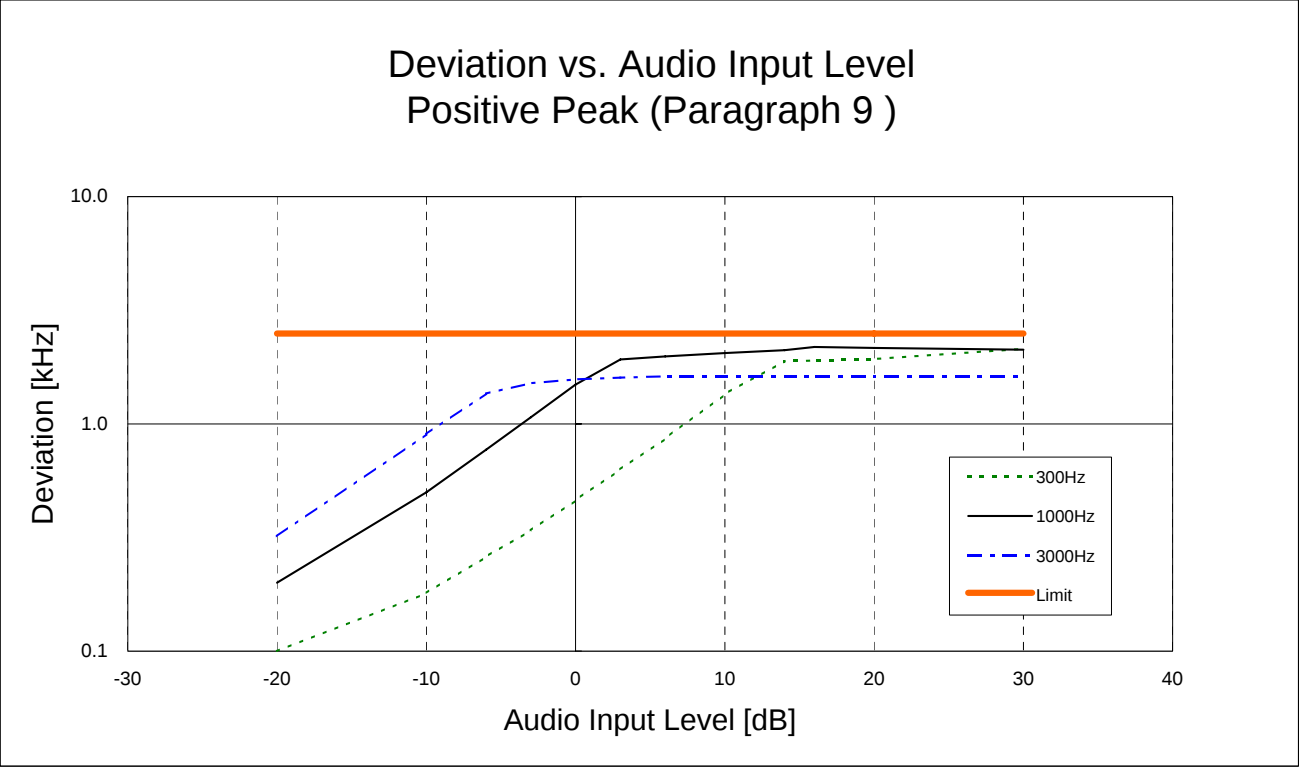

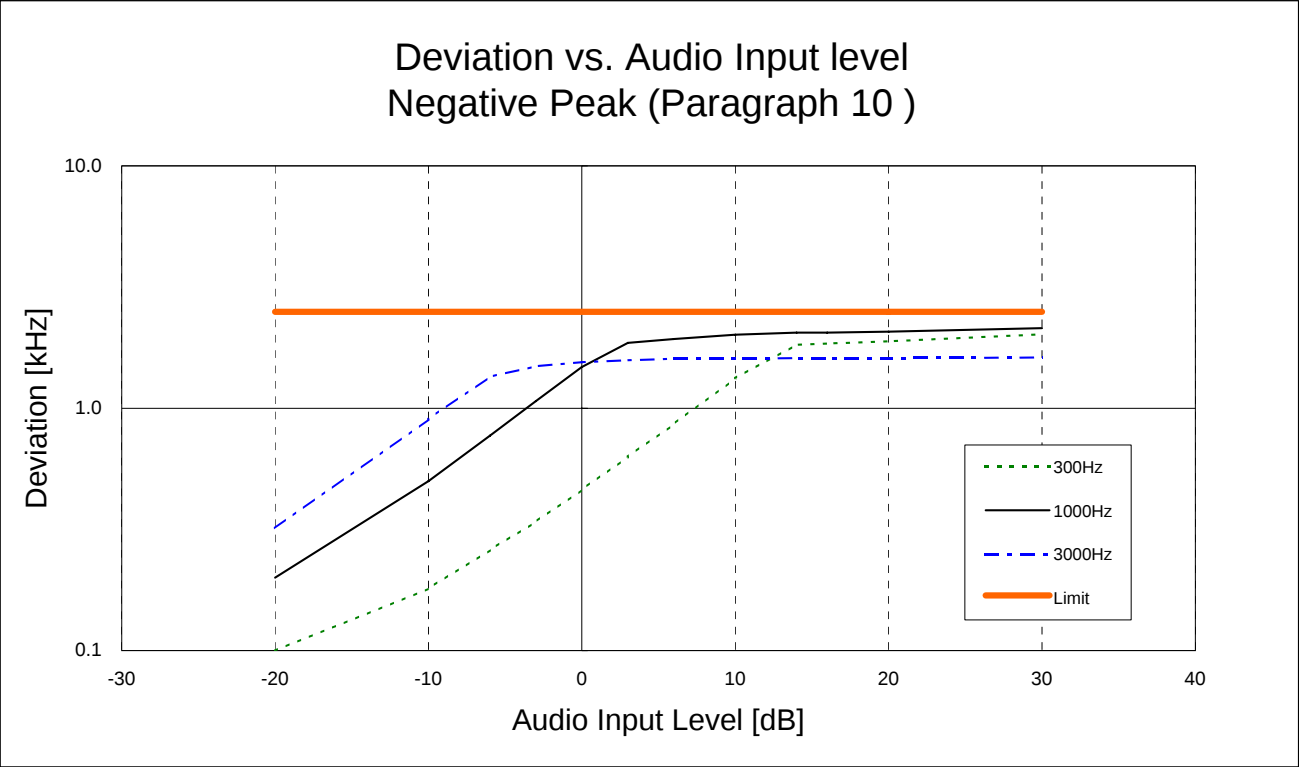

9.Deviation vs. Audio Input Level (Paragraph 9)



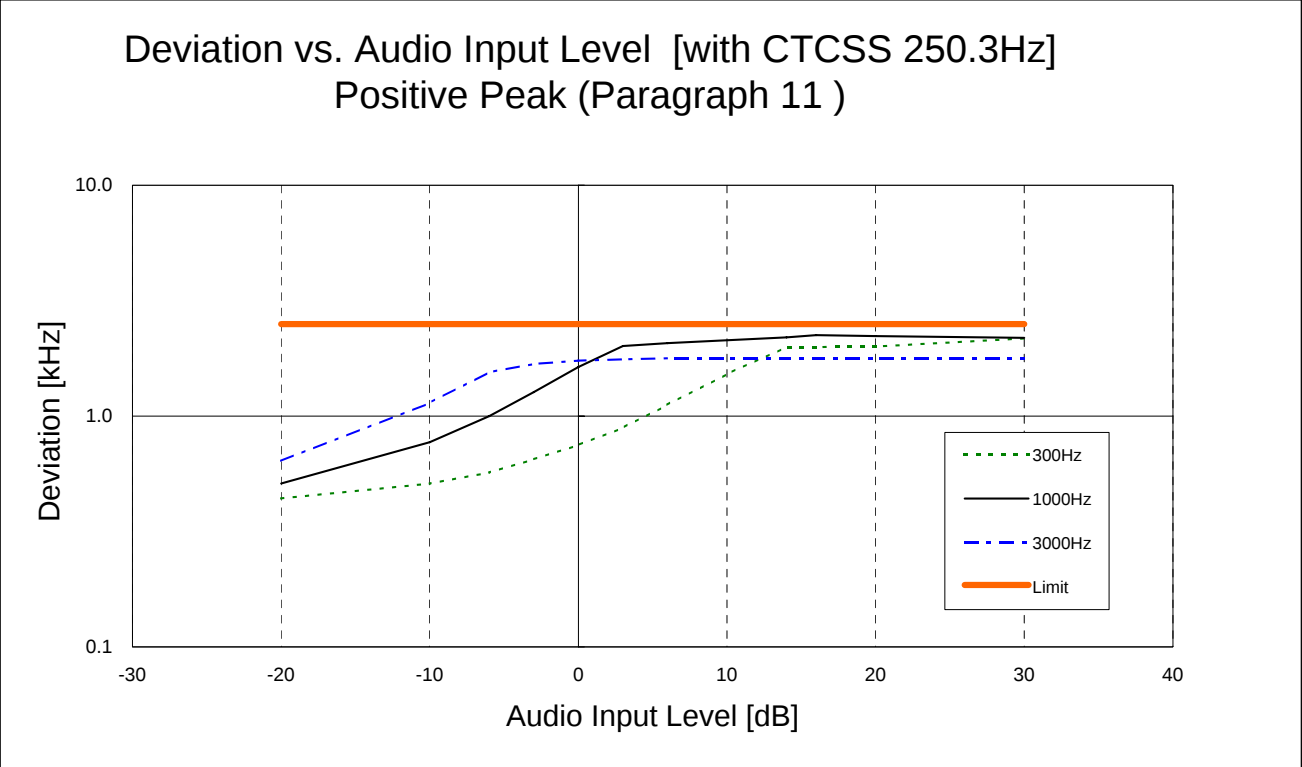
10.Deviation vs. Audio Input Level (Paragraph 10)



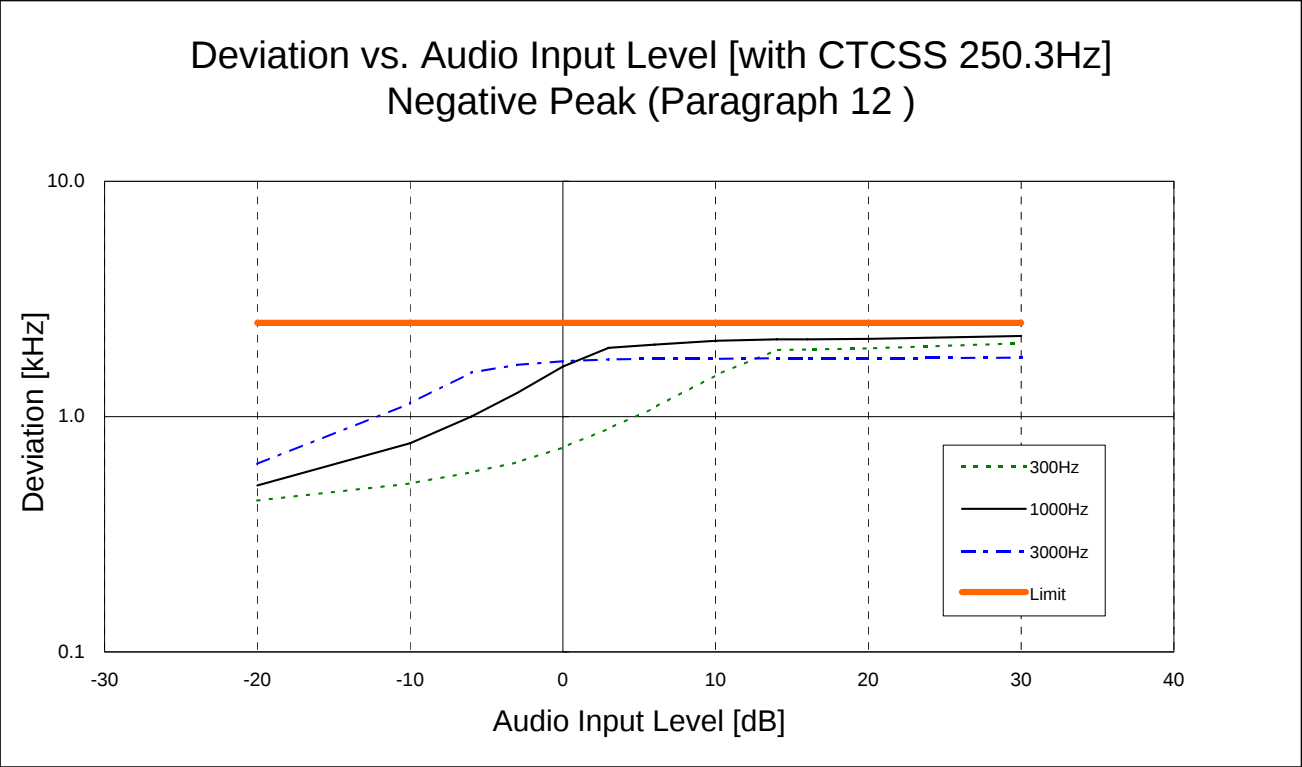

11.Deviation vs. Audio Input Level (Paragraph 11)



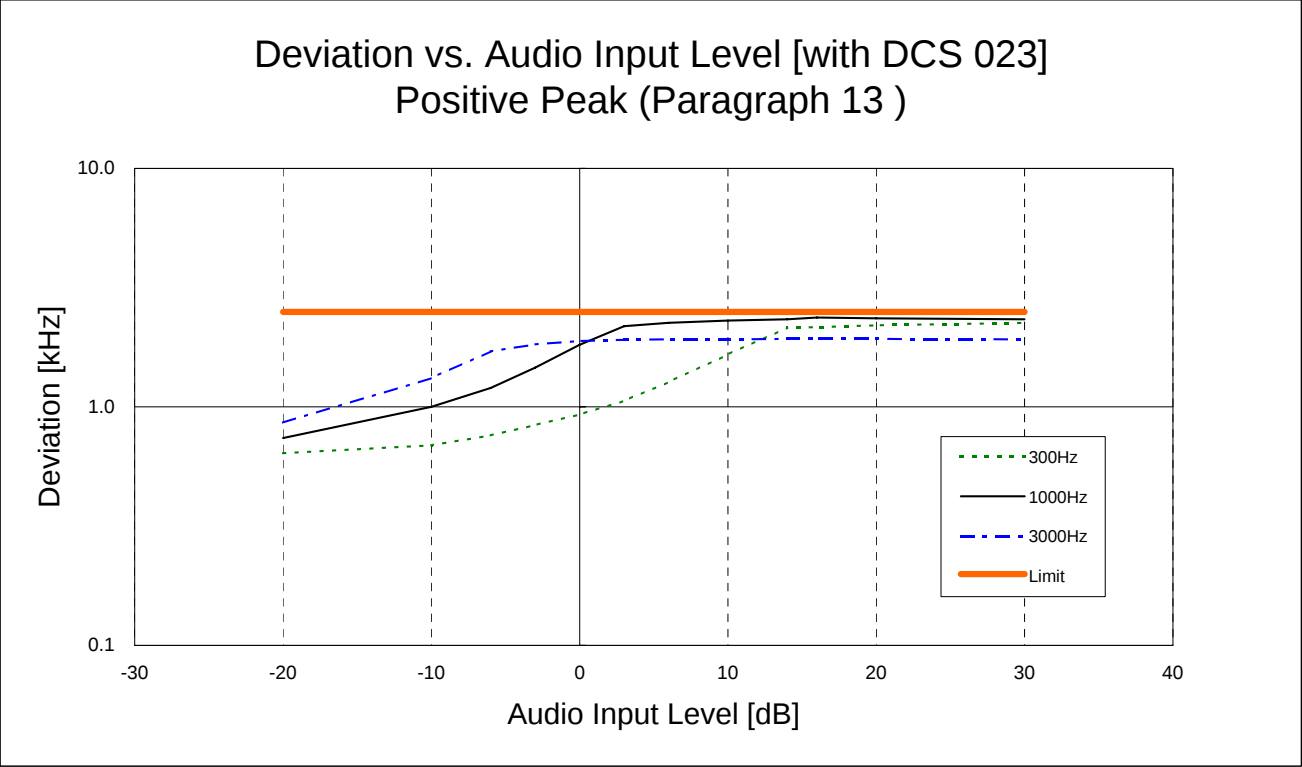
12.Deviation vs. Audio Input Level (Paragraph 12)



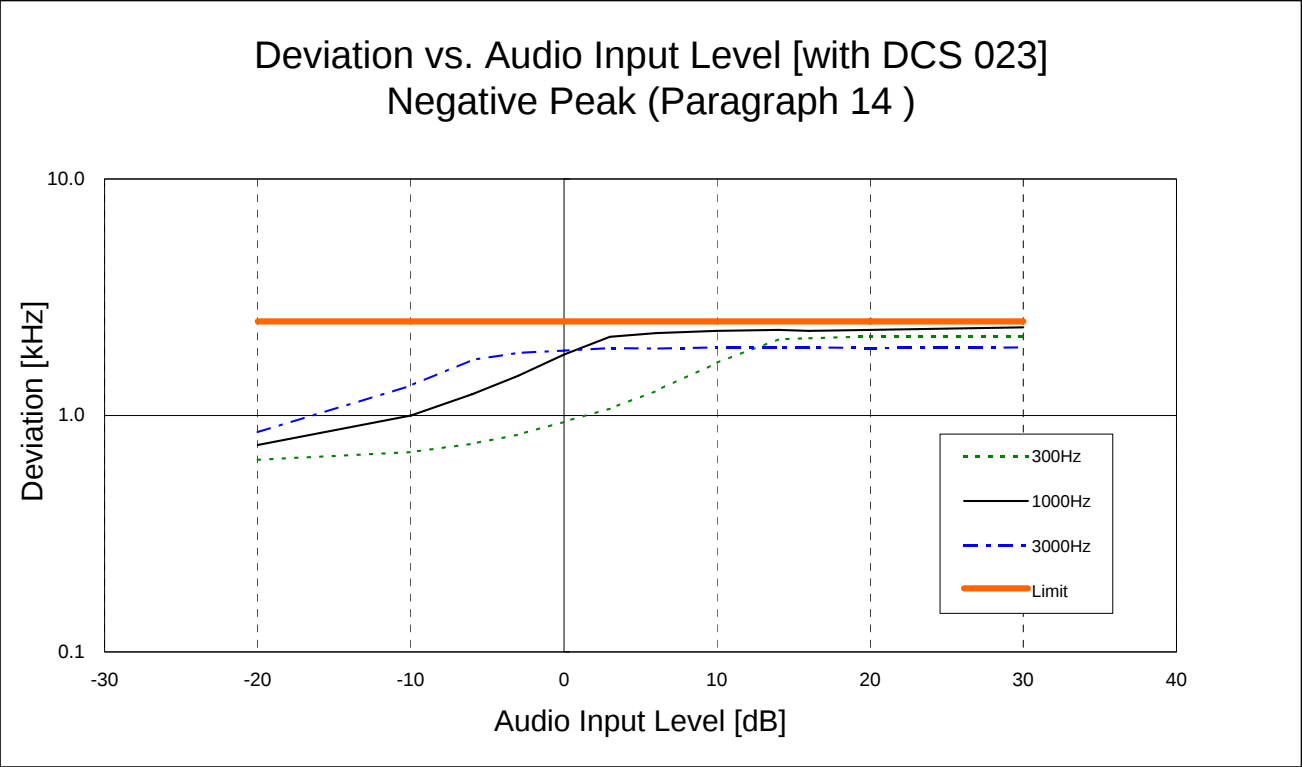

13.Deviation vs. Audio Input Level (Paragraph 13)

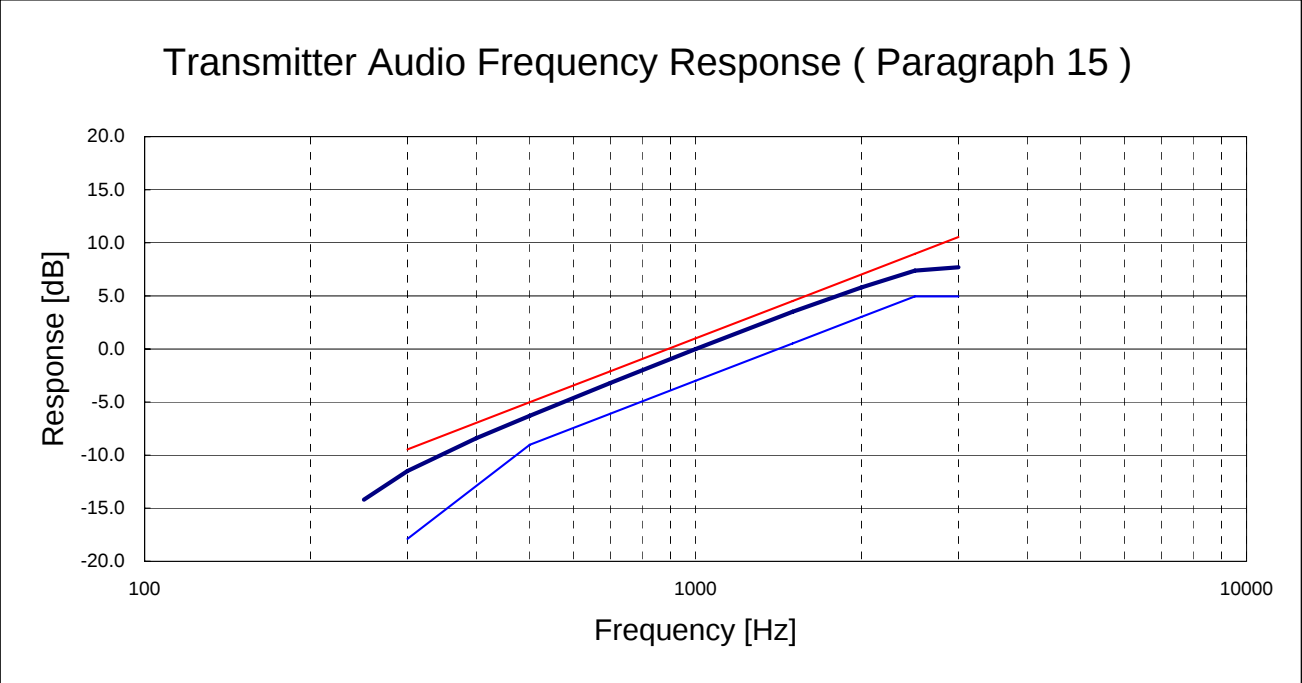


14.Deviation vs. Audio Input Level (Paragraph 14)

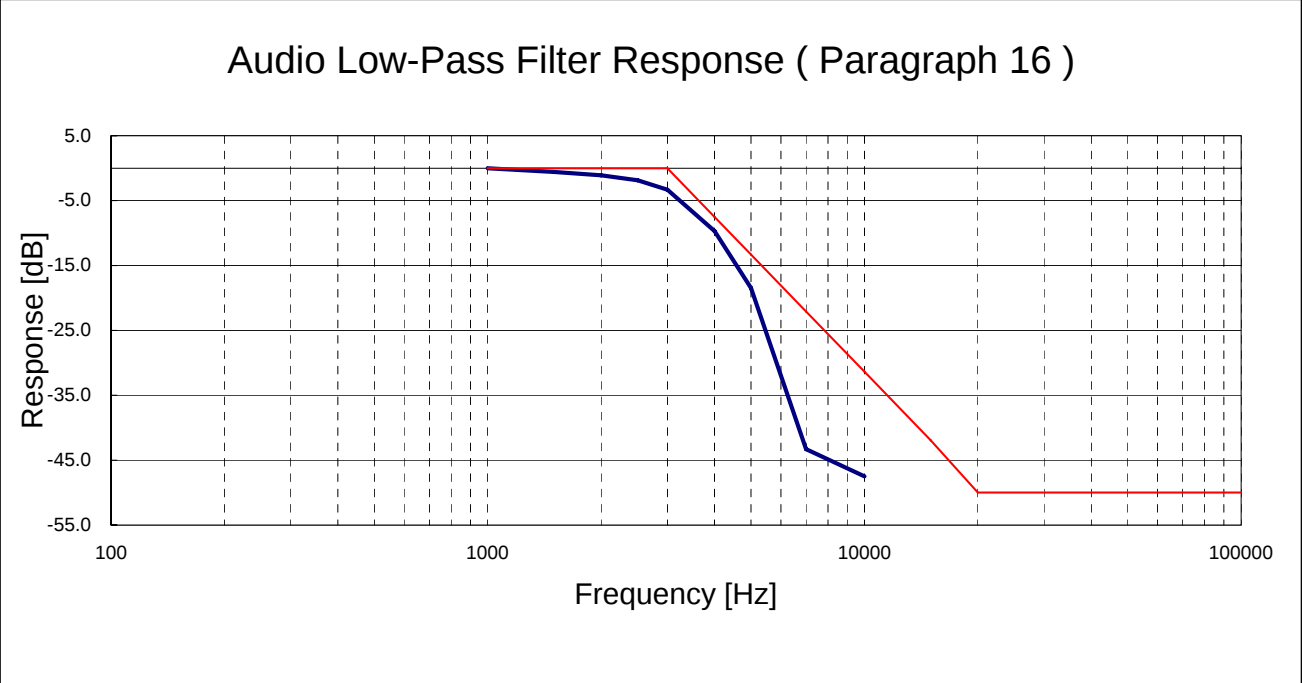

15. Transmitter Audio Frequency Response (Paragraph 15)



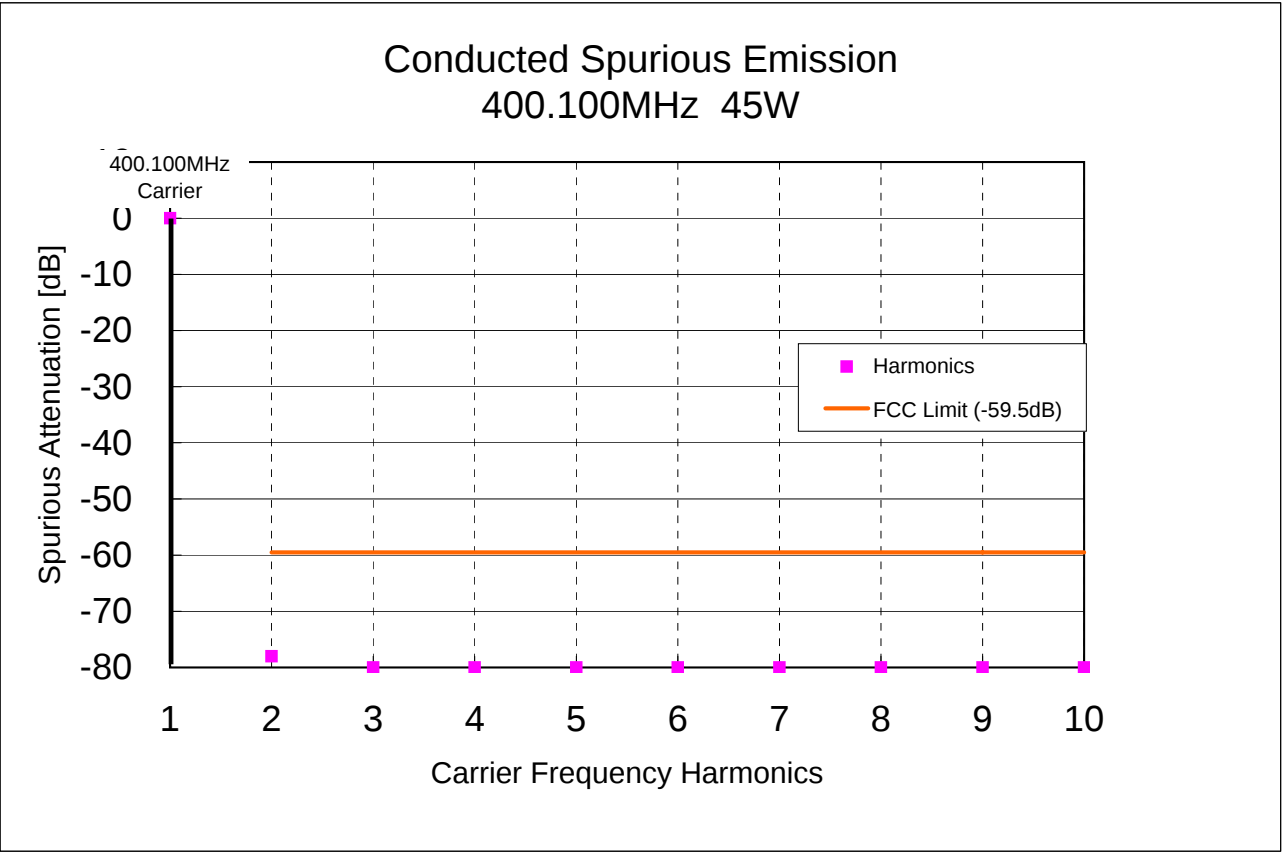
16. Audio Low-Pass Filter Response (Paragraph 16)
