

Procedure	<ol style="list-style-type: none"> <li>The EUT and supporting equipment were set up in accordance with the requirements of the standard on top of a 1.5m x 1m x 0.1m high, non-metallic table.</li> <li>The power supply for the EUT was fed through a 50W/50mH EUT LISN, connected to filtered mains.</li> <li>The RF OUT of the EUT LISN was connected to the EMI test receiver via a low-loss coaxial cable.</li> <li>All other supporting equipment were powered separately from another main supply.</li> <li>The EUT was switched on and allowed to warm up to its normal operating condition.</li> <li>A scan was made on the NEUTRAL line (for AC mains) or Earth line (for DC power) over the required frequency range using an EMI test receiver.</li> <li>High peaks, relative to the limit line, were then selected. 






EUT – Port Front View




Uncover 1 - Front View






EUT PCBA 1- Front View




EUT PCBA 1- Rear View




EUT PCBA 2- Front View




Conducted Emissions Setup Front View




Radiated Emissions Setup Below 1GHz Front View


