## 5 SAR Evaluation

### 5.1 RF Exposure Compliance Requirement

#### 5.1.1 Standard Requirement

According to KDB447498D01 General RF Exposure Guidance v05r02

##### 4.3.1. Standalone SAR test exclusion considerations

Unless specifically required by the published RF exposure KDB procedures, standalone 1-g head or body and 10-g extremity SAR evaluation for general population exposure conditions, by measurement or numerical simulation, is not required when the corresponding SAR Exclusion Threshold condition, listed below, is satisfied.

#### 5.1.2 Limits

The 1-g and 10-g SAR test exclusion thresholds for 100 MHz to 6 GHz at test separation distances  $\leq 50$  mm are determined by:

$$\left[ \frac{(\text{max. power of channel, including tune-up tolerance, mW})}{(\text{min. test separation distance, mm})} \right] \cdot \sqrt[3]{f(\text{GHz})} \leq 3.0 \text{ for 1-g SAR and } \leq 7.5 \text{ for 10-g extremity SAR, where}$$

$f(\text{GHz})$  is the RF channel transmit frequency in GHz

Power and distance are rounded to the nearest mW and mm before calculation<sup>17</sup>

The result is rounded to one decimal place for comparison

The test exclusions are applicable only when the minimum test separation distance is  $\leq 50$  mm and for transmission frequencies between 100 MHz and 6 GHz. When the minimum test separation distance is  $< 5$  mm, a distance of 5 mm is applied to determine SAR test exclusion

#### 5.1.3 EUT RF Exposure

##### For BLE mode

The Max Conducted Peak Output Power is 0.92dBm in Highest channel(2.480 GHz);

The best case gain of the antenna is 2 dBi

$\text{EIRP} = 0.92\text{dBm} + 2\text{dBi} = 2.92\text{dBm}$

2.92dBm logarithmic terms convert to numeric result is nearly 1.9588 mW

According to the formula. calculate the EIRP test result:

$$\left[ \frac{(\text{max. power of channel, including tune-up tolerance, mW})}{(\text{min. test separation distance, mm})} \right] \cdot \sqrt[3]{f(\text{GHz})}$$

General RF Exposure =  $(1.9588 \text{ mW} / 5 \text{ mm}) \times \sqrt[3]{2.480 \text{ GHz}} = 0.6169$  ①

SAR requirement:

$S = 3.0$

So the SAR report is not required.



**For Classic mode**

The Max Conducted Peak Output Power is 2.73dBm in Middle channel(2.441 GHz);

The best case gain of the antenna is 2dBi

EIRP= 2.73dBm + 2dBi = 4.73dBm

4.73dBm logarithmic terms convert to numeric result is nearly 2.9717 mW

According to the formula. calculate the EIRP test result:

$$\left[ \frac{(\text{max. power of channel, including tune-up tolerance, mW})}{(\text{min. test separation distance, mm})} \right] \cdot \sqrt{f(\text{GHz})}$$

General RF Exposure =  $(2.9717 \text{ mW} / 5 \text{ mm}) \times \sqrt{2.441 \text{ GHz}} = 0.9286$  ①
