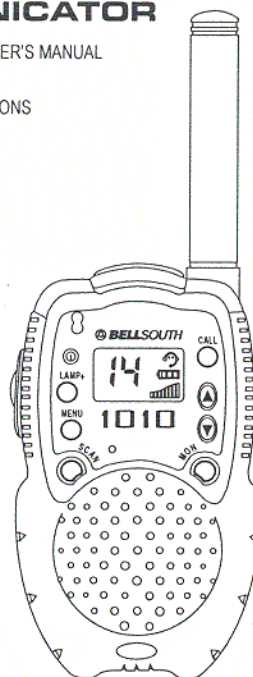

CAUTION

Damaged Antennas

Do not use any COMMUNICATOR that has a damaged antenna. If a damaged antenna comes in contact with the skin, a minor burn may result.

Batteries

The COMMUNICATOR is a lightweight, compact two-way communication device that can be used to communicate with family or friends at parks, shopping malls, sporting events, concerts -- any indoor or outdoor activity!

The COMMUNICATOR is compatible with other brands utilizing the same frequency band (operating in the frequency range from 462.5625MHz to 467.7125MHz).

The COMMUNICATOR has 14-CHANNELS, featuring a multi-functional LCD Screen (which displays the current channel and various status icons).

Other features include ELECTRONIC VOLUME CONTROL and BATTERY SAVE CIRCUITRY.

Please read this Owner's Manual carefully to get the most out of your TWO-WAY COMMUNICATOR.

NOTE: The maximum transmission range will vary depending on terrain and environment. Range will be greater in open fields, while range is shorter within and around buildings or large structures.

To clean the unit, wipe with a soft cloth dampened with water. Don't use cleaners or solvents on the unit; they can harm the body and leak inside, causing permanent damage. Battery contacts may be wiped with a dry, lint-free cloth.

If the unit gets wet, turn it off and remove batteries immediately. Dry battery compartment with a soft cloth to minimize potential water damage. Leave cover off the battery compartment overnight or until completely dry. Do not use the unit until completely dry.

To assure optimal unit performance and to ensure that exposure to RF energy is within the guidelines in the above standards, the following operating procedures should be observed:

FOR PORTABLE TWO-WAY COMMUNICATORS

- When transmitting with a COMMUNICATOR, hold COMMUNICATOR in a vertical position with its microphone 1 to 2 inches (2.5 to 5.0 cm) away from your mouth. Keep antenna at least 1 inch (2.5 cm) from your head and body.
- If you wear a COMMUNICATOR on your body, ensure that the antenna is at least one inch (2.5 cm) from your body when transmitting.

ELECTROMAGNETIC INTERFERENCE / COMPATIBILITY

Nearly every electronic device is susceptible to electromagnetic interference (EMI) if inadequately shielded, designed or otherwise configured for electromagnetic compatibility.

- Turn your unit OFF in any facilities where posted notices instruct you to do so. Hospitals or health care facilities may be using equipment that is sensitive to external RF energy.
- Turn your unit OFF when on board aircraft when instructed to do so. Any use of the unit must be in accordance with airline regulations or crew instructions.

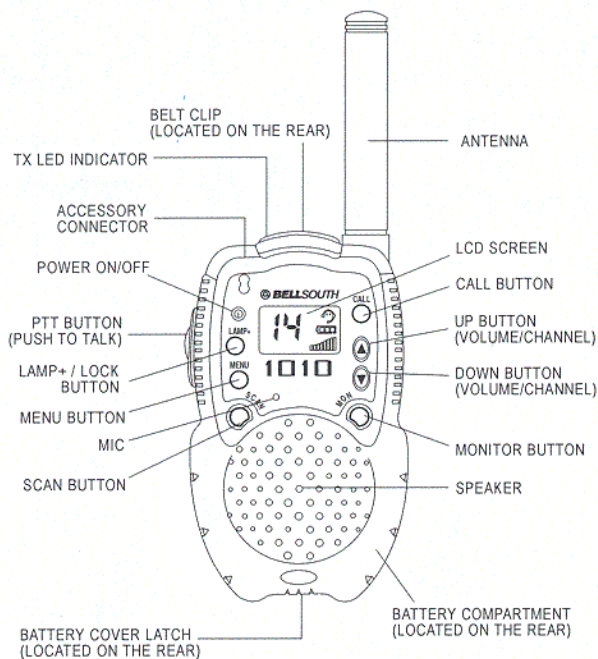

OPERATION

Battery Charge Level/Low Battery Indication

- The BATTERY CHARGE LEVEL is indicated by the number of squares present inside the BATTERY icon on the LCD SCREEN.
- When the battery charge level is low, the BATTERY icon will flash to indicate that the batteries need to be replaced.

Sending Call Tones

You can use Call Tones to alert the other user or to identify yourself. You can also use Call Tones to signal the beginning or the end of transmission.

- Press and release the [CALL] button.
- Release the [CALL] button, Your Call Tones will transmit.

Accessory Connection

The COMMUNICATOR model is designed to work with accessories. When those accessories are connected through ACCESSORY CONNECTOR, the HEADPHONE icon is prompted on the LCD SCREEN indicating the COMMUNICATOR is operating with accessories.

OPERATION

1. Select the desired channel before activation FULL SCAN. When a channel has been selected press the MENU button twice or once more during CHANNEL SCAN mode until a CTCSS number flashes. Press the SCAN button to activate CTCSS Code scan. The CTCSS number on the LCD Screen changes rapidly until an active CTCSS Code is detected.
2. When an active CTCSS Code (one of 38 codes) is detected, SCAN pauses keeping the active signal broadcasted. Press PTT to communicate through the active channel and FULL SCAN is deactivated. If another code is desired, press UP/DOWN button to search for another active CTCSS Code.
3. Press the SCAN button to deactivate CTCSS CODE SCAN. The SCAN stops at starting channel + CTCSS Code when no active channel is detected. But the SCAN stops at a different channel when an active channel is detected.

SPECIAL FEATURES

ANTENNA

LCD (Liquid Crystal Display) SCREEN - Displays current channel selection and other radio status symbols.

CALL BUTTON - Press to transmit CALL Tones.

UP/DOWN BUTTONS - Press to adjust volume level and change channels.

MIC - MICROPHONE

MONITOR BUTTON - Press to tune in and hold onto weak signals.

SPEAKER

BATTERY COMPARTMENT - Houses four (4) "AAA" ALKALINE or NiMH Batteries (not included).

BATTERY COVER LATCH - Secures BATTERY COVER.

SCAN BUTTON - Used to activate/deactivate CHANNEL SCAN.

MENU BUTTON - Allows you to change channels.

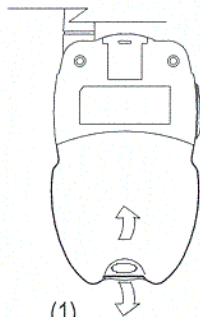

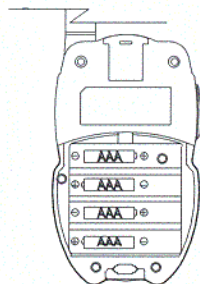

1. Release the BATTERY COVER LATCH located on the rear side of the unit (1), and remove the BATTERY COVER from the BATTERY COMPARTMENT (2) See Figure 1.
2. Install four (4) "AAA" Alkaline Batteries (not included) following the polarities as shown in Figure 2.
3. Reinstall the BATTERY COVER and lock the BATTERY COVER LATCH into position.

The COMMUNICATOR has a built in POWER SAVER feature for maximum battery life. But when the COMMUNICATOR is not being used, conserve battery power by pressing the **POWER** button to OFF.

Remove the batteries if the unit will not be used for a long period of time.

OPERATION

MONITOR

You can use the MONITOR feature to check for weak signals in the current channel.

- CTCSS Code deactivation: When an incoming signal does not have the same CTCSS Code, the TX/RX LED Indicator lights up in green, but no message is received. Press the **MONITOR** button to deactivate CTCSS Code. You can listen for incoming audio signal. CTCSS Code is deactivated when the **MONITOR** button is pressed.
- Press and hold the **MONITOR** button until it "beeps". MONITOR feature works continuously until released - press **MONITOR** button to deactivate this feature.
- Press the **MONITOR** button for channel skipping during SCAN mode.

LAMP+ (LAMP/BUTTON LOCK)

- Press and release the **LAMP+** button to light up the LCD SCREEN. The backlight will automatically shut off after 4 seconds when no other button has been pressed
- Press and hold the **LAMP+** button until the LOCK icon is displayed. Volume and channel scan operations are disabled during **BUTTON LOCK** Mode. Press and hold the **LAMP+** button again to deactivate **BUTTON LOCK** mode.

CHANNEL SCAN

Channel Scan performs searches for active signals in an endless loop from 1 to 14, and an endless CTCSS Code loop from 0 to 38.

1. Press and release the **MENU** button and the current number flashes. Press the **SCAN** button to activate CHANNEL SCAN. The CTCSS number is set at 0, and the channel number on the LCD Screen changes rapidly until an active signal is detected.
2. When an active signal (one of 14 channels) is detected, SCAN pauses keeping the active signal broadcasted. Press **PTT** to communicate through the active signal channel and **FULL SCAN** is deactivated. If another channel is desired, press **UP/DOWN** button to continue searching.
3. Press **SCAN** button to deactivate CHANNEL SCAN. The SCAN stops at starting channel when no active channel is detected. But the SCAN stops at a different channel when an active channel is detected.

NOTE: Volume and channel change operations are disabled during **BUTTON LOCK** mode. Press and hold **LAMP+** again to deactivate **BUTTON LOCK** mode.

Changing CHANNELS

The COMMUNICATOR has 14 available channels. To change channels:

1. Press and hold the **MENU** button until the current channel number flashes on the LCD SCREEN.
2. While the channel number is flashing:
 - Press the **UP** (**▲**) button to move to a higher channel.
 - Press the **DOWN** (**▼**) button to move to a lower channel.
 - The channel changes from 1 to 14, or from 14 to 1.
3. Press the **MENU** button or **PTT** button to select the desired channel and return to NORMAL mode.

NOTE: Refer to the "Channel Table" section of this owner's manual for detailed frequency listings.

Changing CTCSS CODE - Sub-channel

The Communicator has 38 available CTCSS Codes. Please set CTCSS Code in addition to channel setting if you do not want to be bothered by someone else. To set CTCSS Code:

1. Press the **MENU** button twice until the current CTCSS number flashes. (Or press the **MENU** button again when you are in Channel Setting mode.)
2. While the CTCSS Number is flashing:
 - Press the **UP** (**▲**) button to move to a higher Code.
 - Press the **DOWN** (**▼**) button to move to a lower Code.
 - The channel changes from 0 to 38, or from 38 to 0.
3. Press the **MENU** button or **PTT** button to select the desired channel and CTCSS Code, and return to NORMAL mode.

Removing the BELT CLIP

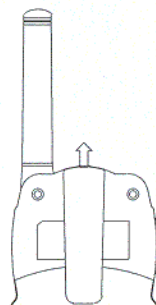

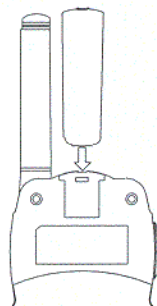

1. Pull the BELT CLIP LATCH away from the unit.
2. While pulling the BELT CLIP LATCH, push up on the BELT CLIP to remove it from the unit, as shown in Figure 3.

Installing the Belt Clip

1. Slide the BELT CLIP into the BELT CLIP SLOT as shown in Figure 4.
2. A "click" indicates the BELT CLIP is locked into position.

Turning the Unit ON

Press and hold the **POWER** button. The unit will "beep" and the LCD SCREEN will briefly display a SELF-TEST SCREEN.

Turning the Unit OFF

Press and hold the **POWER** button. The unit will beep and the LCD SCREEN will turn blank.

Adjusting Speaker Volume

- Press the **UP** () button increase the **SPEAKER** volume.
- Press the **DOWN** () button to decrease the **SPEAKER** volume.
- The Speaker volume level is indicated by the number of bars displayed in the lower right corner of the LCD SCREEN.

Receiving a Signal

The unit is continuously in the **RECEIVE** mode when the unit is ON. When you receive a signal, the current channel is displayed. (See "LCD Screen" for details).

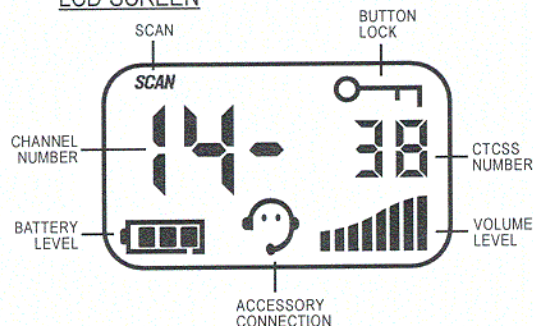
Transmitting a Signal






1. Check channel activity by pressing and holding the **PTT** button to **TRANSMIT**. The **TX LED INDICATOR** will light up in red. You'll hear static if the channel is clear to use. Don't transmit if someone is talking on the channel. Hold the unit in a vertical position with the microphone 2 to 3 inches from the mouth.
2. While holding the **PTT** button, speak into the unit using a normal tone of voice.
3. Release the **PTT** button when you have finished transmitting.

NOTE: In order for other people to receive your transmission, they must also be on the same channel you are currently using. Refer to the "Changing Channels" section for more information.
