






Radiated Prescan



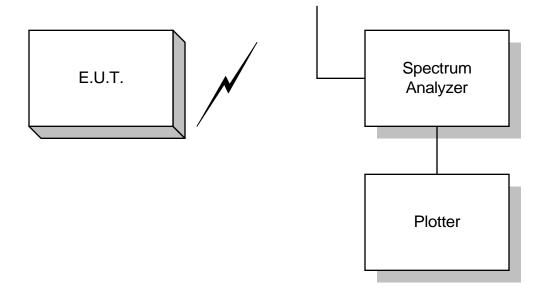
Outdoor Test Site For Radiated Emissions
