









#### Test Procedure:

- (1) On a test site, the EUT shall be placed on a turntable and in the position closest to the normal use as declared by the user.
- (2) The test antenna shall be oriented initially for vertical polarization located 3m from the EUT to correspond to the transmitter.

- (7) The test antenna shall be raised and lowered again through the specified range of height until the measuring receiver detects a maximum signal level.
- (8) The maximum signal level detected by the measuring receiver shall be noted.
- (9) The measurement shall be repeated with the test antenna set to horizontal polarization.
- (10) Replace the antenna with a proper Antenna (substitution antenna).
- (11) The substitution antenna shall be oriented for vertical polarization and, if necessary, the length of the substitution antenna shall be adjusted to correspond to the frequency of transmitting.
- (12) The substitution antenna shall be connected to a calibrated signal generator.
- (13) If necessary, the input attenuator setting of the measuring receiver shall be adjusted in order to increase the sensitivity of the measuring receiver.




