











**6.6.3 Measurement Procedure and Data****Test Procedure:**

- (1)On a test site, the EUT shall be placed on a turntable and in the position closest to the normal use as declared by the user.
- (2)The test antenna shall be oriented initially for vertical polarization located 3m from the EUT to correspond to the transmitter.




