

8. The FCC identifier is located inside the battery compartment and will also appear on the box

7. MODEL: PRINT THE FULL MODEL NUMBER AS IN BOM & PO (WITHOUT THE ITEM NO.)
e.g. IF "TARGUS ABC1234US-10" IS PROVIDED, THE MODEL NUMBER IS "ABC1234US".

NOTE: YOU CAN MAKE THE LABEL WITH THE BASIC MODEL (e.g. ABC12) AND PRINT "34US" USING THE SAME METHOD AS PRINTING THE SERIAL NO. (no need to underline).

6. ITEM NUMBER: THE 2 DIGITS SHOULD FOLLOW THE BOM &/OR PO FOR THE PRODUCT.
e.g. IF "TARGUS ABC1234-10" IS PROVIDED, THE ITEM NUMBER IS "10".

NOTE: YOU CAN PRINT THE ITEM NO. USING THE SAME METHOD AS PRINTING THE SERIAL NO. (no need to underline).

5. SERIAL NUMBER: YY = MFG YEAR, MM = MFG MONTH, THE SIX DIGITS FOLLOWING THE MONTH IS THE SEQUENTIAL QTY COUNT FOR THE SAID MONTH.
e.g. IF 5000 PCS OF TARGUS P/N AMXXXX WERE PRODUCED IN AUGUST 2005,
THE SERIAL NUMBER WILL RUN FROM 0508000001 TO 0508005000.

4. PRODUCT SAFETY MARKING(S): FCC, CE, C-TICK, WEEE, CLASS 2 LASER PRODUCT & WARNING (another label)

3. PERMANENT ADHESIVE BACKING.
