1. Overview and specifications

(1) Overview

The remote control uses wireless communication in the 2.4 GHz band and can control the STB. It also makes it easier for the user to control the remote control by providing voice assistance while it is connected to the STB.

2. Precautions

- (8) Discard the batteries used in the designated location.
