

Figure 1. Below 30MHz




Figure 2. 30MHz to 1GHz




Figure 3. Above 1 GHz





- 2) Scan from 9kHz~25GHz, The disturbance above 13GHz and below 30MHz was very low, and the above harmonics were the highest point could be found when testing, so only the above harmonics had been displayed.
- 3) As shown in this section, for frequencies above 1GHz, the field strength limits are based on average limits. However, the peak field strength of any emission shall not exceed the maximum permitted average limits specified above by more than 20 dB under any condition of modulation. So, only the peak measurements were shown in the report.




Figure 1. 30MHz to 1GHz




Figure 2. Above 1 GHz


