Pout = output power to antenna in mW

G = gain of antenna in linear scale

Pi = 3.1416

R = distance between observation point and center of the radiator in cm

Classification:

The antenna of this product, under normal use condition, is at least 20cm away from the body of the user.

Therefore, the worst-case situation is 0.000507mW/cm², which is less than "1". This confirmed that the device compliance with FCC 1.1310 MPE limit.
