1 General Information

1.1 General Description

The equipment under test (EUT) is a receiver for remote control toy car operating at 49.860 MHz.

The EUT is charged by its remote controller. When the charging process complete, the EUT receive the signal from transmitter and move forward, backward left or right direction.

The brief circuit description is listed as follows:

- Q7 and associated circuit act as RF amplification
- I.C. and associated circuit act as decoding and oscillation
- Q3, Q4, Q5 & Q6 and associated circuit act as motor control
- Q1 & Q2 and associated circuit act as L/R control

1.2 Related Submittal Grants

This is a single application for certification of a receiver. The transmitter for this receiver is authorized by Certification procedure.

2 Description of the radiated emission test

2.1 Test Procedure

Radiated emissions measurements are investigated and taken pursuant to the procedures of ANSI C63.4 – 1992.

The equipment under test (EUT) was placed on a non-conductive turntable with dimensions of 1.5m x 1m and 0.8m high above the ground. 3m from the EUT, a broadband antenna mounting on the mast received the signal strength. The turntable was rotated to maximize the emission level. The antenna was then moving along the mast from 1m up to 4m until no more higher value was found. Both horizontal and vertical polarization of the antenna were placed and investigated.

2.2 Test Result

The fundamental emission was based on measurements employing the peak detector on the open area test site.

The harmonic emissions meeting the requirement of section 15.209 are based on measurements employing the CISPR qusai-peak detector.

* Emissions appearing within the restricted bands shall follow the requirement of section 15.205.

It was found that the EUT meet the FCC requirement.
