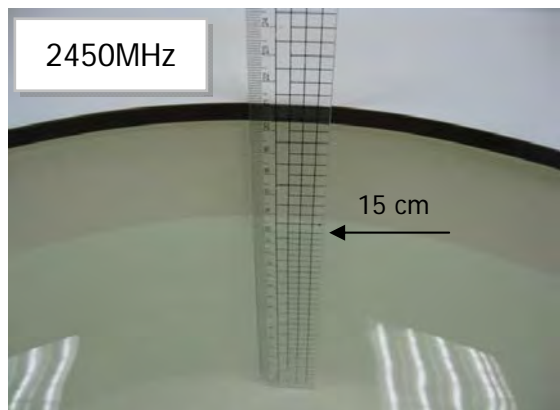

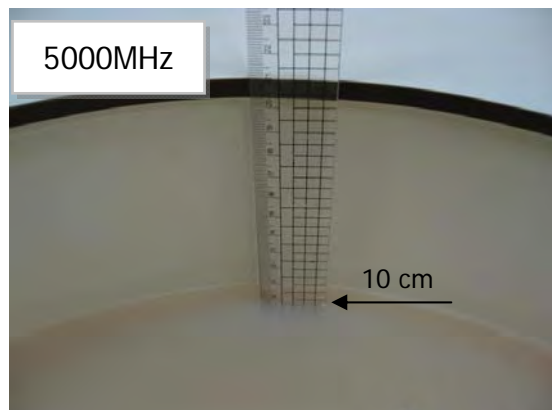

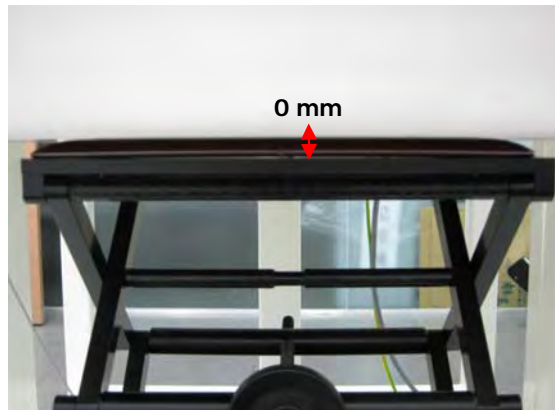

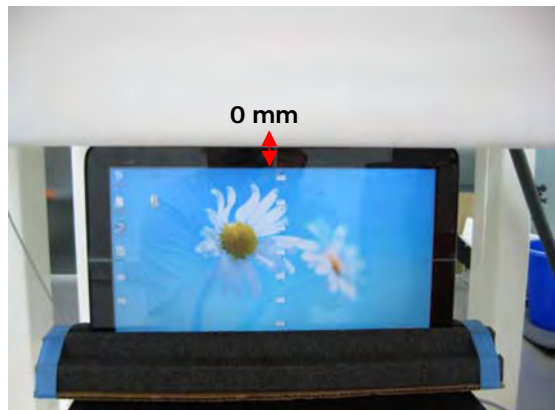

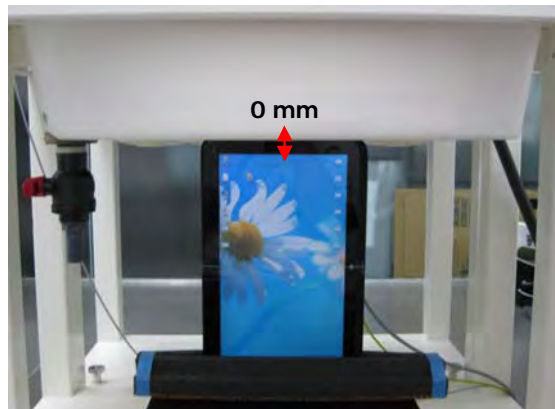

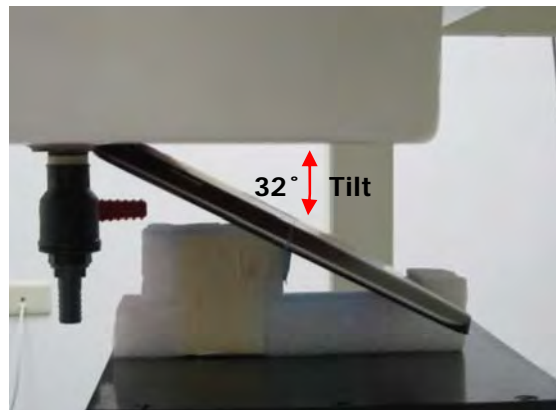


Fig.6 EUT Curve Edge to flat phantom

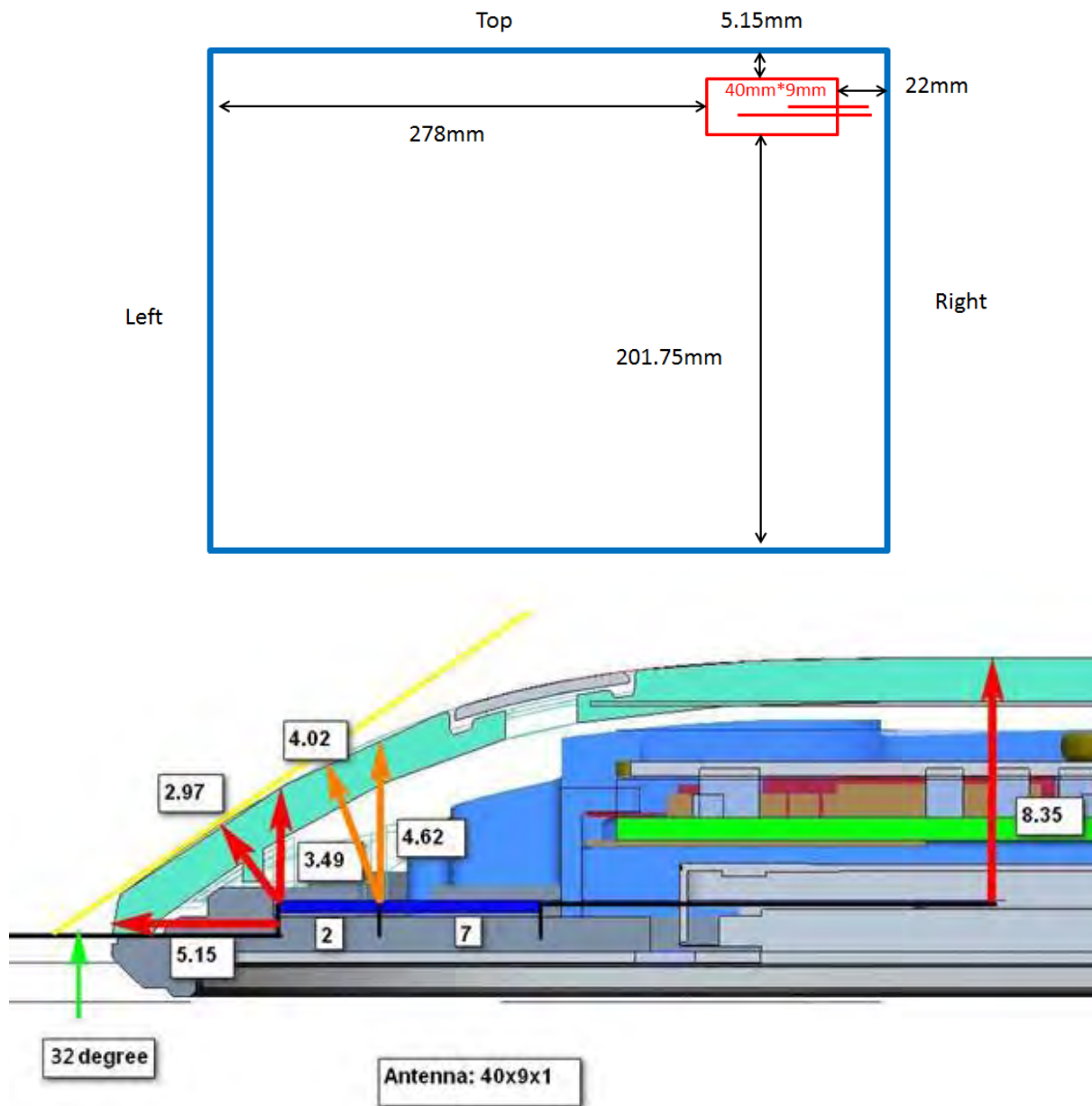


Fig.12 Antenna position of EUT
