# ⊕ FCC requirements for e-label implementation


Lenovo will meet the following requirements without problem.

- Regulatory Information can be shown in no more than three steps without special accessories.
- The instruction how to access the information will be included in the User's manual
- Lenovo will provide Intel with User's manual including the instruction as submittal application.

## **B. Access to the required information on the e-label**

1. Users must be able to access the information without requiring special access codes or permissions and, in all cases the information must be accessible in no more than **three steps** in a device's menu.<sup>6</sup>
2. Devices must not require special accessories or supplemental plug-ins (e.g., the installation of a SIM/USIM card) to access the information.
3. Users must be provided specific instructions on how to access the information. The instructions must be included in the User's manual, operating instructions, insert in the packaging materials, or other similar means.<sup>7</sup> Alternately, the access information may be available on the product related website with instructions on how to access the website provided in the packaging material.
4. The equipment authorization application for the device must clearly include the instructions for accessing information as part of the exhibit showing the label information.


- Boot up screen is shown after pressing Power button

# • Step 1 : BIOS boot up




- Press [Enter] key (clamshell products) / touch the prompt message (tablet products) to open “Startup Interrupt Menu”  
---> Go to the next page
- Press [F9] key to enter “Regulatory Information” page directly (clamshell products )  
---> Go to Page 6

## • Step 2 : Press [F9] key to show Regulatory Information



- Press [F9] key (clamshell products) or touch the Regulatory Information selection (tablet products) to open “Regulatory Information” page

# • Step 3 : Regulatory Information page is displayed



- \* If [F9] key is pressed at Step 1, “Startup Interrupt Menu” is skipped and “Regulatory Information” page is displayed directly
