



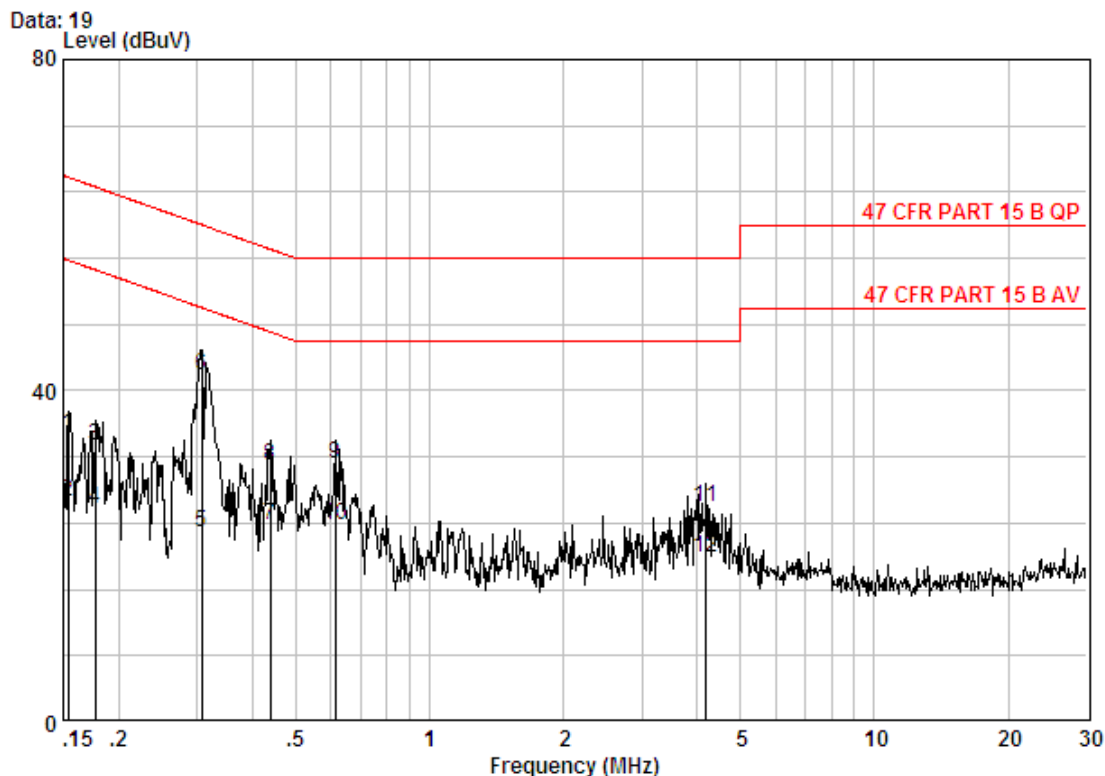

Live line:



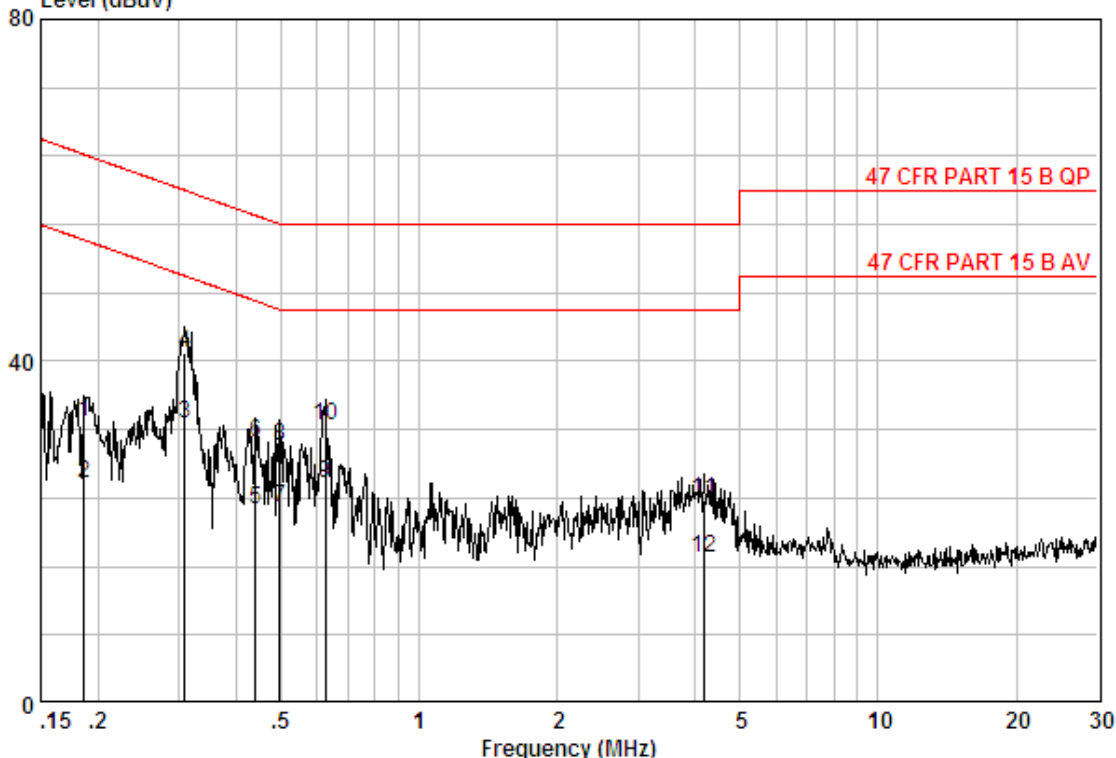

Figure 1. Below 30MHz

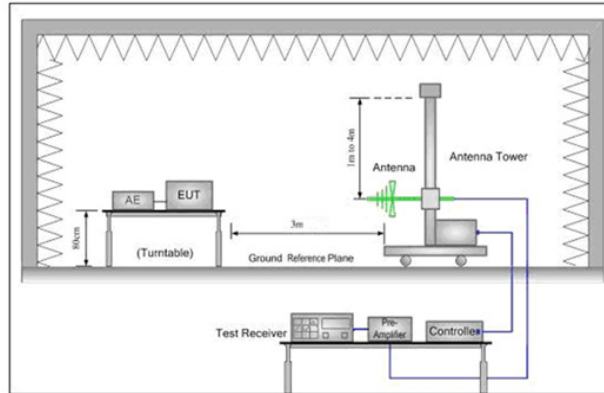


Figure 2. 30MHz to 1GHz

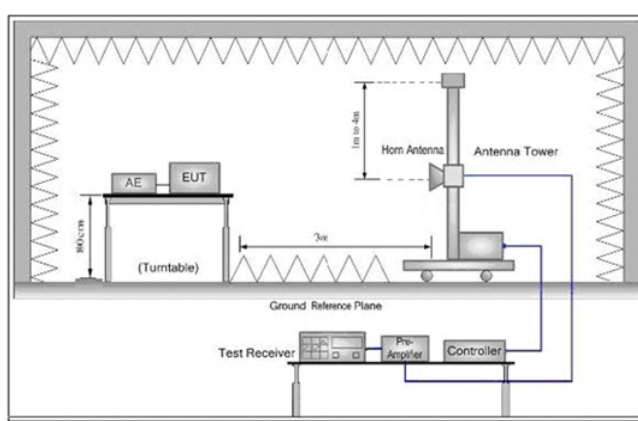


Figure 3. Above 1 GHz

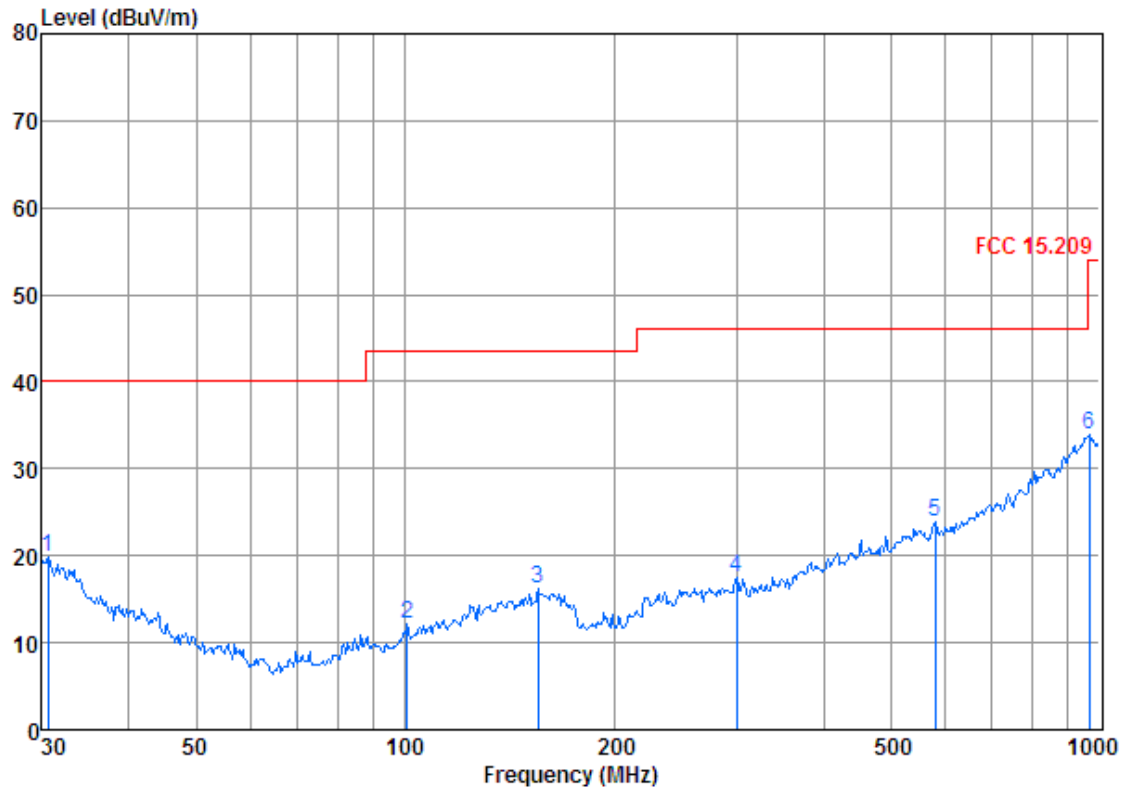

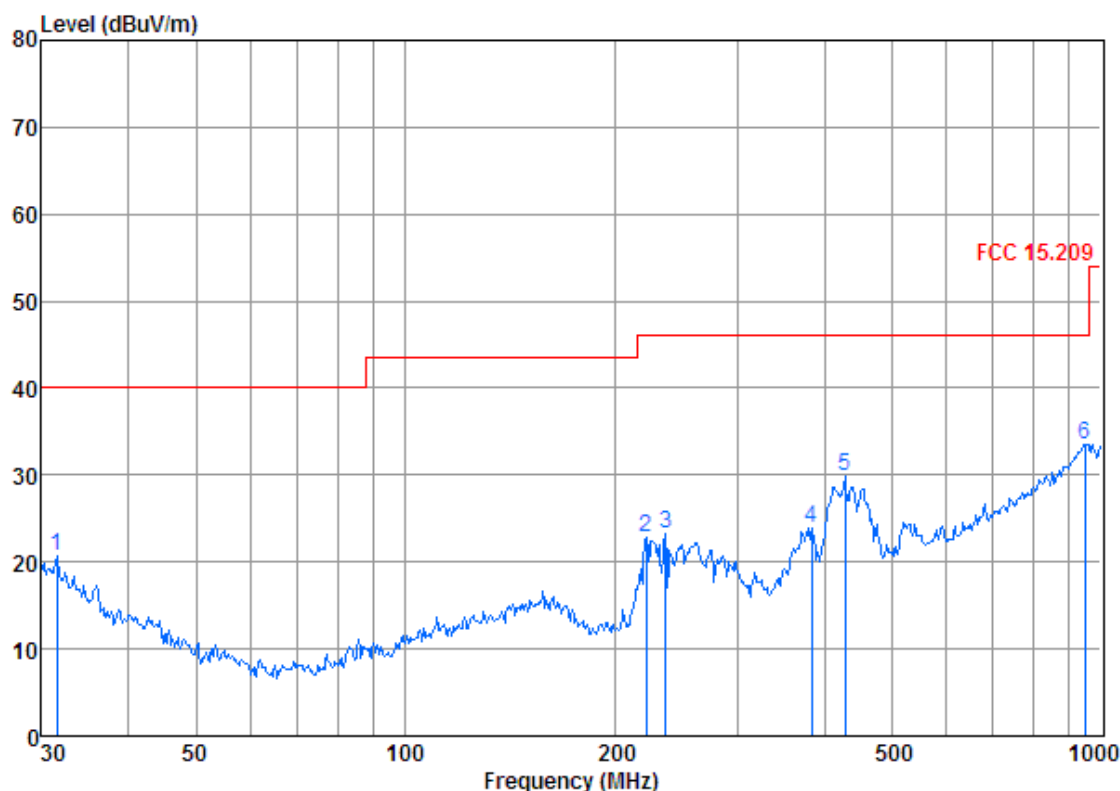

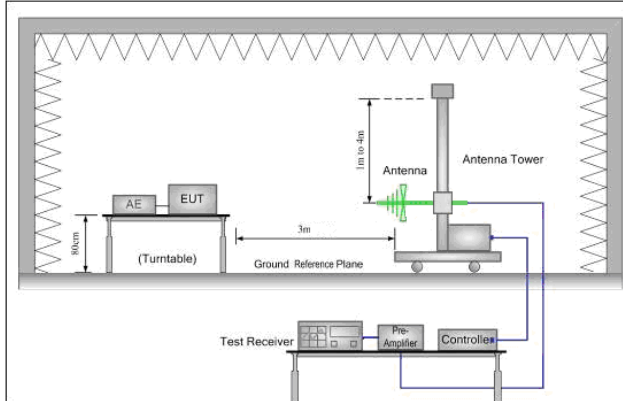


Figure 1. 30MHz to 1GHz

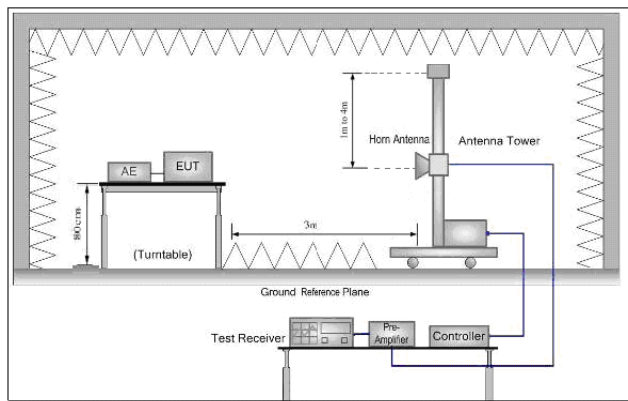


Figure 2. Above 1 GHz

The table was rotated 360 degrees to determine the position of the highest radiation.</li><li>b.
