LightPointe Communications, Inc. hereby declares that products: *Aire X-Stream G80 PLUS series*, model(s):

SAXI-1250-93X-M8S, system comprised of units LAXI-1250-91X-M8S and LAXI-1250-92X-M8S

SAXI-1250-93E-M8S, system comprised of units LAXI-1250-91E-M8S and LAXI-1250-92E-M8S


are electrically identical with the same electromagnetic emissions and electromagnetic compatibility characteristics as models: *SAXI-1250-93X-S3S* and *SAXI-1250-93E-S3S* system, comprised of units *LAXI-1250-91X-S3S*, *LAXI-1250-92X-S3S* and *LAXI-1250-91E-S3S*, *LAXI-1250-92E-S3S*, respectively and tested by BACL, the results of which are featured in BACL project: *R1608172*.
