

**Test Method:**

The sample was placed 0.8m above the ground plane on the OATS \*. Measurements in both horizontal and vertical polarities were performed. During the test, each emission was maximized by: having the EUT continuously working, investigate all operating modes, rotated about all 3 axis (X, Y & Z) to obtain worst position, manipulating interconnecting cables, rotating turntable, varying antenna height from 1m to 4m in both horizontal and vertical polarizations. The emissions worst-case are shown in Test Results of the following pages.





## **Appendix B**

### **Duty Cycle Correction During 100msec**

Each function key sends a different series of characters, but each packet period (25.575msec) never exceeds a series of 28 long or short (525 $\mu$ sec) pulses. Assuming any combination of short and long pulses may be obtained due to encoding the worse case transmit duty cycle would be considered  $28 \times 525\mu\text{sec} / 25.575\text{msec} = 57.4\%$  duty cycle. Figure A through C show the characteristics of the pulse train for one of these functions.

Remarks:

Duty Cycle Correction =  $20\log(0.574) = -4.8\text{dB}$

Figure A [Pulse Train]





Figure B [Long and Short Pulse]


### Front View of the product




## Rear View of the product
