**Re: USER MANUAL FOR THE WALKIE TALKIE #22300**

**CAUTION:**

1. YOUR TRANSCIVER SET HAS BEEN FULLY ADJUSTED PRIOR TO SHIPMENT FROM THE FACTORY. BE SURE NOT TO TOUCH THE INTERNAL COMPONENTS OTHER THAN TO REPLACE BATTERIES.
2. WHEN THE SOUND BECOMES WEAK, IT IS TIME TO CHANGE THE BATTERY.
3. AFTER USE, ALWAYS TURN THE "ON/OFF/VOLUME" DIAL TO THE "OFF" POSITION.
4. KEEP YOUR SET IN A CLEAN, DRY PLACE.

**HOW TO OPERATE YOUR TRANSCIVER:**

1. UNSCREW AND OPEN BATTERY COVER TO SNAP IN A 9-VOLT BATTERY.
2. TURN THE "ON-OFF-VOLUME" DIAL TO THE "ON" POSITION.
3. TURN THE VOLUME CONTROL KNOB TO ADJUST THE SOUND LEVEL.
4. PRESS THE "PUSH-TO-TALK" BUTTON TO TRANSMIT.
5. RELEASE THE "PUSH-TO-TALK" BUTTON TO RECEIVE.
6. WHEN TRANSMITTING, SPEAK IN A CLEAR VOICE WITH THE MICROPHONE ABOUT THREE INCHES FROM YOUR MOUTH.
7. BEST TRANSMISSION AND RECEPTION IS ACHIEVED WHEN THE ANTENNA IS HELD IN A VERTICAL POSITION.

**HOW TO USE MORSE CODE:**

1. TURN THE "ON-OFF" DIAL TO THE "ON" POSITION.
2. WHILE PUSHING THE "PUSH-TO-TALK" SWITCH, PRESS IN THE "MORSE CODE" BUTTON MOMENTARILLY AND RELEASE FOR DESIRED SIGNAL LENGTH.
3. FOR ACHIEVING A SIGNAL, ADJUST THE VOLUME CONTROL FOR NORMAL LISTENING LEVEL.
