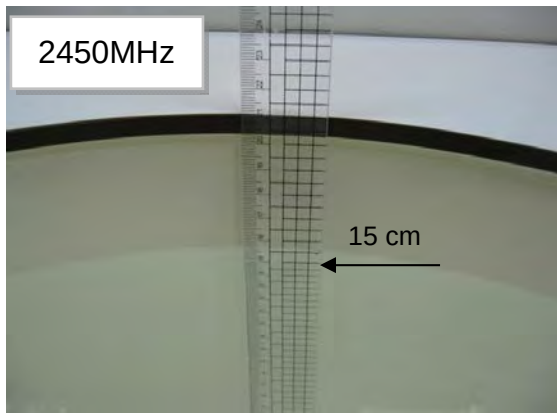

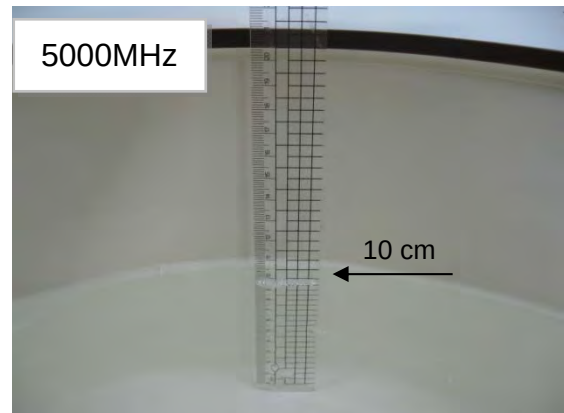

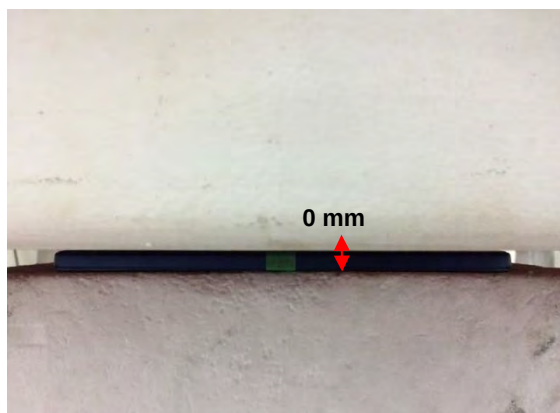


Fig.3 EUT Back side to flat phantom

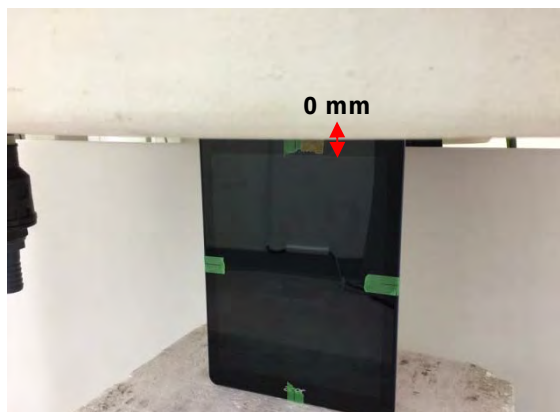


Fig.4 EUT Top side to flat phantom

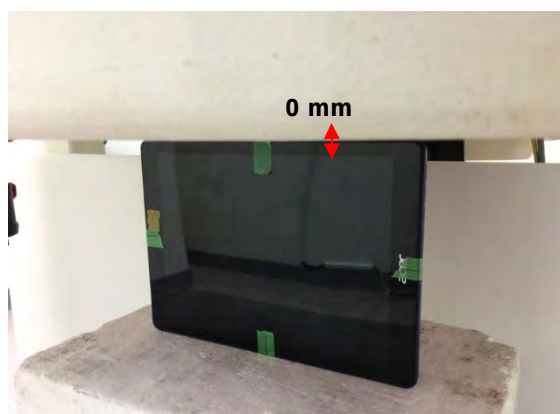


Fig.5 EUT Right side to flat phantom

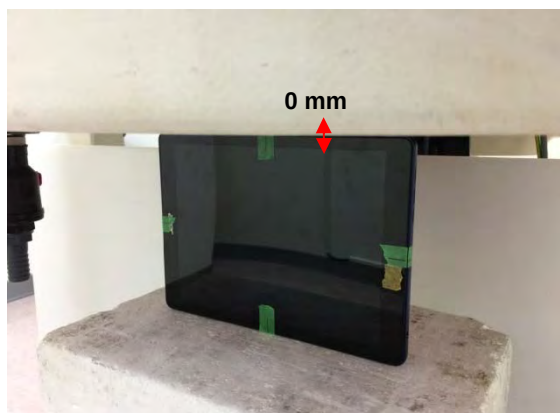

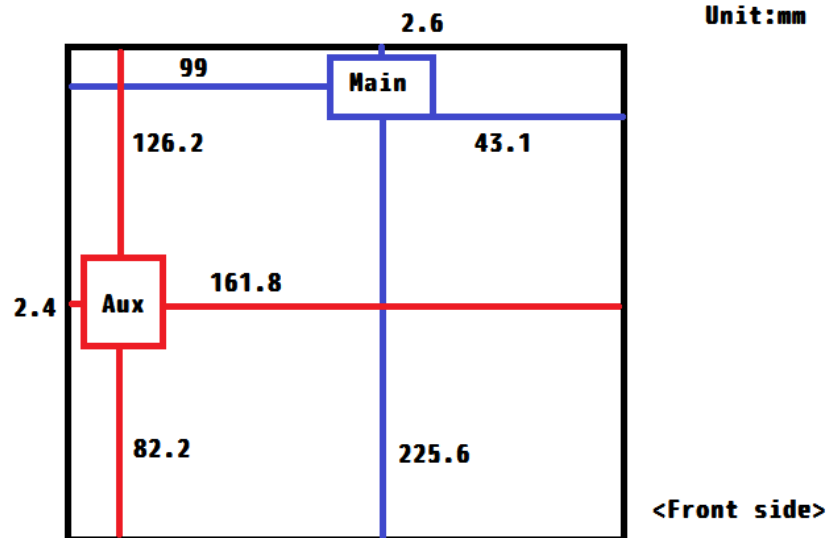


Fig.9 Antenna position of EUT
