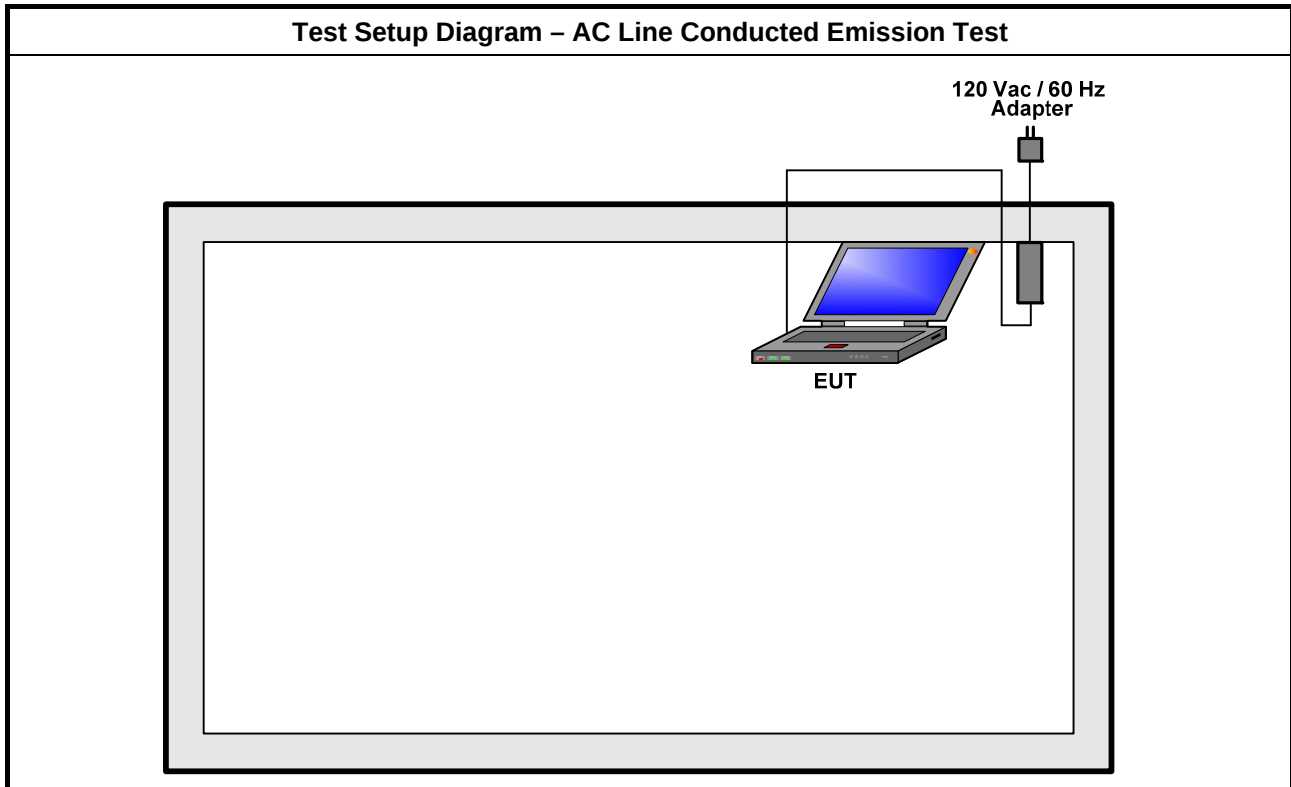

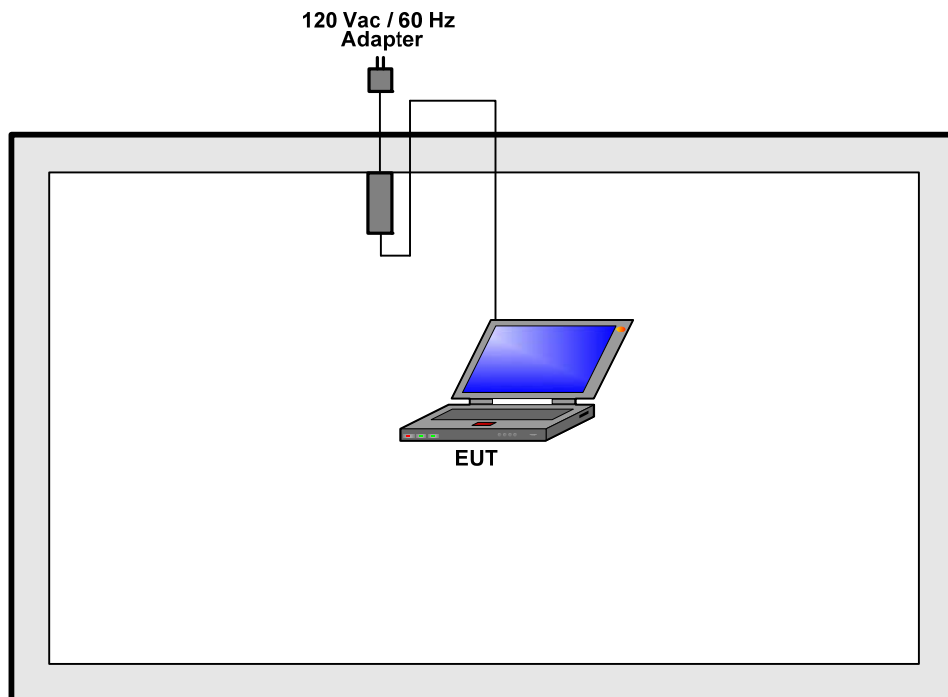

Test Setup Diagram - Radiated Emission Above 1GHz Test



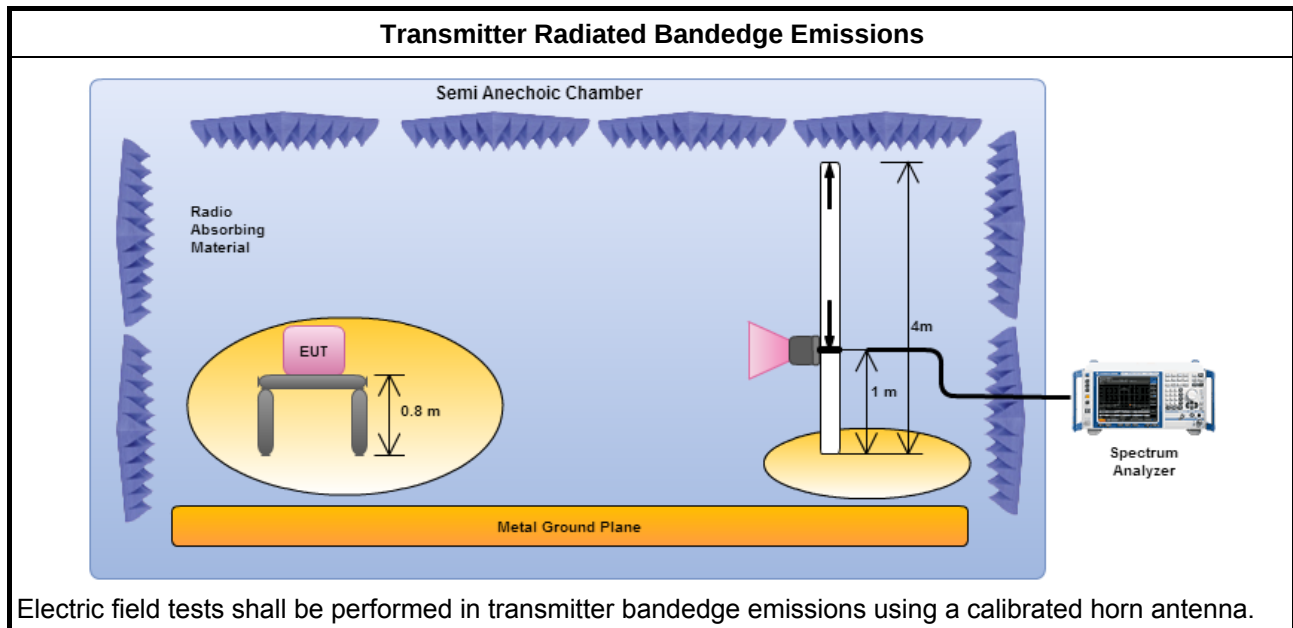

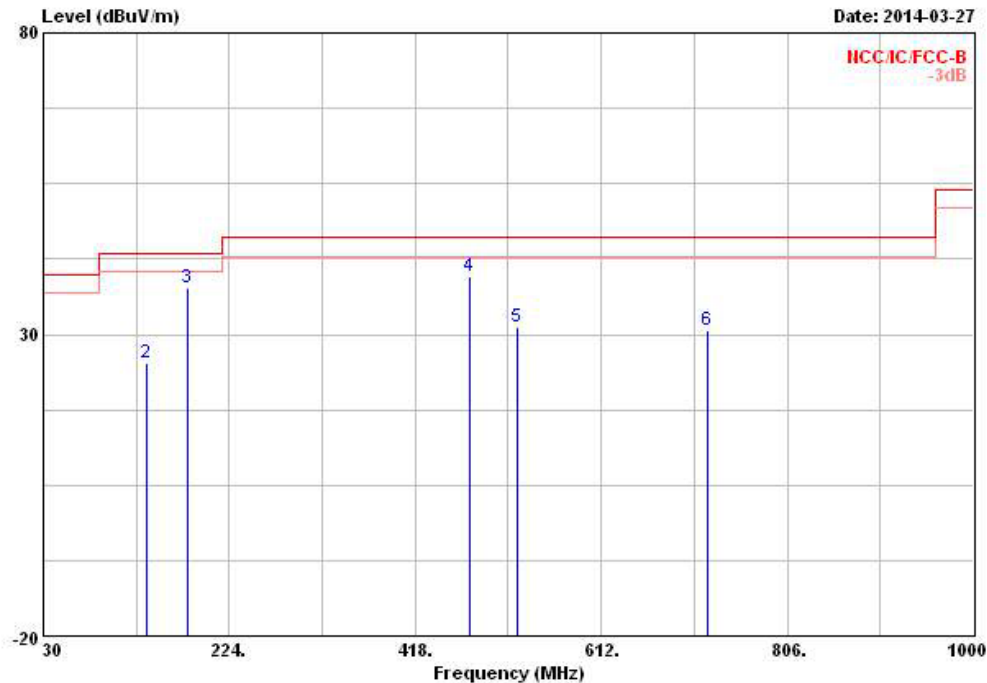

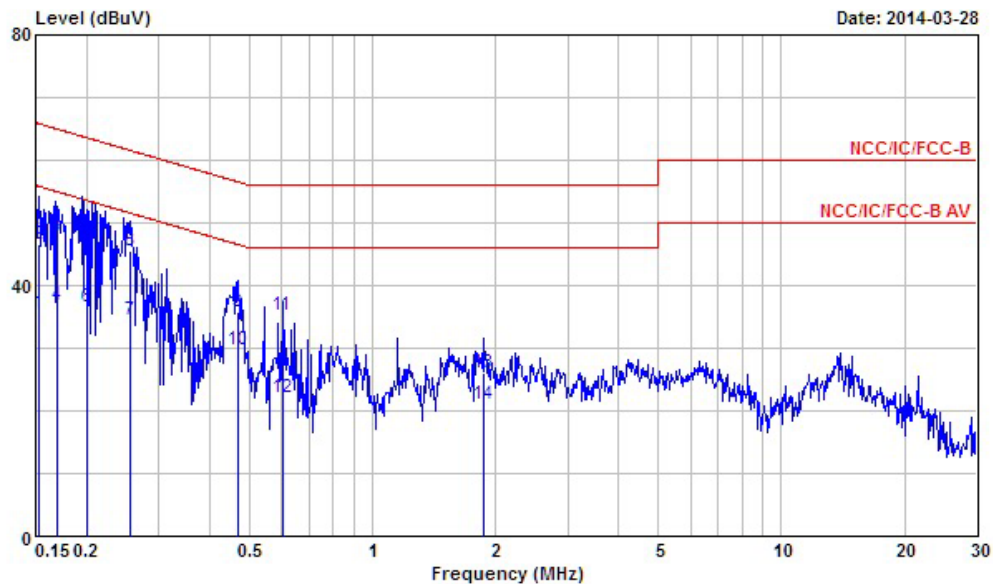
