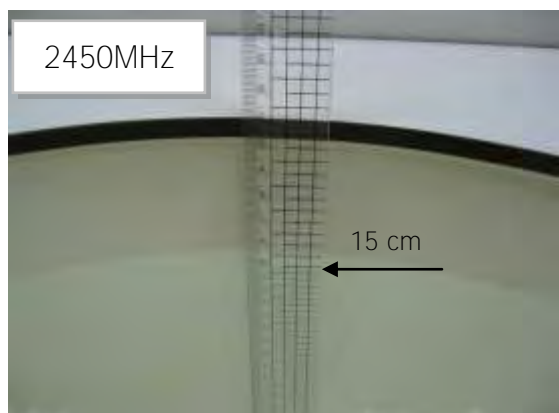

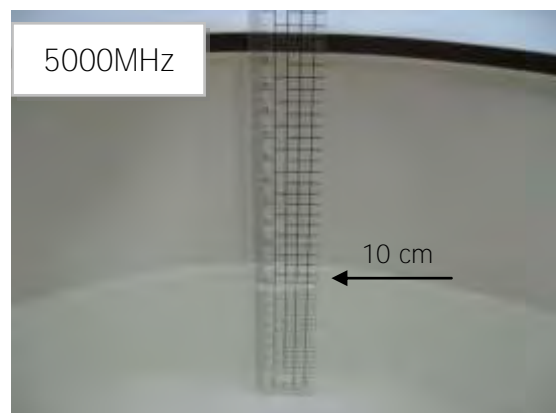

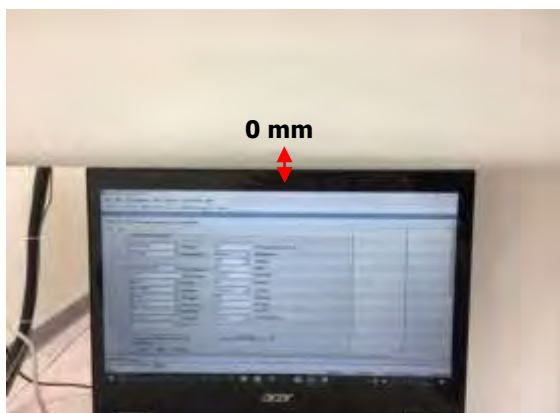


Fig.3 EUT Top side to flat phantom (tablet mode)

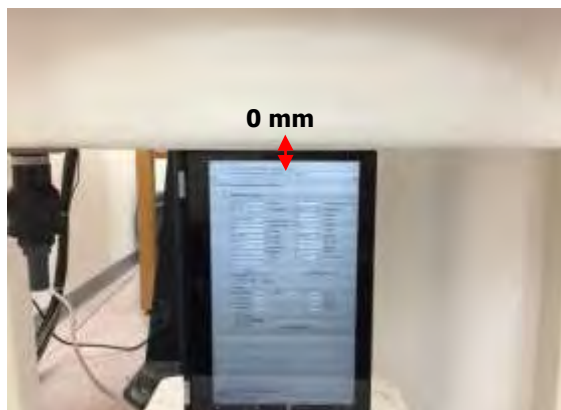


Fig.6 EUT Left side to flat phantom (tablet mode)

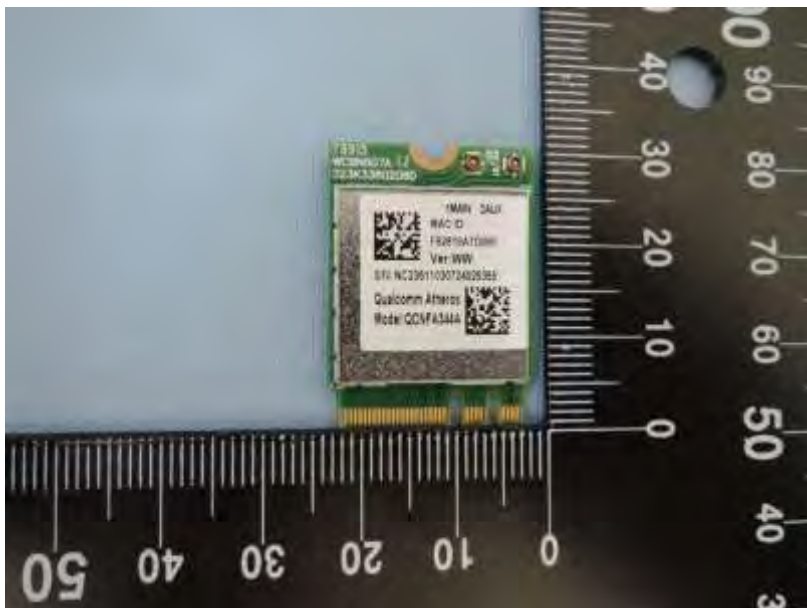


Fig.10 Back view_2

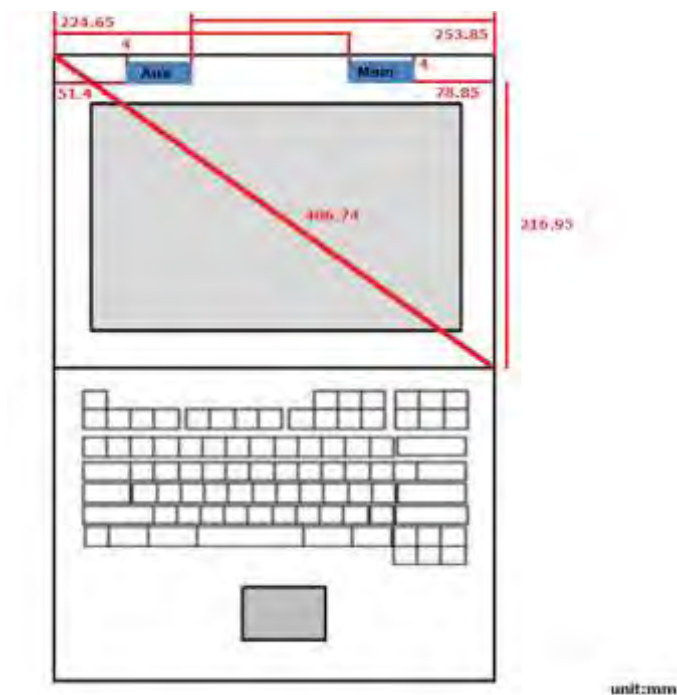


Fig.11 Antenna location

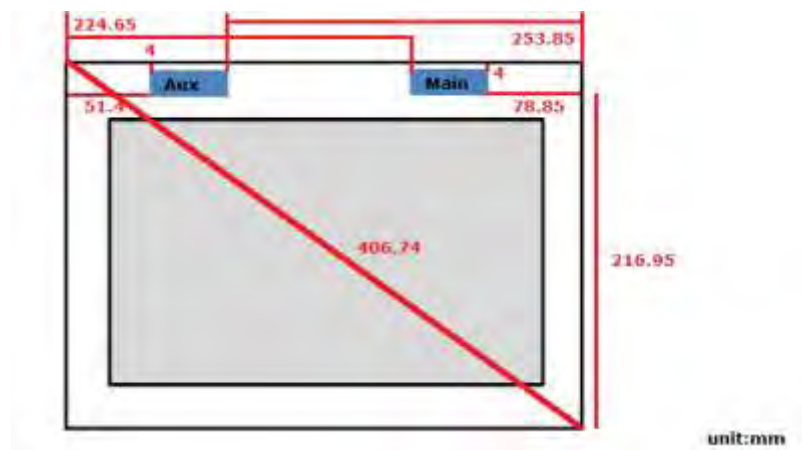

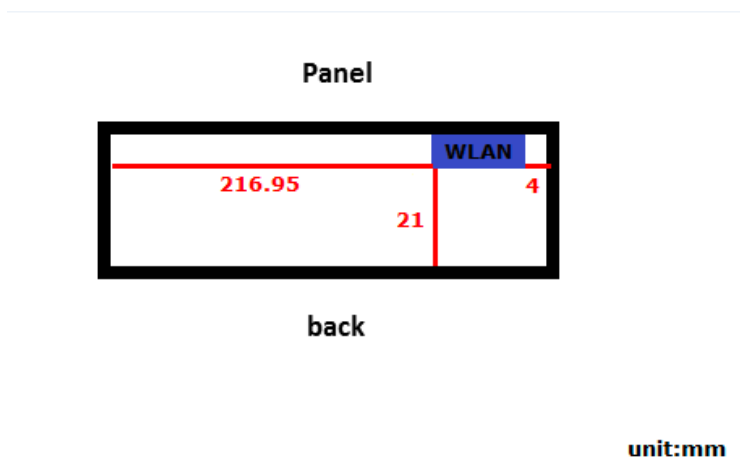
