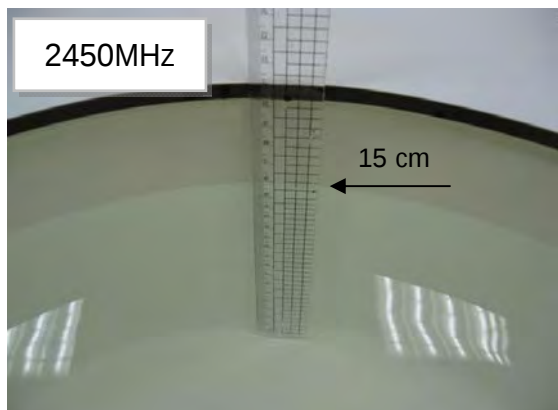

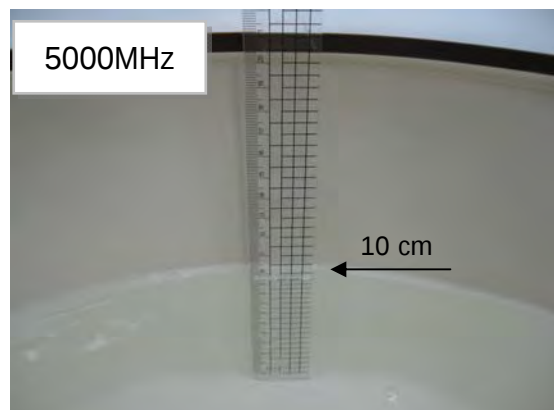

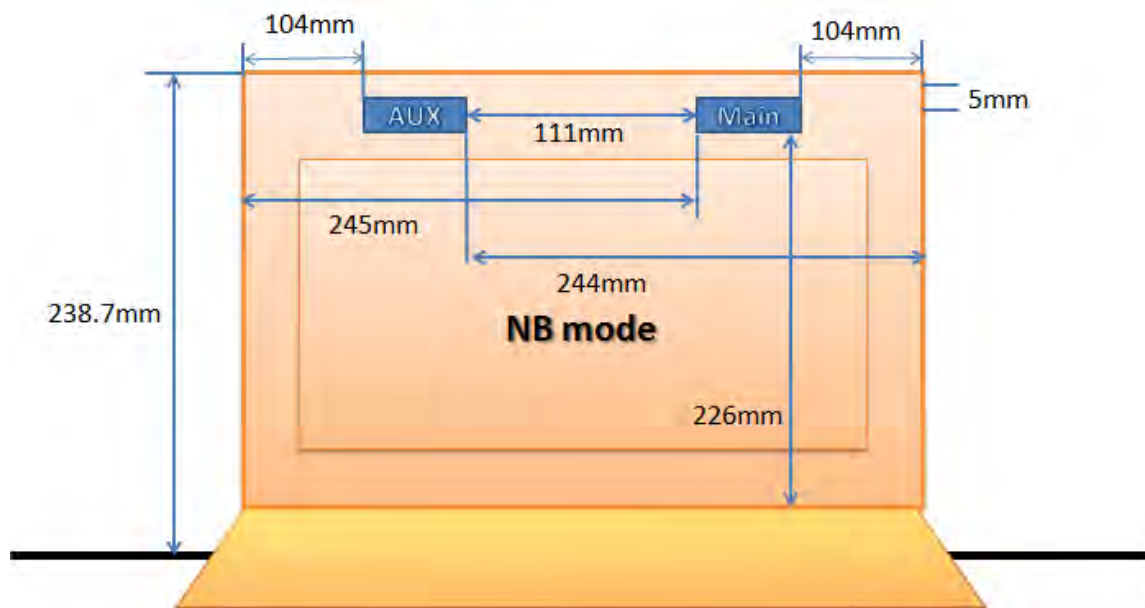


Fig.7 Antenna position of EUT
