### **1 General Information**

#### **1.1 General Description**

The equipment under test (EUT) is a transmitter for Micro Slider. Operating at 27.145 MHz which is controlled by a crystal. The EUT is powered by 9V battery. There are six buttons and one on / off switch on the EUT. When the A~D button is pressed once, it will transmit a radio frequency for receiver go forward and backward or turn left and turn right. When the E~F button is pressed once, it will transmit a radio frequency for receiver slider sideways running.

The brief circuit description is listed as follows :

- U1 and associated circuit act as encoder.
- Q3 and associated circuit act as power control.
- Q1, X1 and associated circuit act as oscillator.
- Q2 and associated circuit act as amplifier.

The model(s) 60-4395 is the same as model 60-4394 in hardware aspect. The difference between these models is matching with different receiver.

#### **1.2 Related Submittal Grants**

This is a single application for certification of a transmitter.

The receiver for this transmitter is exempted from the Part 15 technical rules per 15.101(b).

### **2 Description of the radiated emission test**

#### **2.1 Test Procedure**

Radiated emissions measurements are investigated and taken pursuant to the procedures of ANSI C63.4 – 2001.

The equipment under test (EUT) was placed on a non-conductive turntable with dimensions of 1.5m x 1m and 0.8m high above the ground. 3m from the EUT, a broadband antenna mounting on the mast received the signal strength. The turntable was rotated to maximize the emission level. The antenna was then moving along the mast from 1m up to 4m until no more higher value was found. Both horizontal and vertical polarization of the antenna were placed and investigated.

The device was rotated through three orthogonal axes to determine which attitude and configuration produce the highest emission during measurement.

#### **2.2 Test Result**

Peak Detector data was measured unless otherwise stated.

\* Emissions appearing within the restricted bands shall follow the requirement of section 15.205.

It was found that the EUT meet the FCC requirement.

#### **5.1 Bandwidth**

The plot on saved in TestRpt 2.pdf shows the fundamental emission is confined in the specified band. It also shows that the band edge met the 15.209 requirement at 26.9599 and 27.2801 MHz.

#### **5.2 The duty cycle is simply the on-time divided by the period :**

The duration of one cycle = 36.90ms

Effective period of the cycle =  $(1.6\text{ms} \times 8) + (480\mu\text{s} \times 8)$   
= 16.64ms

Duty Cycle =  $(16.64 / 36.90) \text{ms}$   
= 0.451

Therefore, the average factor is found by  $20 \log_{10} 0.451 = -6.9 \text{ dB}$





### **Duty Cycle 1**




