

PK (VERSION):

- · Install your lights within Wi-Fi range
- When installing on a rope or cable, hook every other bulb onto the rope/cable. Leaving more than two consecutive bulbs unsupported may lead to sagging over time.
- Do not nail through the lights wire.
   Instead, hang the lights using the eyehole above each bulb.
- Avoid placing the light string over sharp edges as this could damage the wire.
- Ensure control box is installed vertically.


**TIP!** Use your phone's Wi-Fi to determine if you will have enough signal where you plan on installing your lights.

- 1. Remove protective film from each bulb.
- 2. Thread the rope through the eyeholes above each bulb.
- 3. Affix both ends of the rope to a pole, post, or wall.
- 4. Connect the control box to the string light and tighten the screw connector.
- 5. Mount the control box **vertically** using included screws. When mounting to a rounded surface, use cable ties to hold in place.


