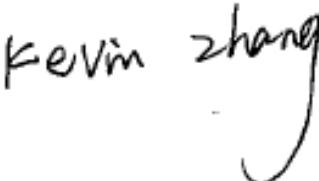

4 RF Exposure Evaluation

Friis transmission formula: $P_d = (P_{out} * G) / (4 * \pi * R^2)$

Where

P_d = power density in mW/cm²

P_{out} = output power to antenna in mW

G = gain of antenna in linear scale

π = 3.1416

R = distance between observation point and center of the radiator in cm

P_d is the limit of MPE, 1 mW/cm². If we know the maximum gain of the antenna and the total power input to the antenna, through the calculation, we will know the distance r where the MPE limit is reached.

2. According to the declaration from the applicant, the electrical circuit design, layout, components used and internal wiring were identical for all models, with only difference on the button and LED indicator.

The model CSWONBLPWF1 has one button and two white LED. The model CSWONBLTWF1 has two buttons and one white LED. Model CSWONBLPWF1 and CSWONBLTWF1 have the same Wi-Fi and Bluetooth modules.

Therefore only one model CSWONBLTWF1 was tested in this report.
