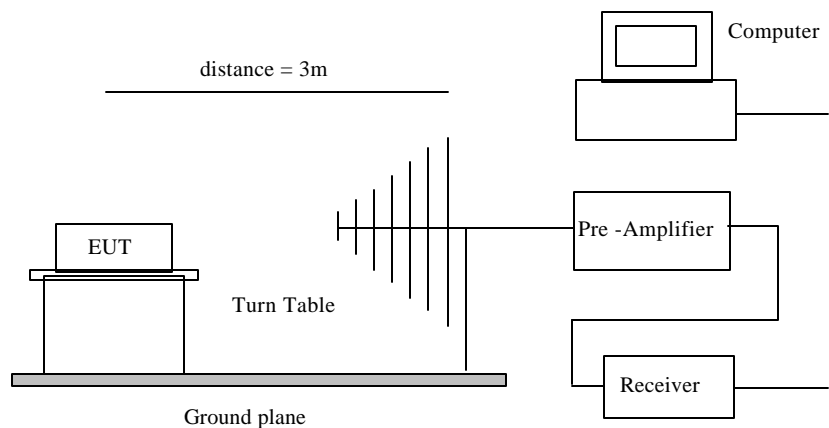

The sample was placed 0.8m above the ground plane on the OATS *. Measurements in both horizontal and vertical polarities were performed. During the test, each emission was maximized by: having the EUT continuously working, investigate all operating modes, rotated about all 3 axis (X, Y & Z) to obtain worst position, manipulating interconnecting cables, rotating turntable, varying antenna height from 1m to 4m in both horizontal and vertical polarizations. The emissions worst-case are shown in Test Results of the following pages.

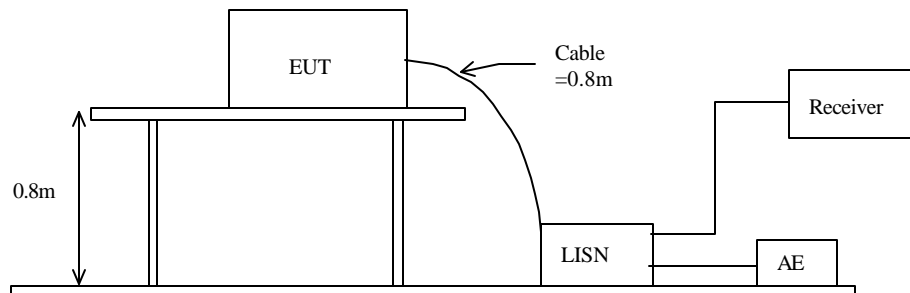

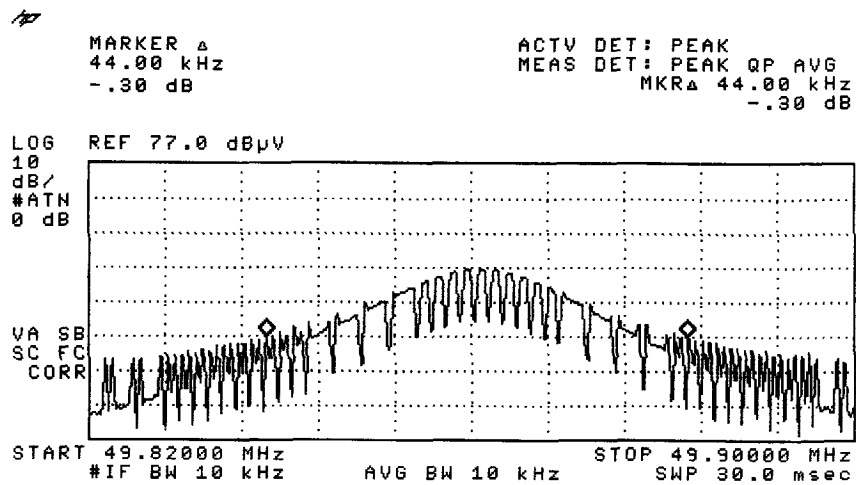

Appendix B**Duty Cycle Correction During 100msec**

Each function key sends a different series of characters, but each packet period (9.9msec) never exceeds a series of 4 long (800µsec) and 10 short (250µsec) pulses. Assuming any combination of short and long pulses may be obtained due to encoding the worse case transmit duty cycle would be considered $4 \times 800\mu\text{sec} + 10 \times 250\mu\text{sec}$ per $28\mu\text{sec} = 58\%$ duty cycle. Figure A through C show the characteristics of the pulses train for one of these function.

Remarks:

Duty Cycle Correction = $20\text{Log}(0.58) = -4.7\text{dB}$

Figure A [Pulse Train]

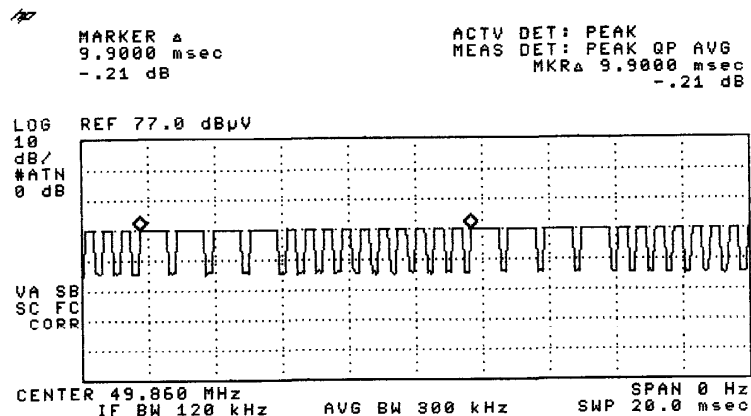


Figure B [Long Pulse]

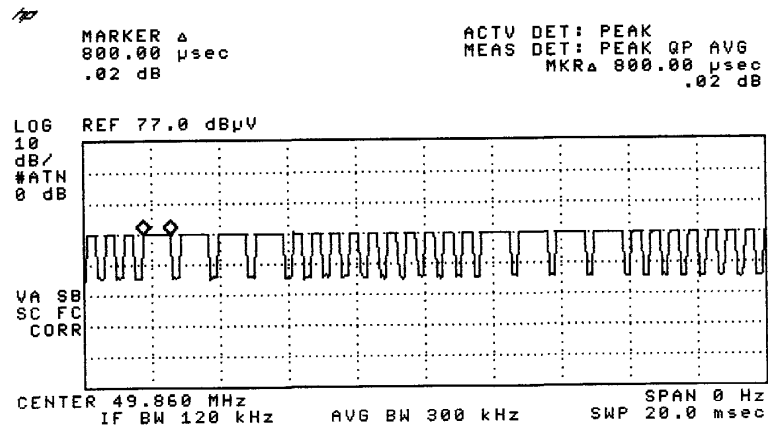
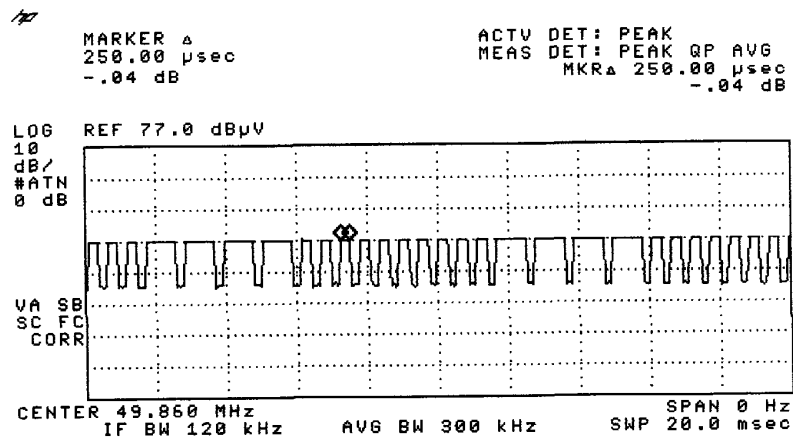


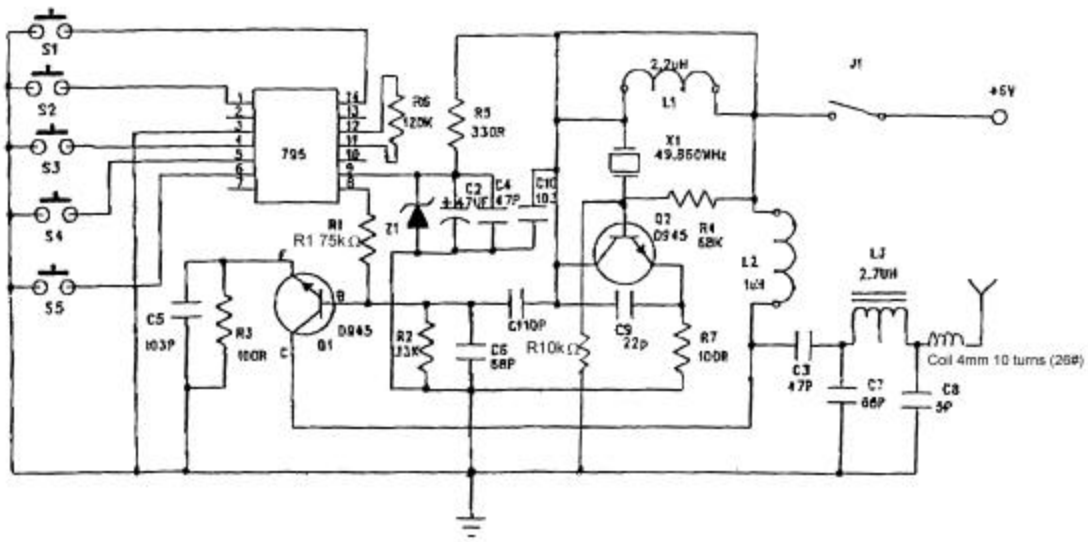
Figure C [Short Pulse]

Appendix C**Modification Method**

1. The resistance of R1 should be changed from 5.6k Ω .
2. Added R 10k Ω between the b pole of the Q2 and ground.
3. Added a coil \varnothing 4mm 10 Turns with 26# copper wire between antenna and C8.
