


# Frequency Response of E-Field






Uncertainty of Frequency Response of E-field: ± 6.3% (k=2)

# Receiving Pattern ( $\phi$ ), $\theta$ = 0°









Uncertainty of Axial Isotropy Assessment: ± 0.5% (k=2)

# Dynamic Range f(SAR<sub>head</sub>)








Uncertainty of Linearity Assessment: ± 0.6% (k=2)






# Frequency Response of E-Field






Uncertainty of Frequency Response of E-field: ± 6.3% (k=2)

# Receiving Pattern ( $\phi$ ), $9 = 0^{\circ}$









Uncertainty of Axial Isotropy Assessment: ± 0.5% (k=2)

# Dynamic Range f(SAR<sub>head</sub>)








Uncertainty of Linearity Assessment: ± 0.6% (k=2)




# **Deviation from Isotropy in HSL**


Error (¢, 3), f = 900 MHz






