DL_Cellular Band_1.25MHz AWGN input_Upper band edge_10dB above AGC

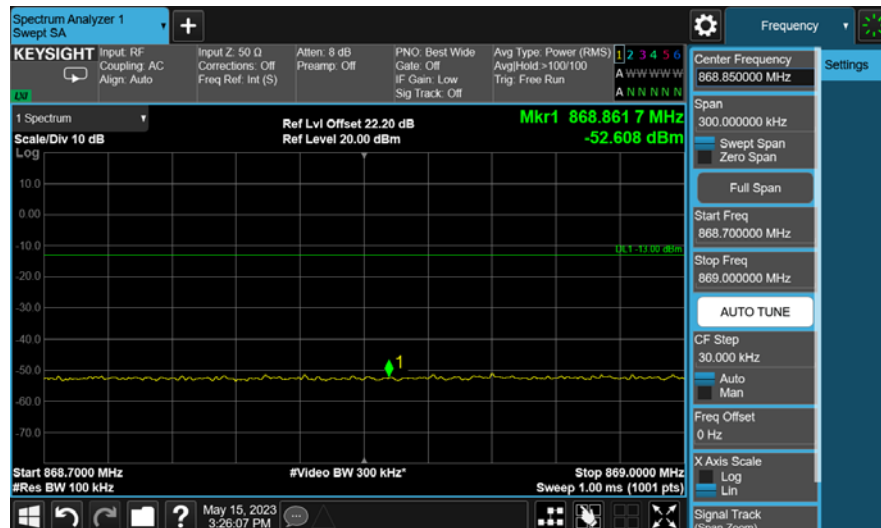

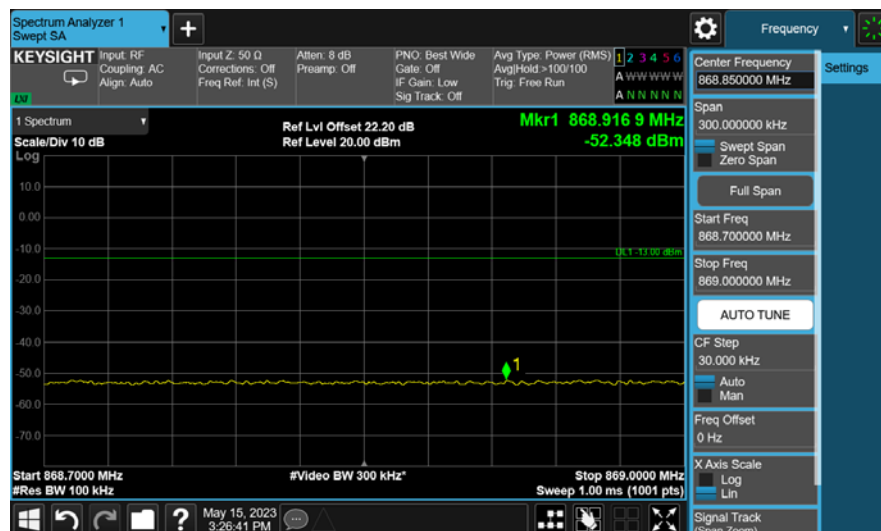

DL_Cellular Band_4.1MHz AWGN input_Lower band edge_10dB above AGC

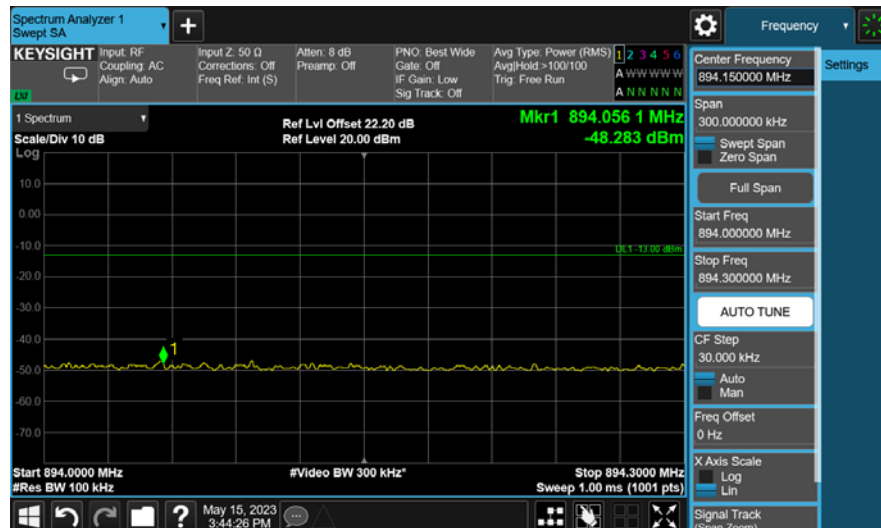

DL_Broadband PCS Band_4.1MHz AWGN input_Lower band edge_10dB above AGC

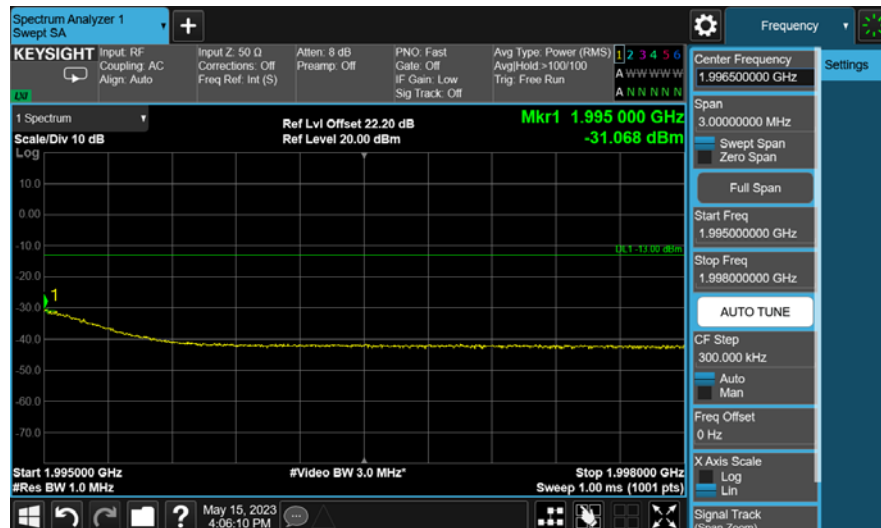
