DL_GSM input_Upper band edge_pre-AGC

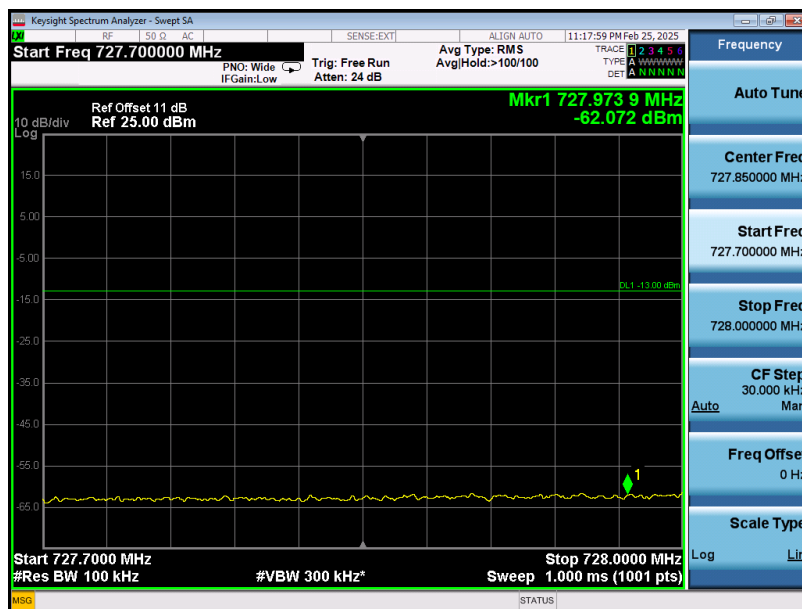


DL_GSM input_Upper band edge_10dB above AGC

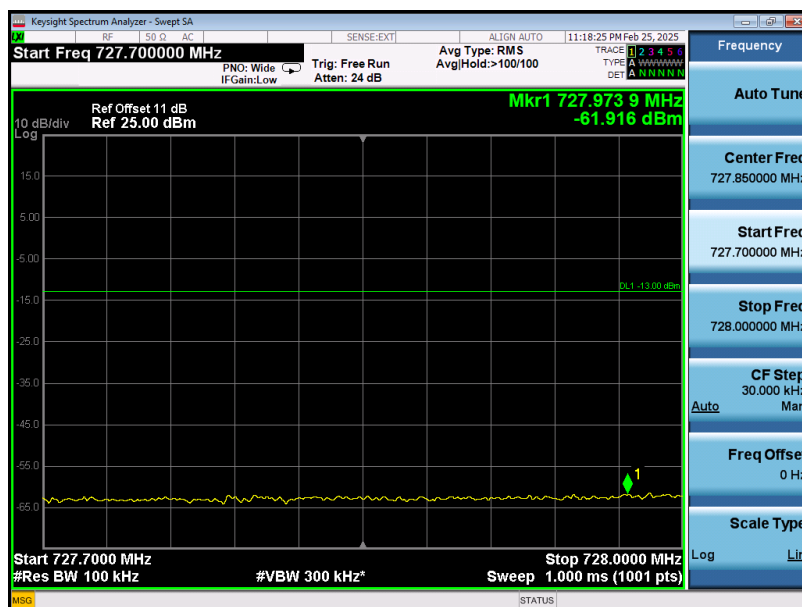

DL_1.25MHz AWGN input_Lower band edge_pre-AGC

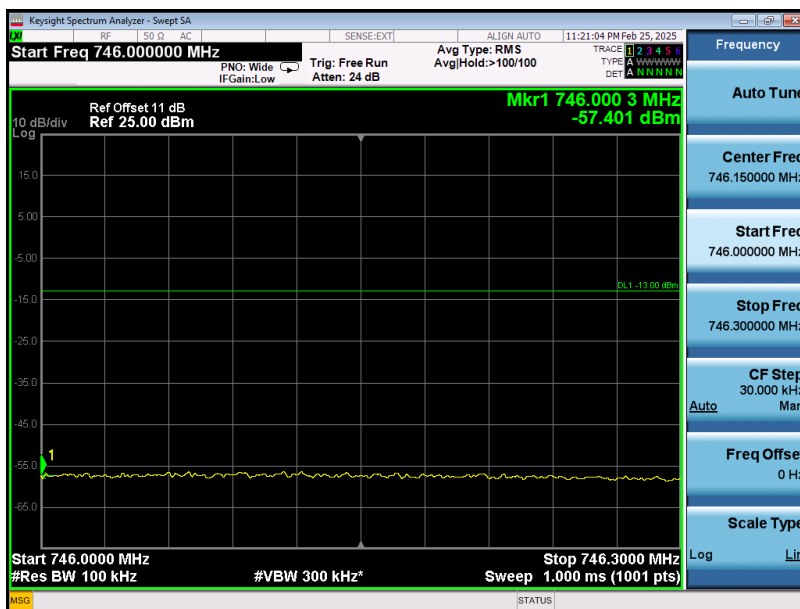


DL_1.25MHz AWGN input_Lower band edge_10dB above AGC

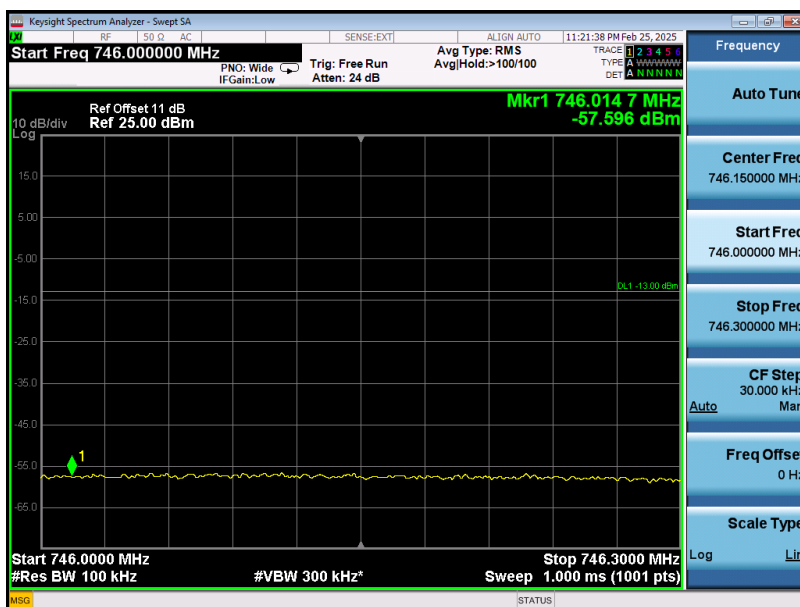

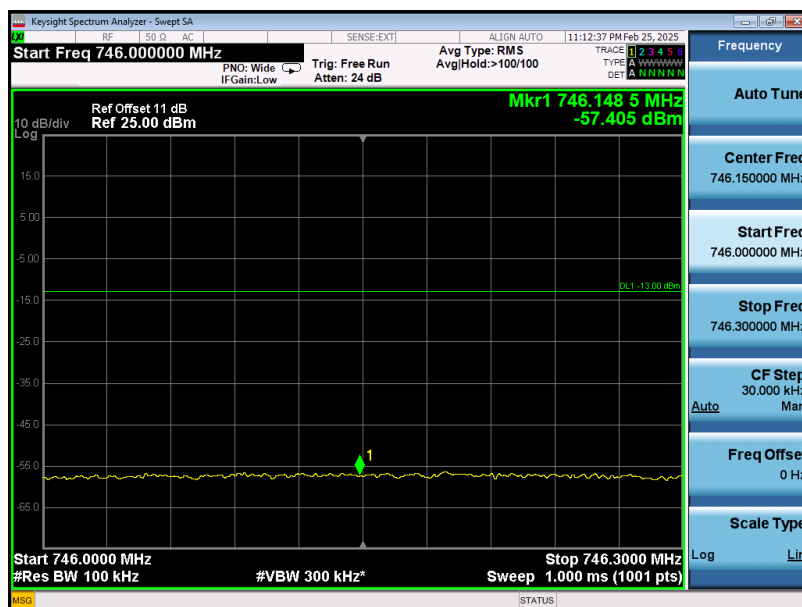

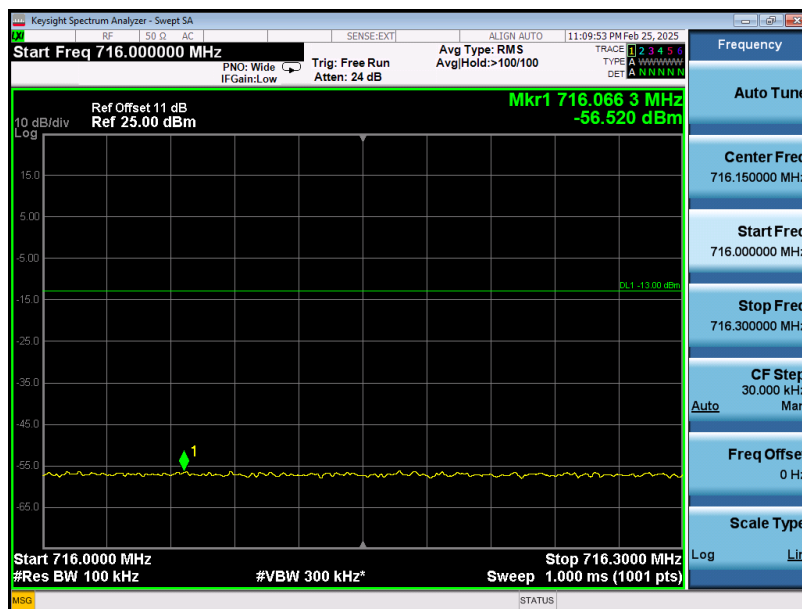


UL_4.1MHz AWGN input_Lower band edge_10dB above AGC

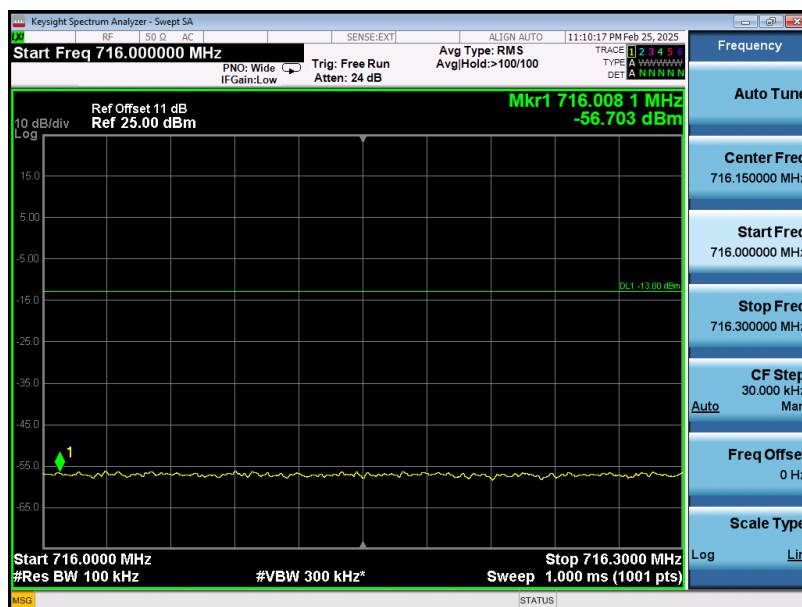

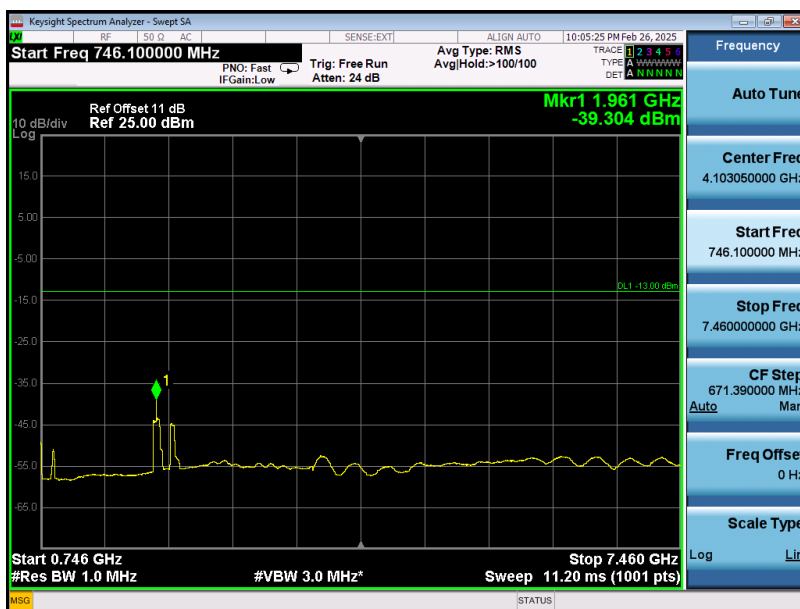
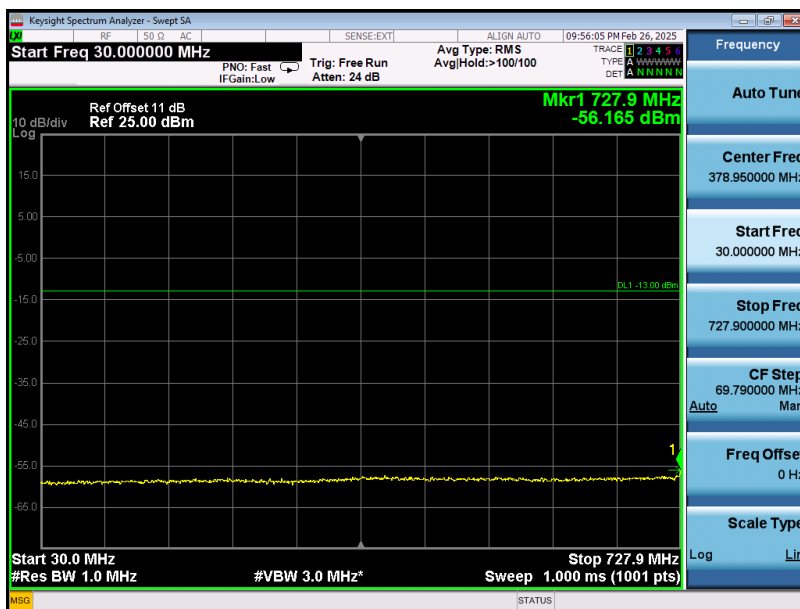
