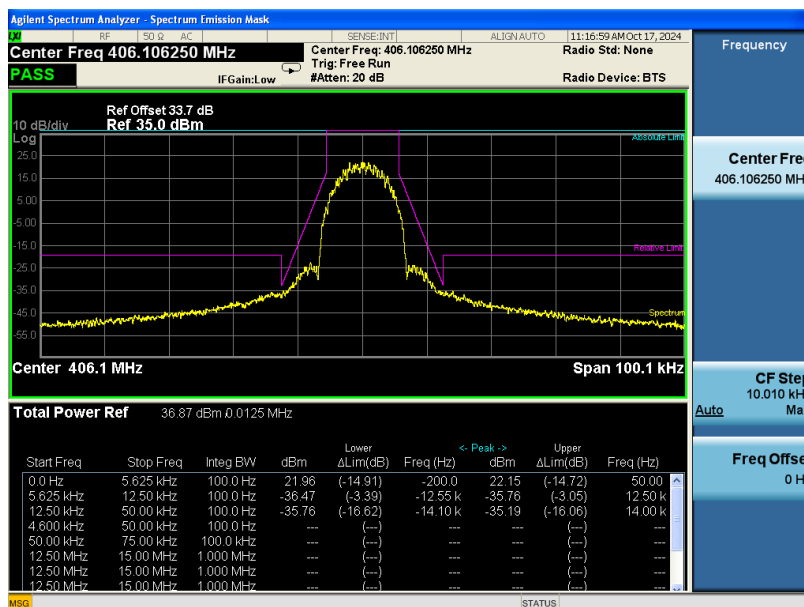


#### DL\_C4FM\_HCH\_3dB above AGC

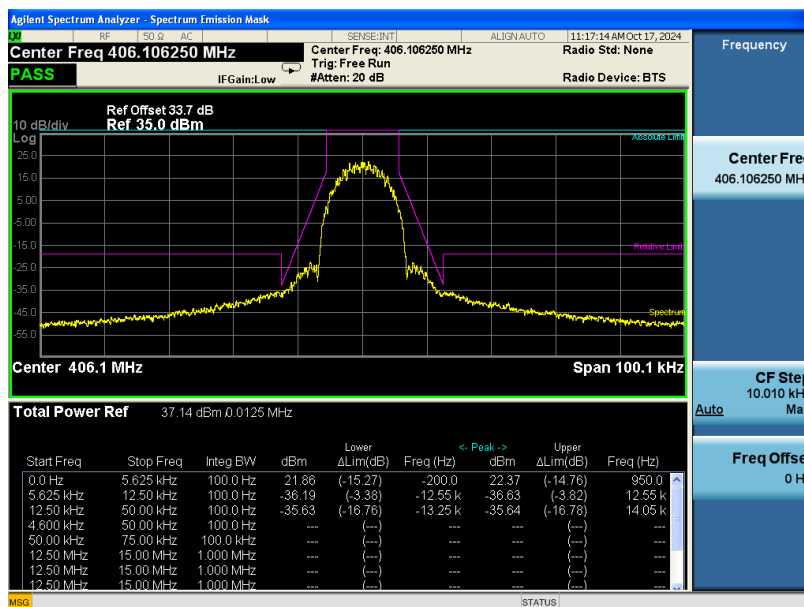

#### DL\_H-DQPSK\_HCH\_Pre-AGC

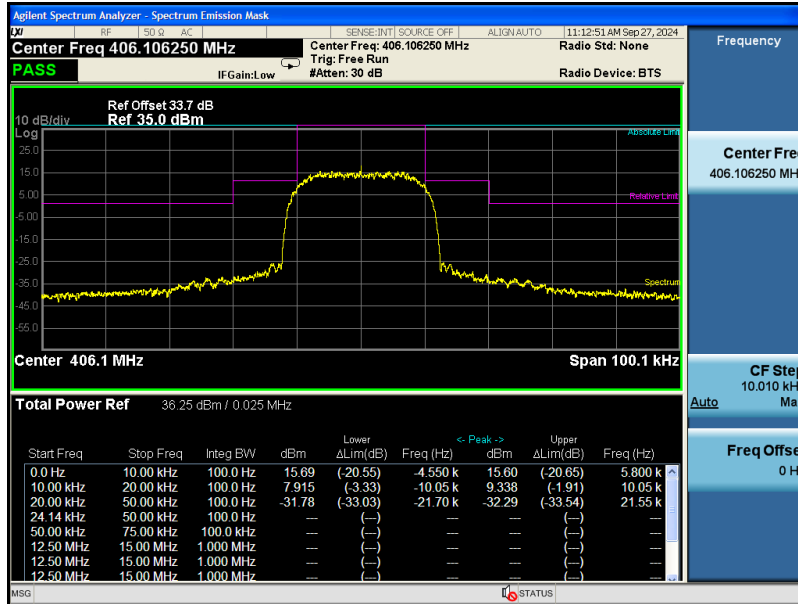

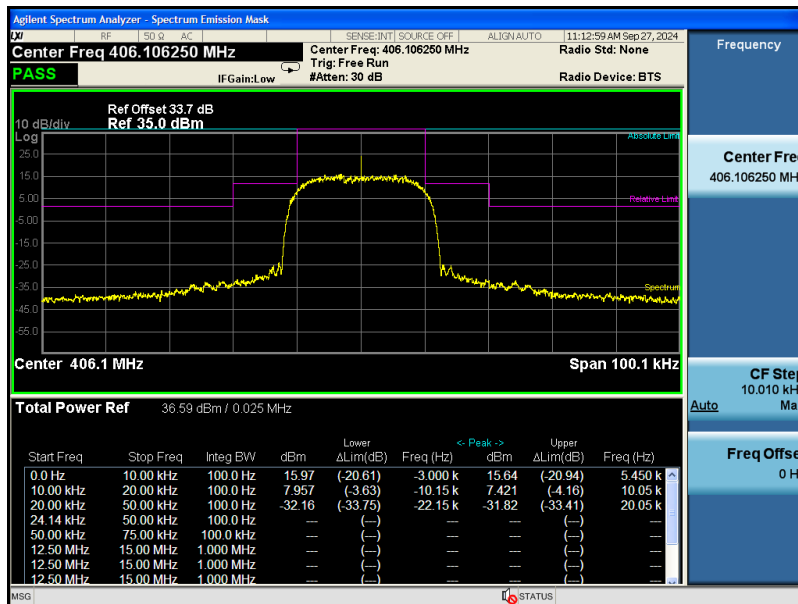

#### DL\_TETRA\_LCH\_Pre-AGC

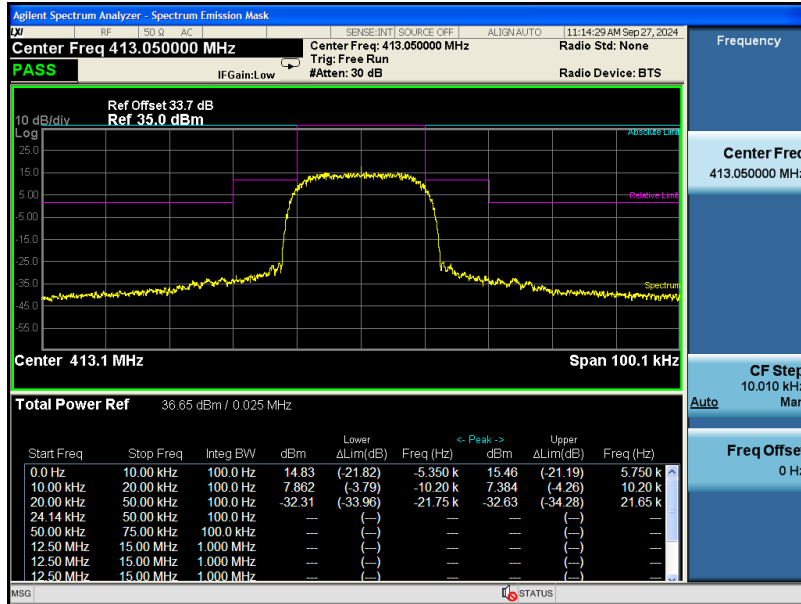

#### UL\_H-DQPSK\_LCH\_Pre-AGC

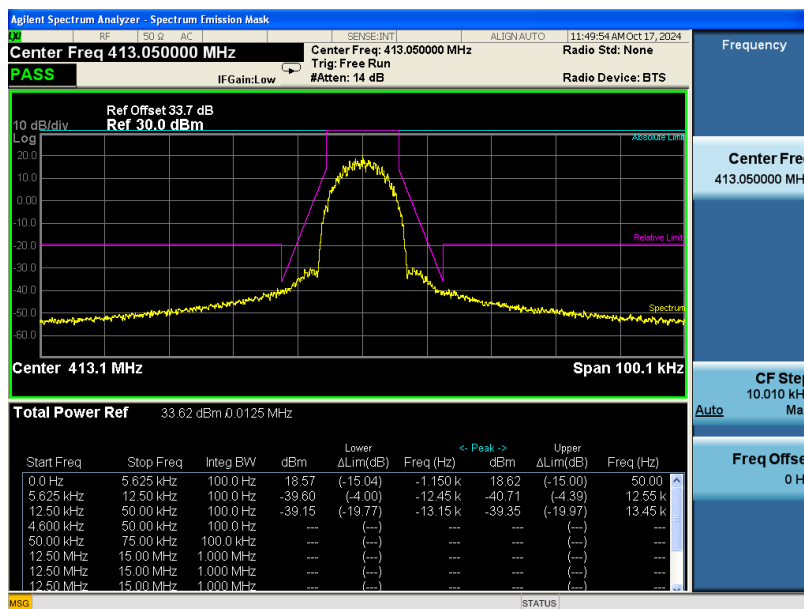

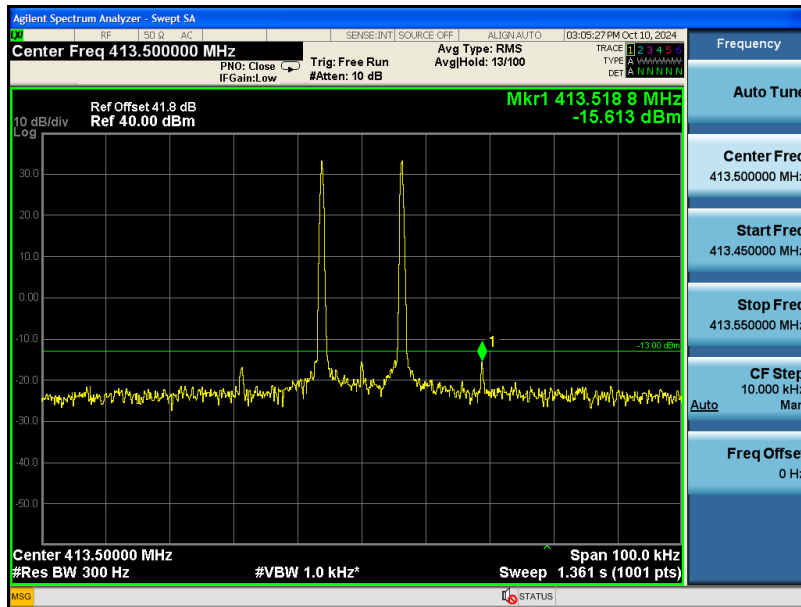


#### DL\_6.25kHz\_3dB above AGC

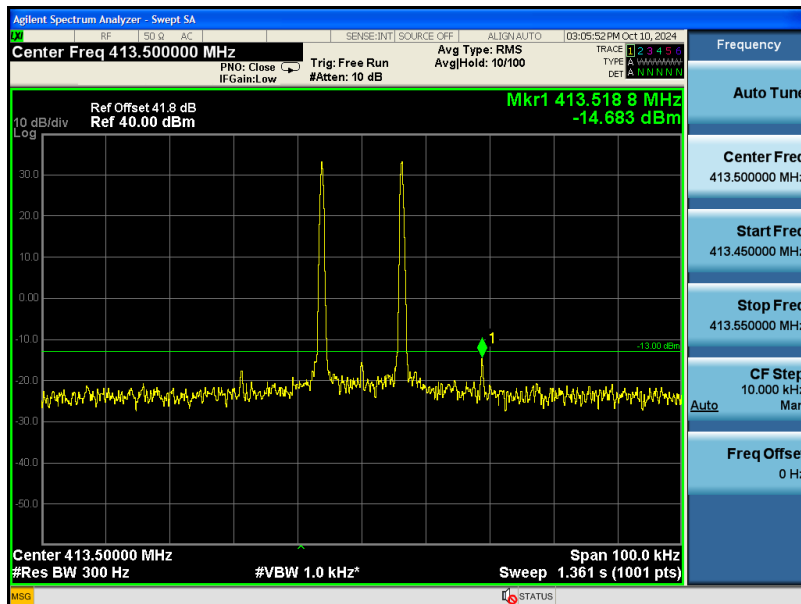
