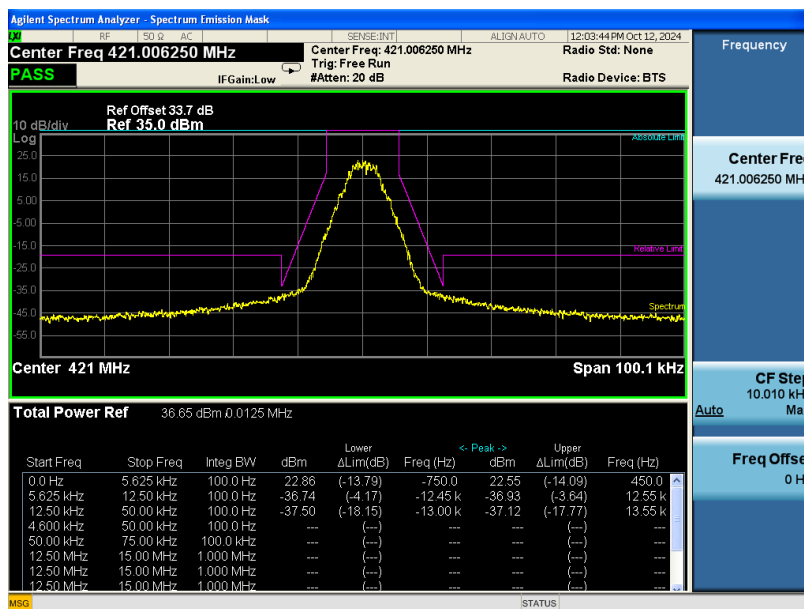
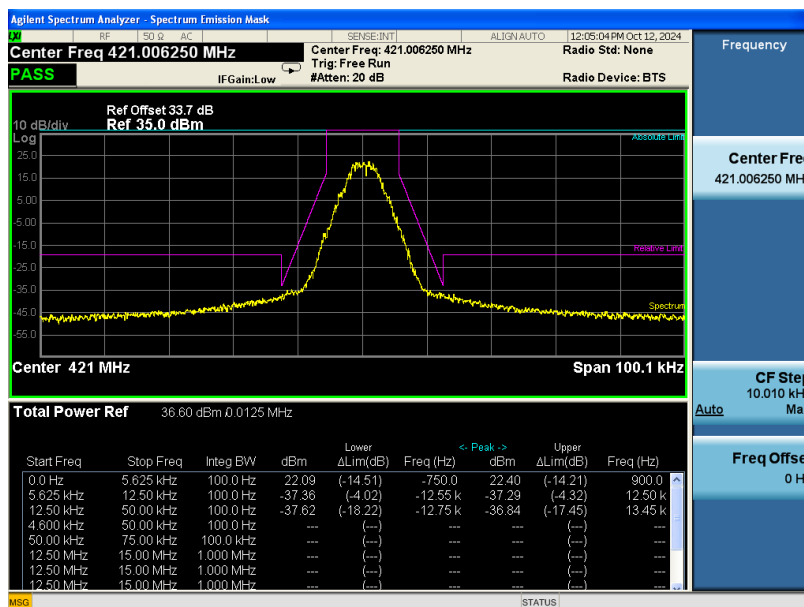

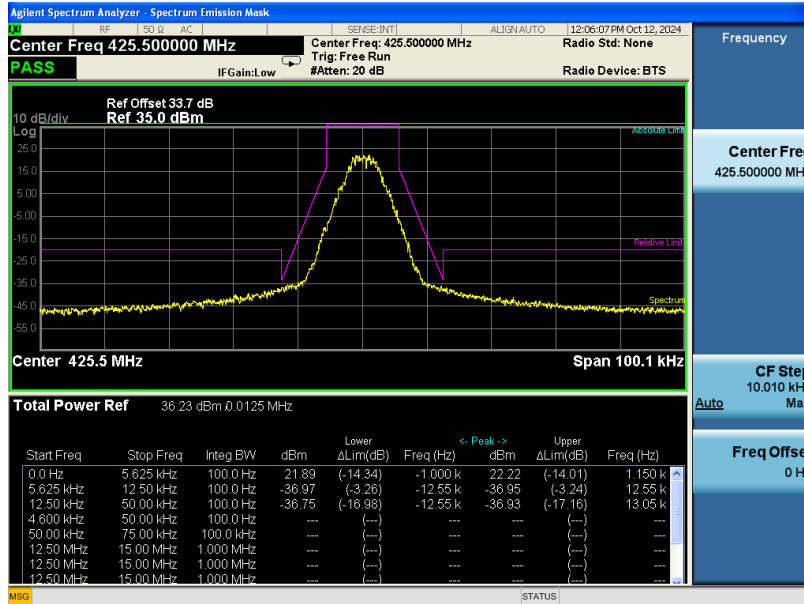


DL_DMR_LCH_3dB above AGC

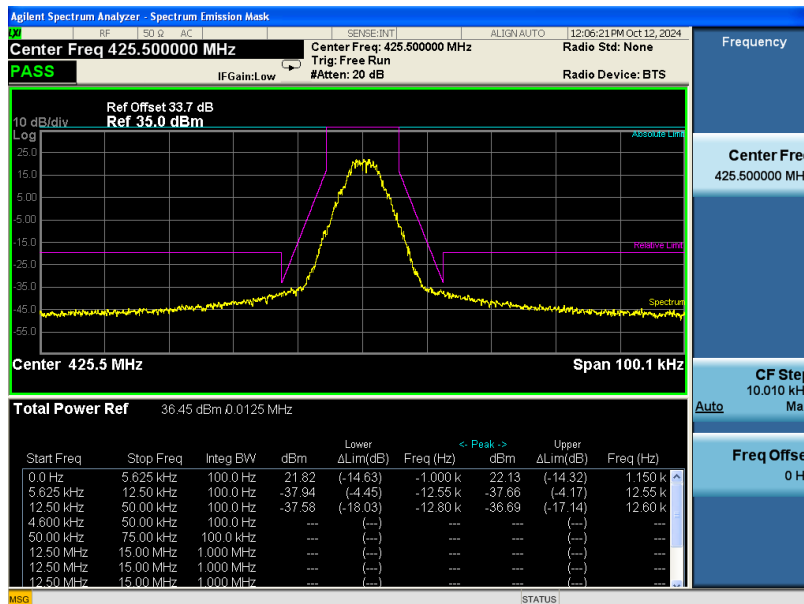

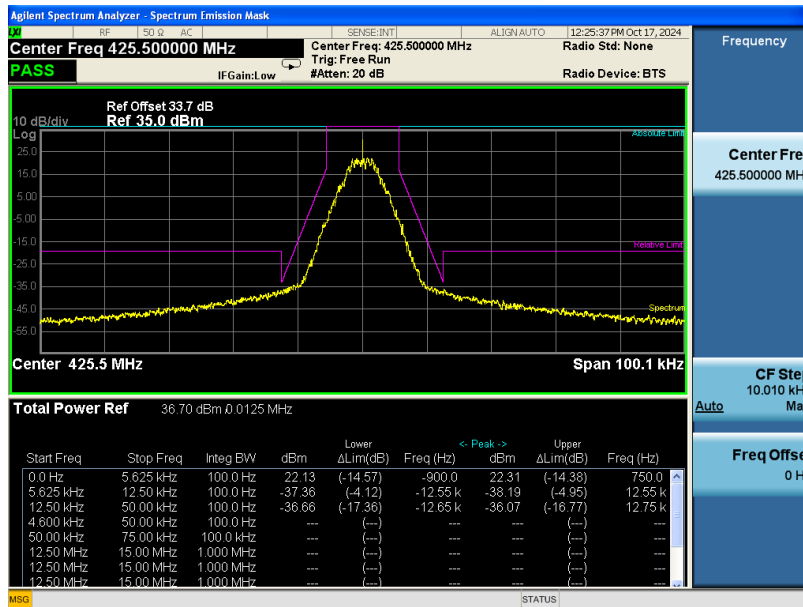


DL_C4FM_LCH_3dB above AGC

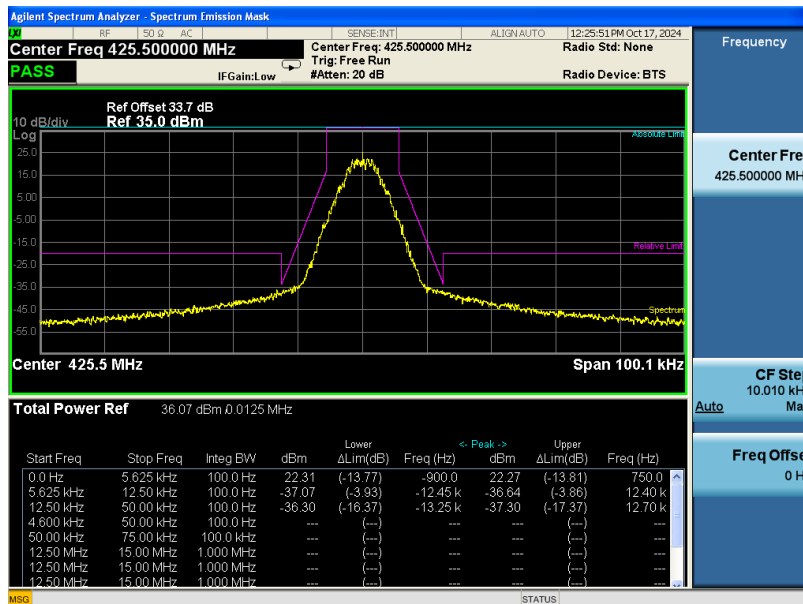

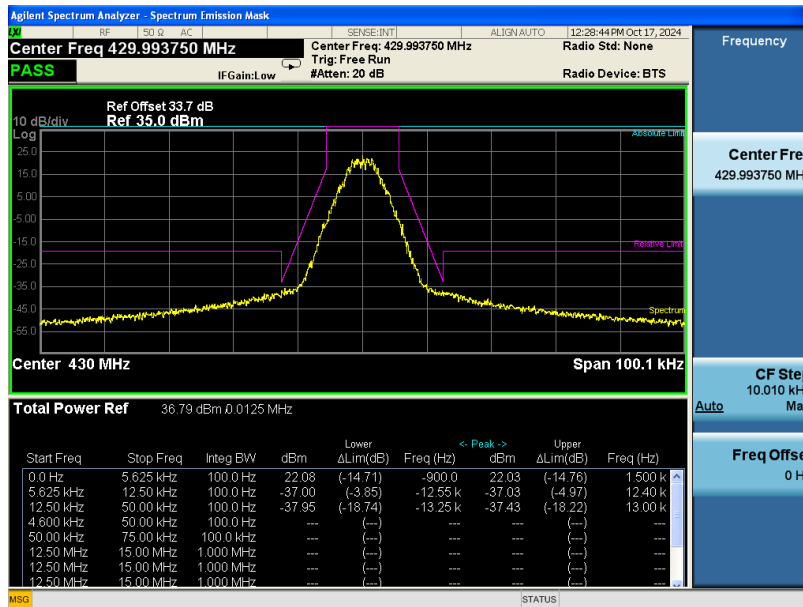


DL_C4FM_MCH_3dB above AGC

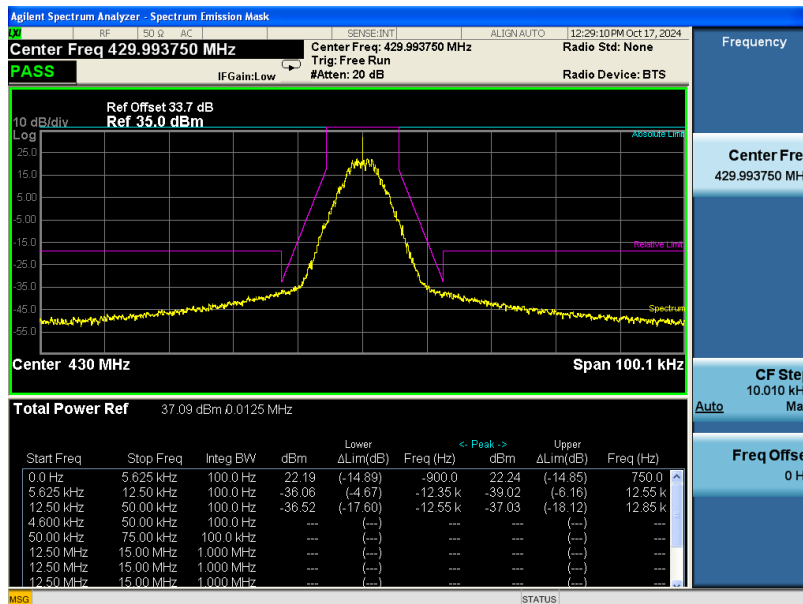

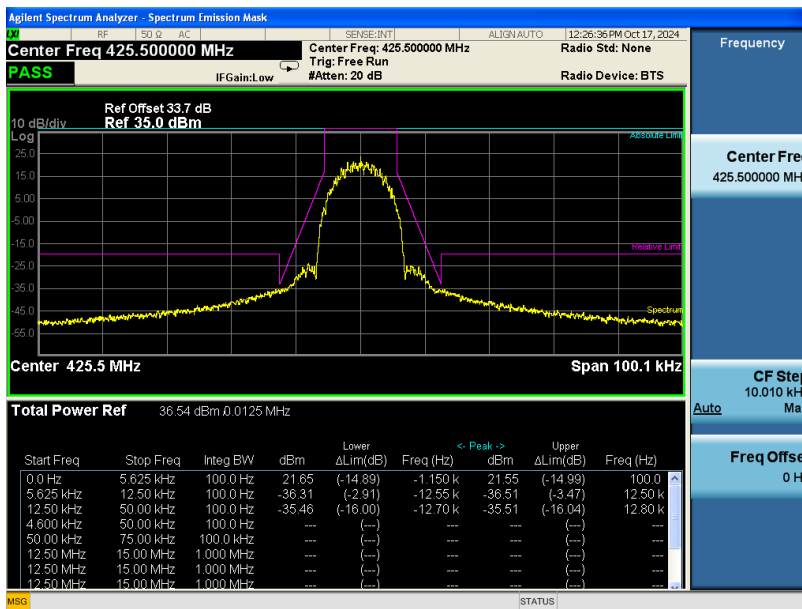


DL_H-DQPSK_LCH_3dB above AGC

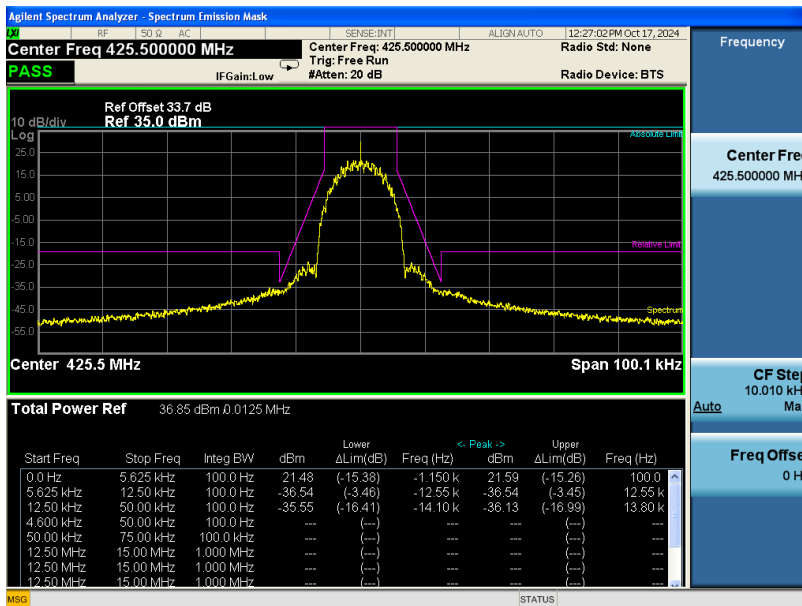

DL_H-DQPSK_MCH_Pre-AGC

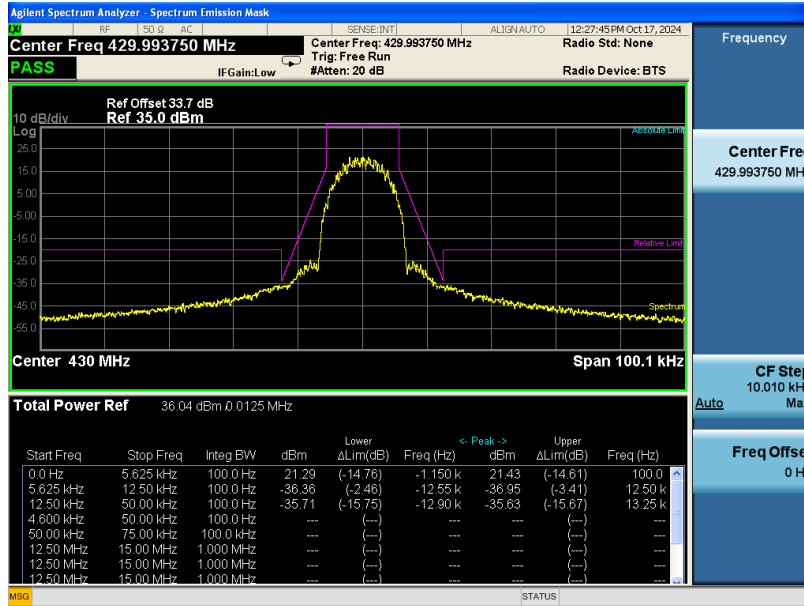


DL_H-DQPSK_MCH_3dB above AGC

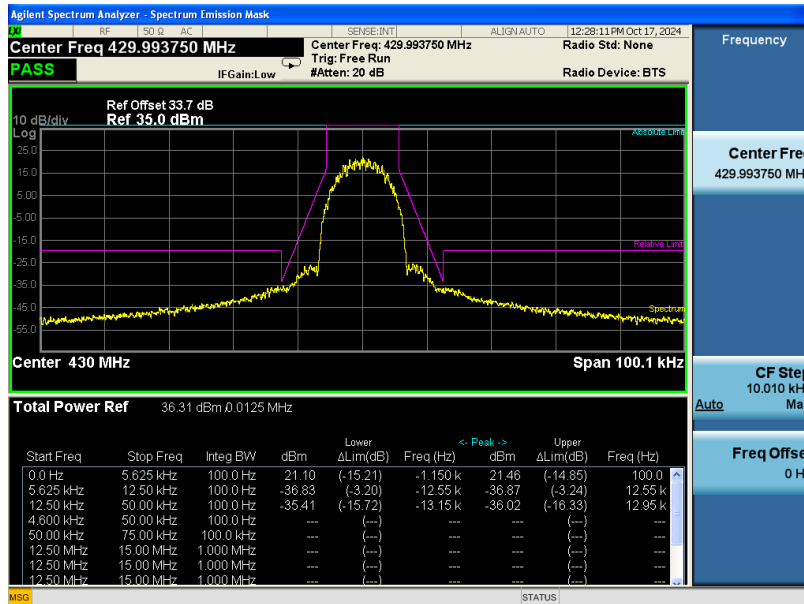

DL_H-DQPSK_HCH_Pre-AGC

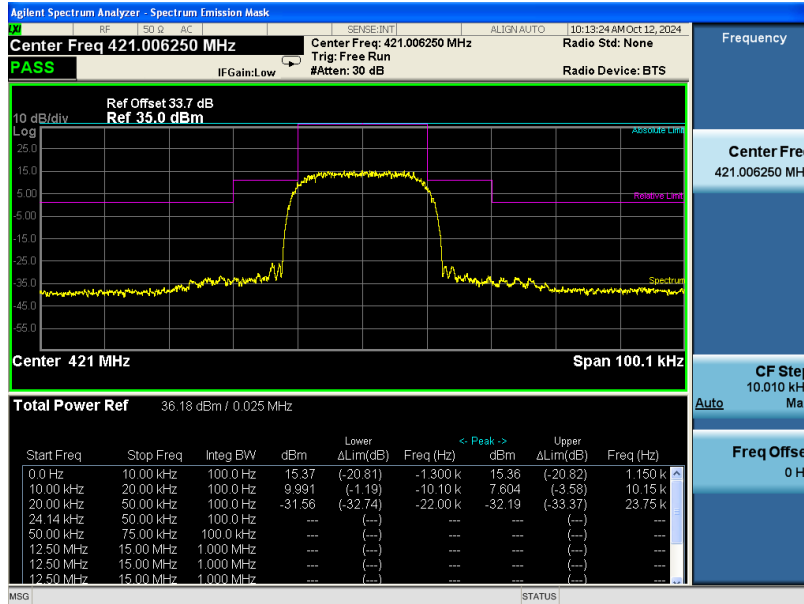


DL_H-DQPSK_HCH_3dB above AGC

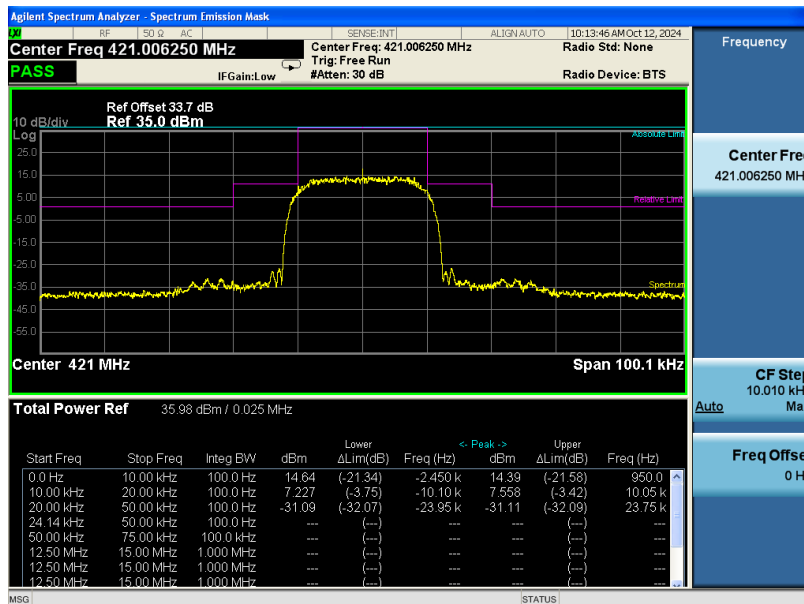

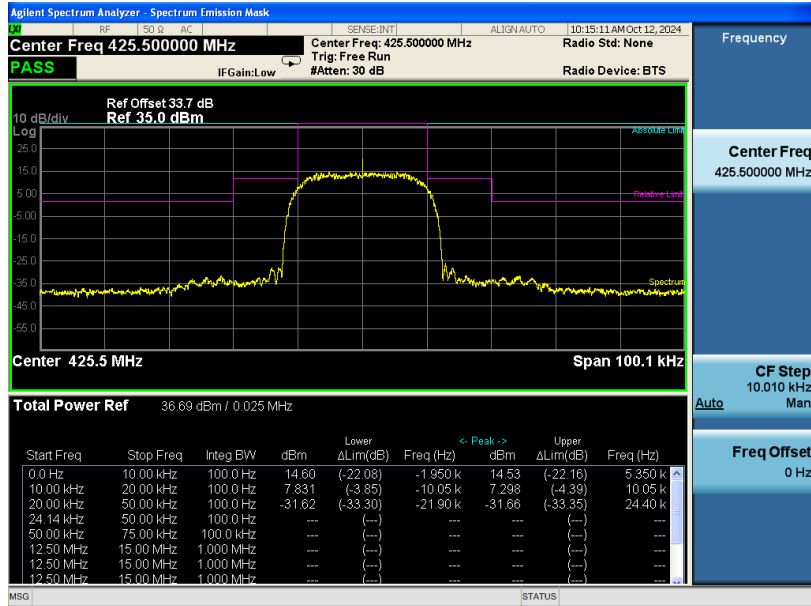


DL_TETRA_LCH_3dB above AGC

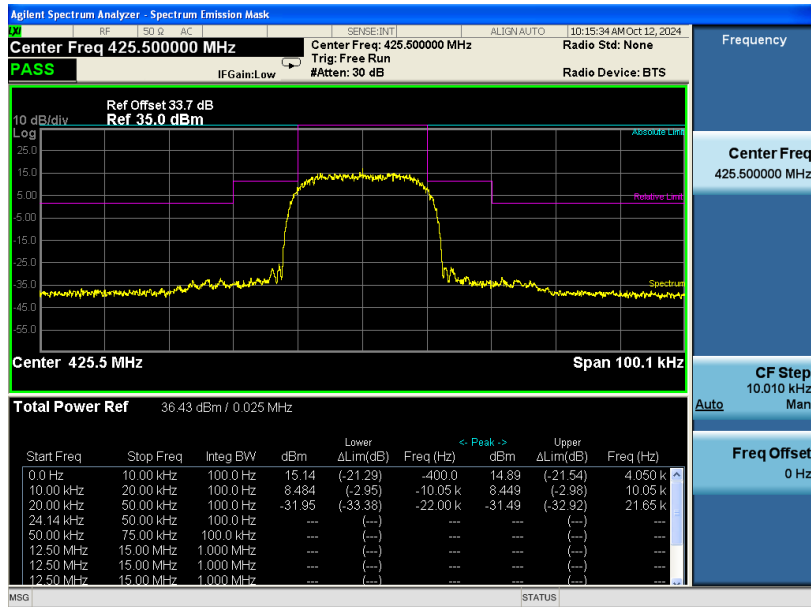

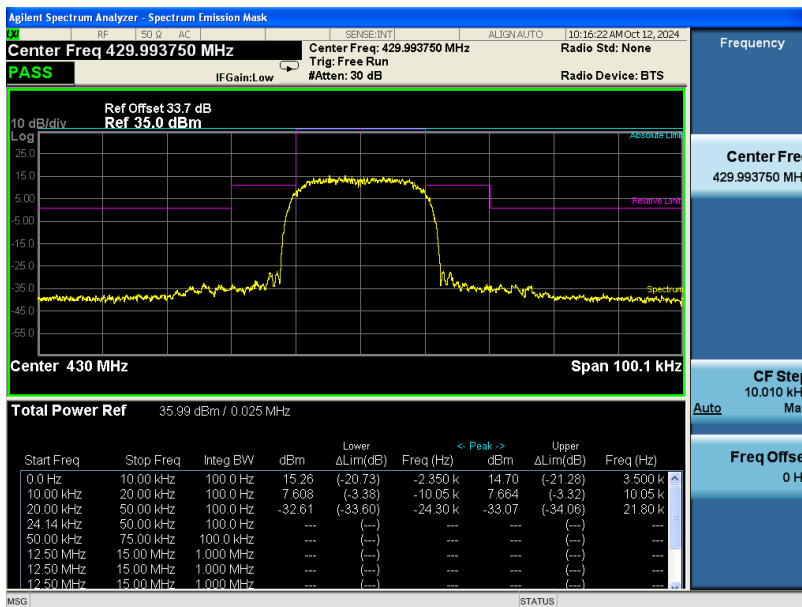


DL_TETRA_MCH_3dB above AGC

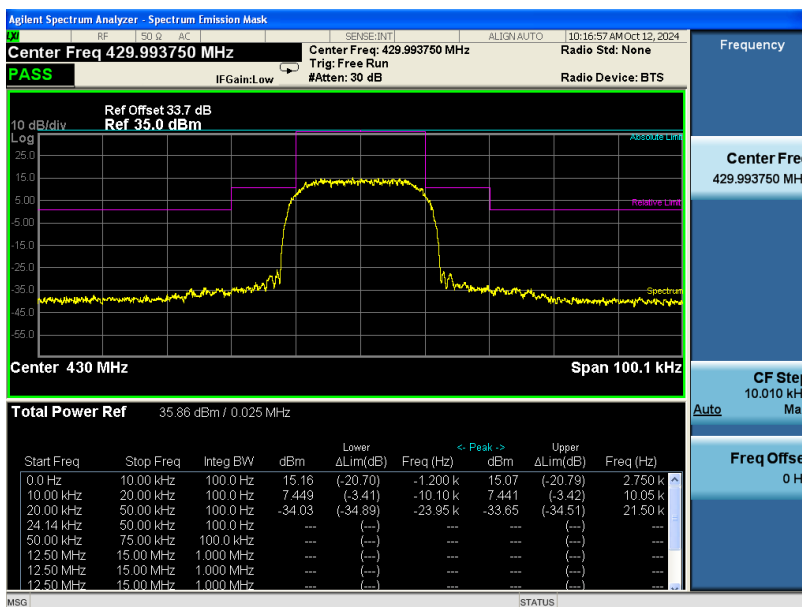

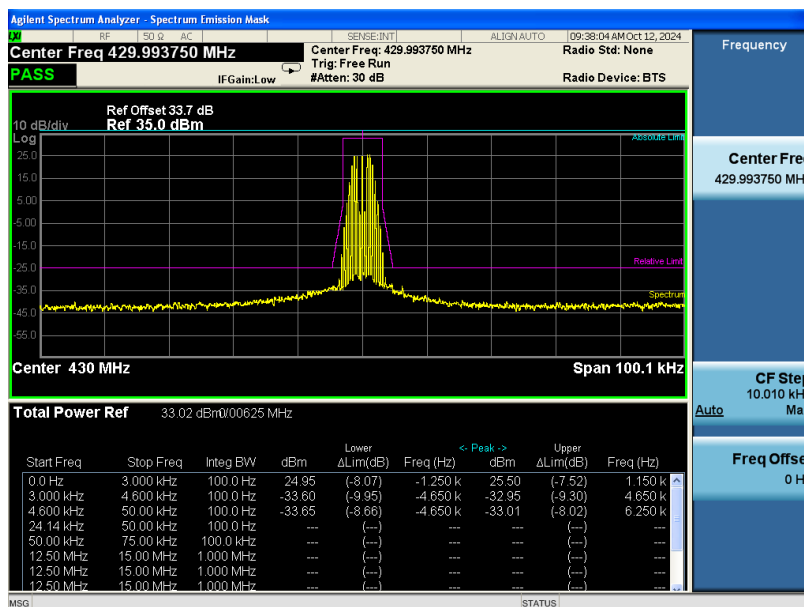


UL_FM_LCH_3dB above AGC

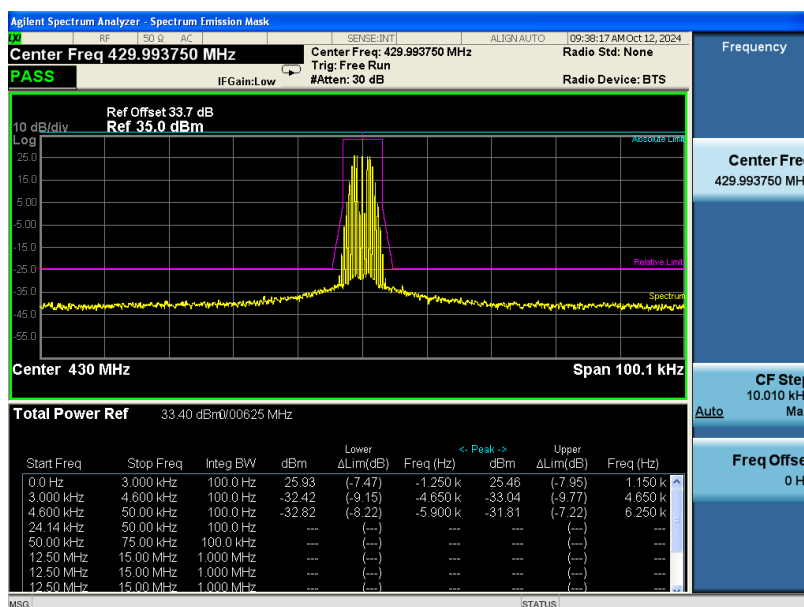

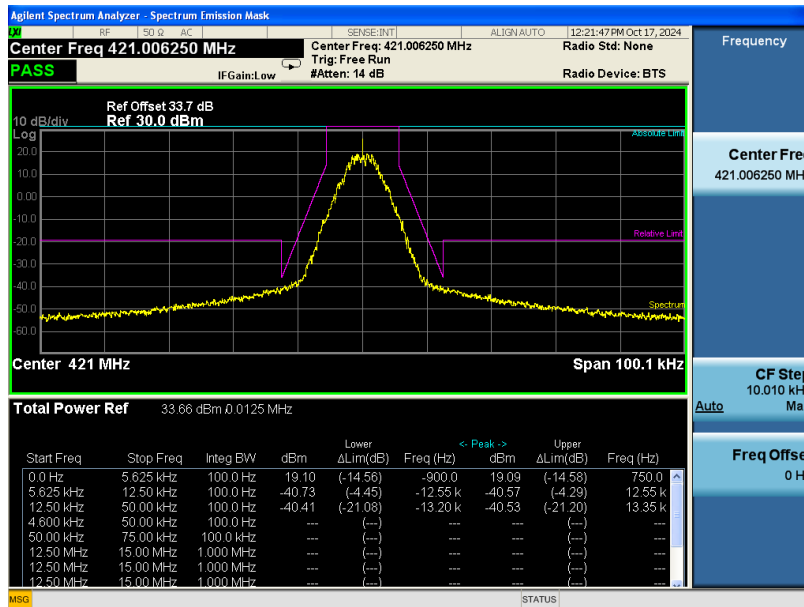


UL_DMR_HCH_3dB above AGC

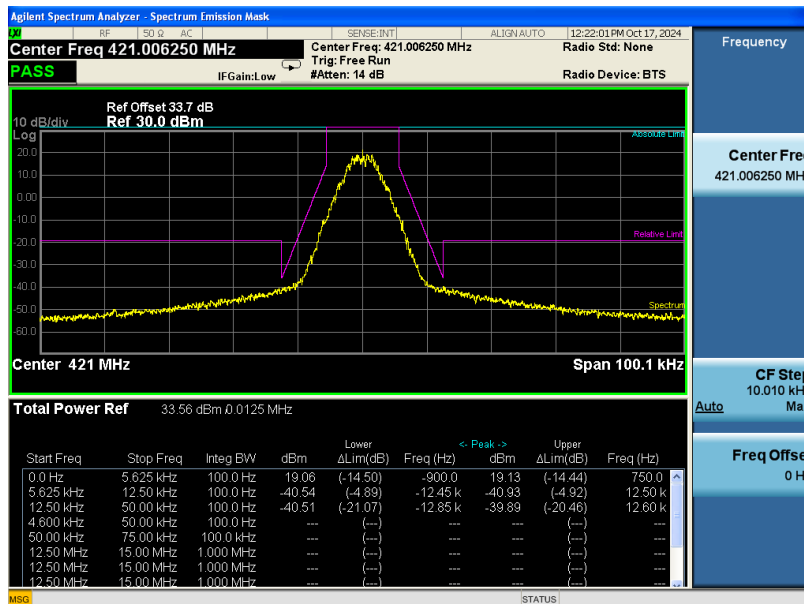

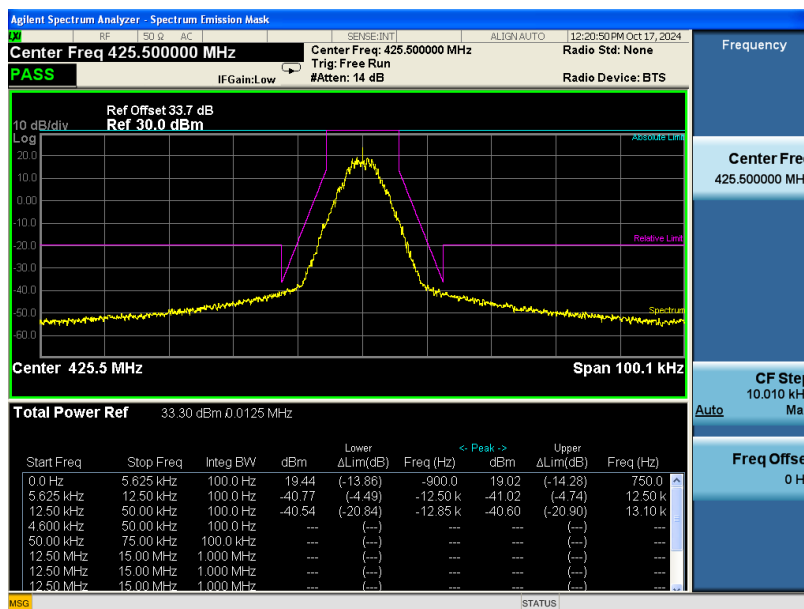


UL_C4FM_LCH_3dB above AGC

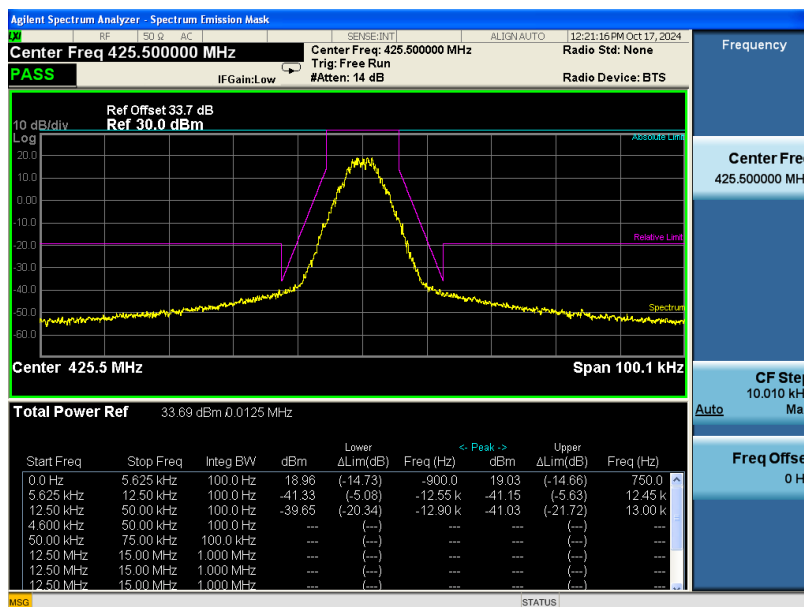

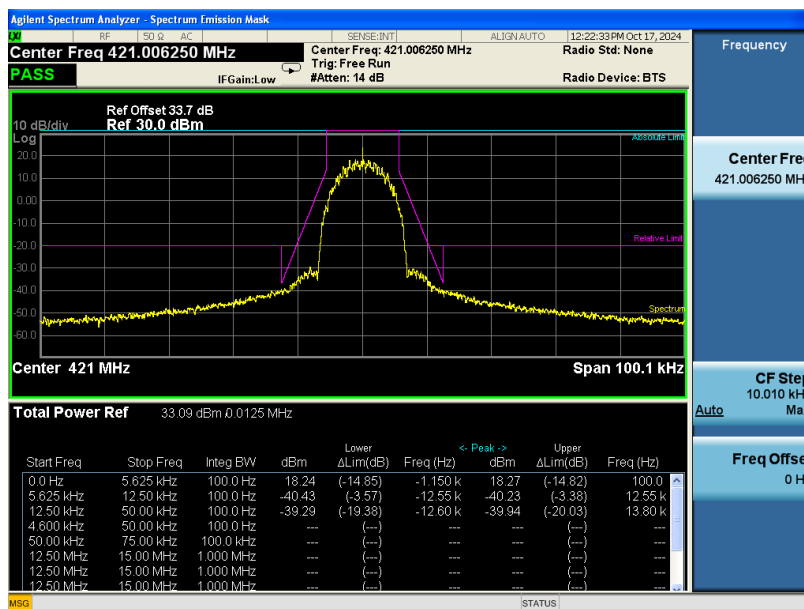


UL_C4FM_HCH_3dB above AGC

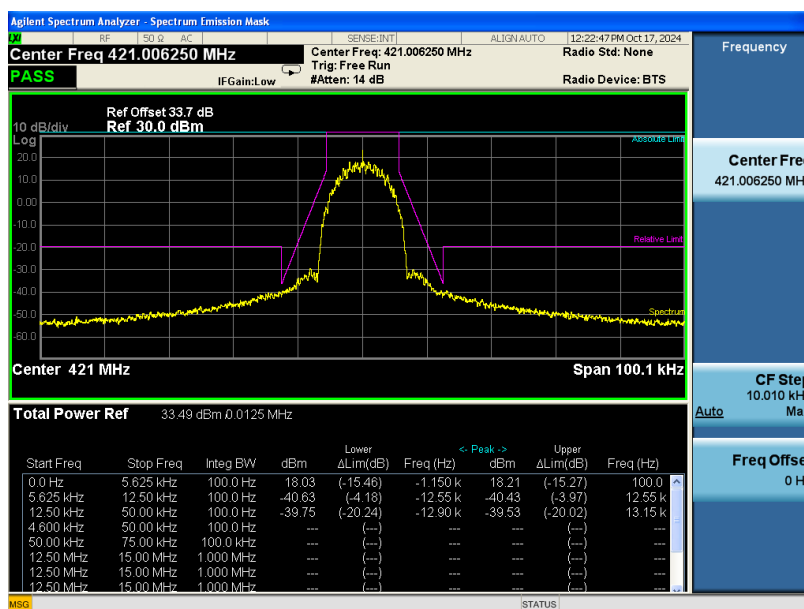

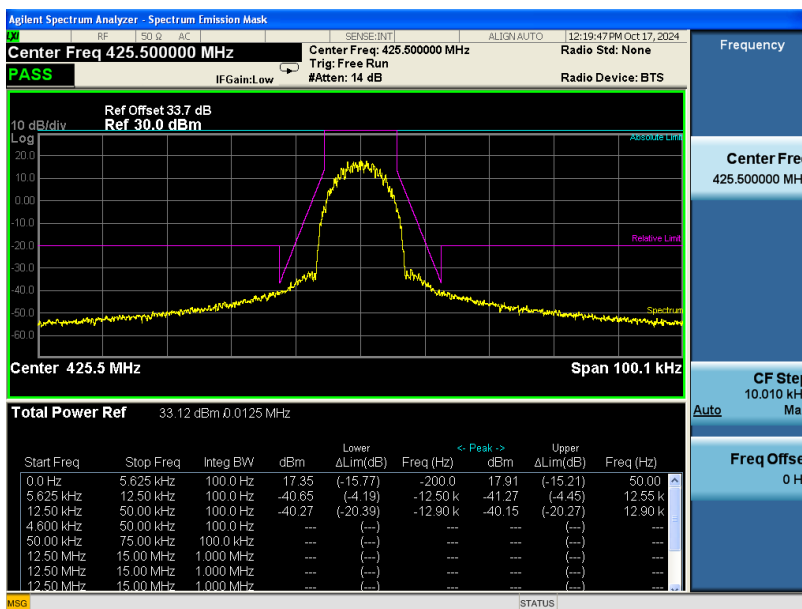


UL_H-DQPSK_LCH_3dB above AGC

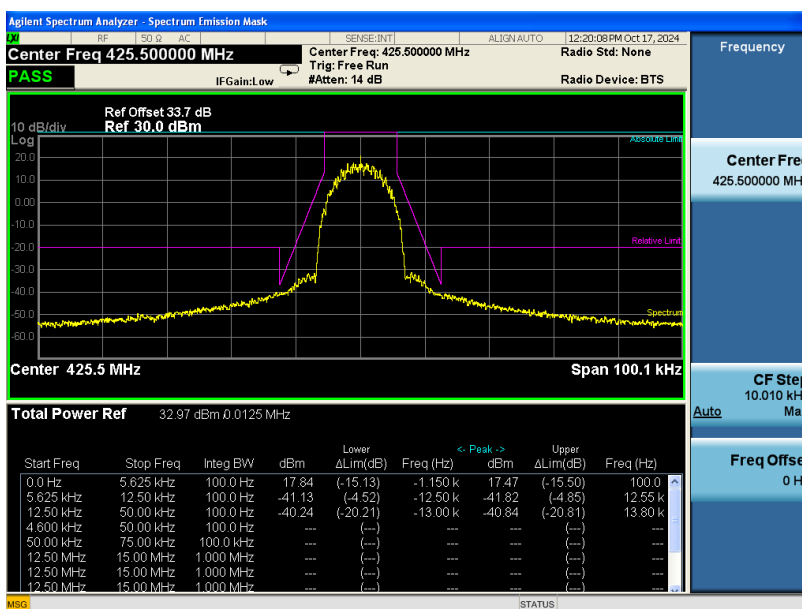

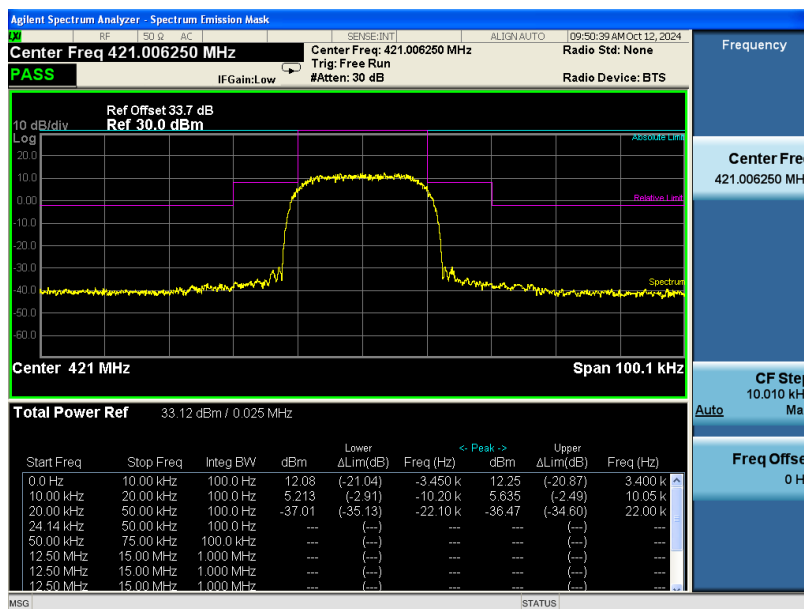


UL_H-DQPSK_HCH_3dB above AGC

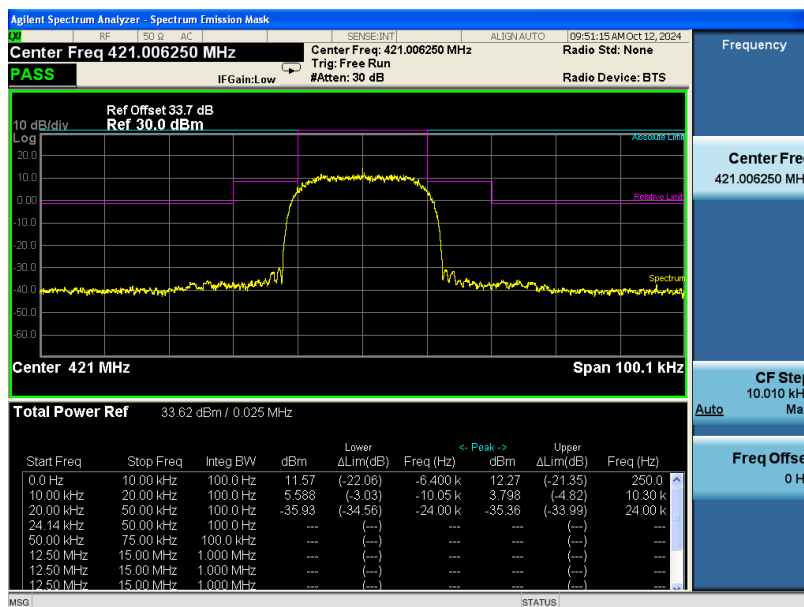

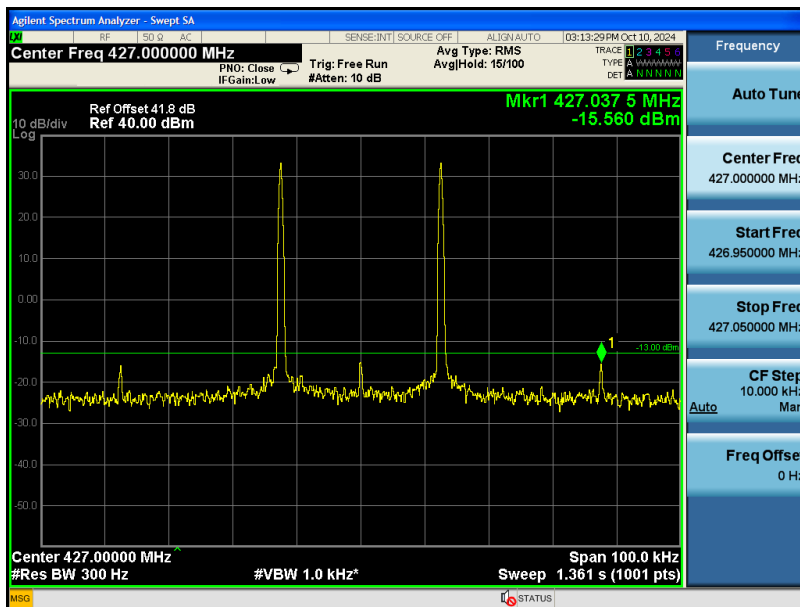


DL_12.5kHz_3dB above AGC

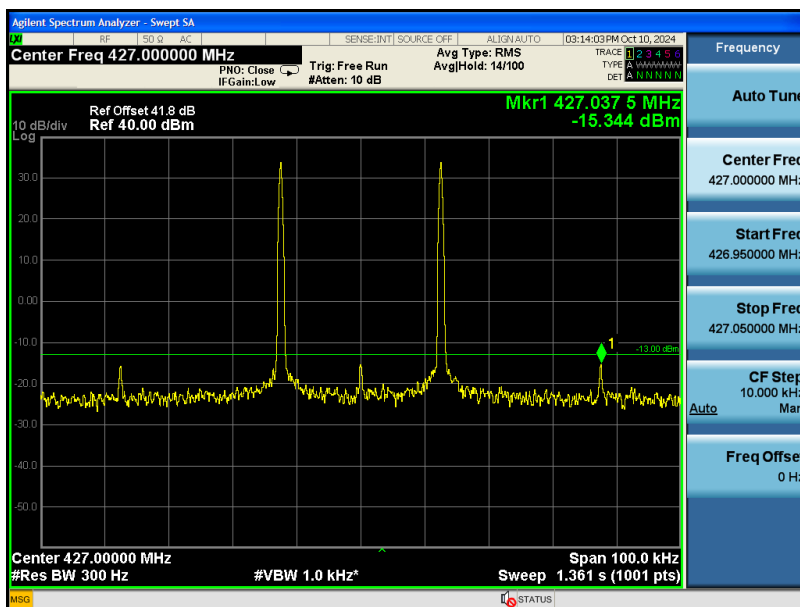

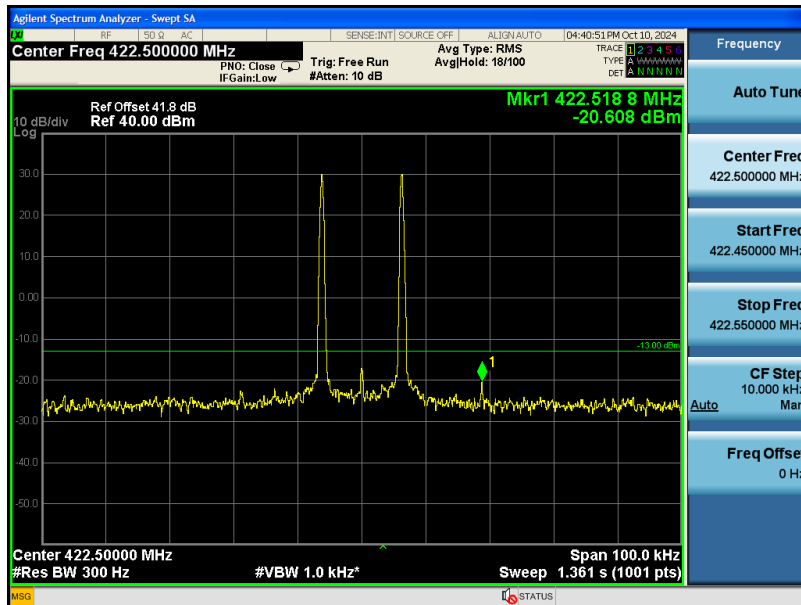


UL_6.25kHz_3dB above AGC

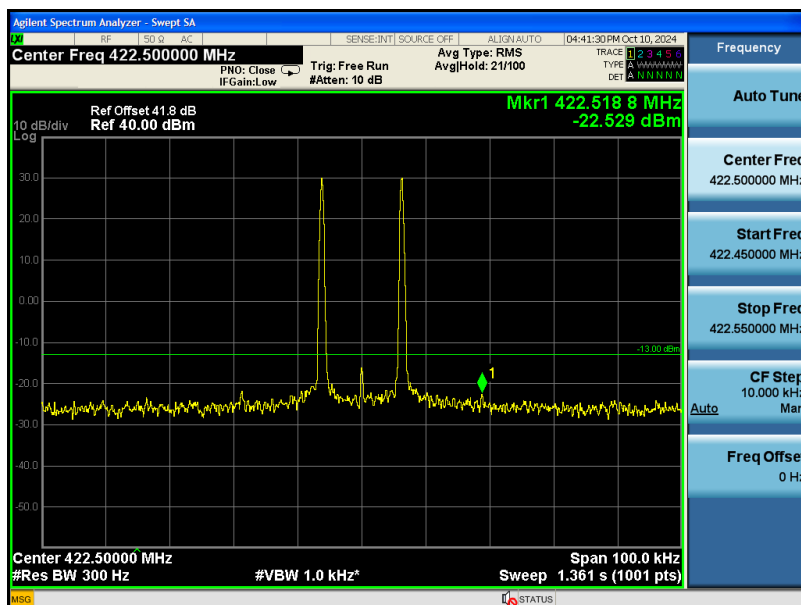
