

## Waterproof Wall Button

When used in conjunction with MobileHelp's Cellular Base Station and/or Mobile Device, the waterproof Wall Button allows you to obtain emergency help with the press of a button. The Wall Button can be mounted on a flat surface such as a wall or placed on a table top. Mounting hardware and two-sided tape is included. The Wall Button has an LED Light that will communicate the following:

| Light Indicator | What it Means                                                            |
|-----------------|--------------------------------------------------------------------------|
| ● <b>RED</b>    | When you press your emergency Wall Button, the LED light will flash red. |
| ☀ <b>AMBER</b>  | When the battery level is low, the LED light will blink amber.           |
