The horizontal ground plane projected 50 cm beyond the footprint of the EUT system and distanced 80 cm to the wooden test table. 


Figure 1: RF Test Setup

5.4 Band Edge

5.4.1 Definition

5.6 Conducted Emission

5.6.1 Definition



5.6.2 Test Description

The EUT is powered by the AC Adapter which is powered by 120V, 60Hz AC mains supply. The path loss as the factor is calibrated to correct the reading. During the measurement, the EUT is activated and is set to operate at maximum power.



5.6.3 Test Result

A scan was taken on both power lines, Line 1 and Line 2, recording at least the six highest emissions. Emission frequency and amplitude were recorded into a computer in which correction factors were used to calculate the emission level and compare reading to the applicable limit. If EUT emission level was less -2dB to the A.V. limit in Peak mode, then the emission signal was re-checked using Q.P and Average detector.


