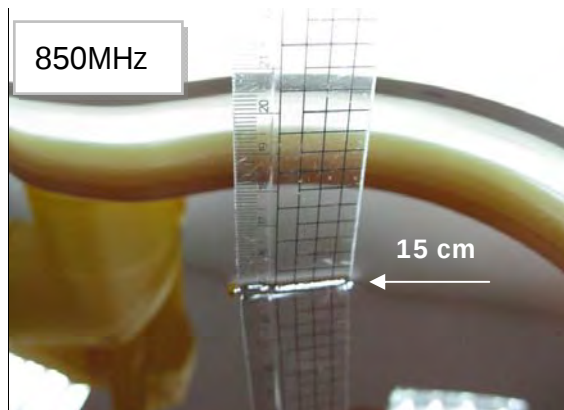

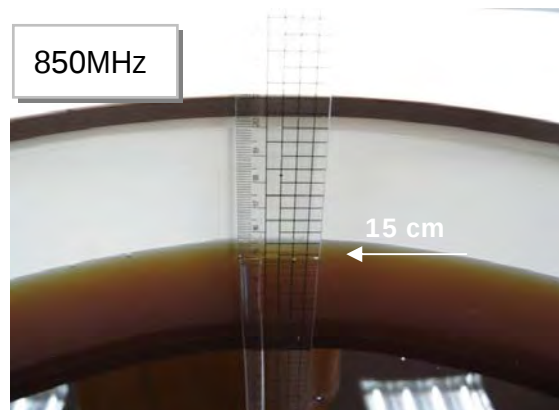

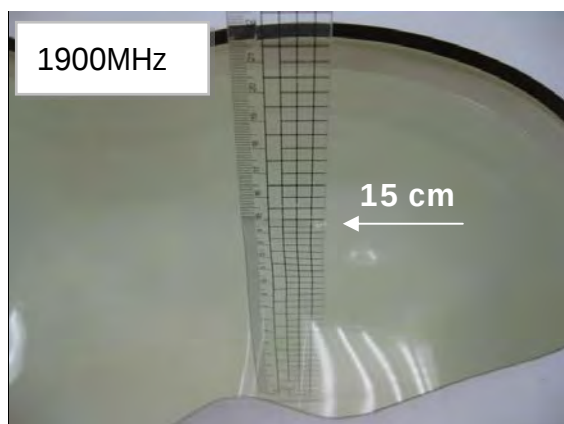

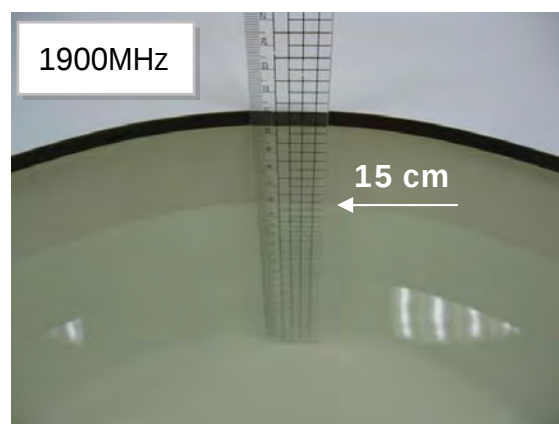

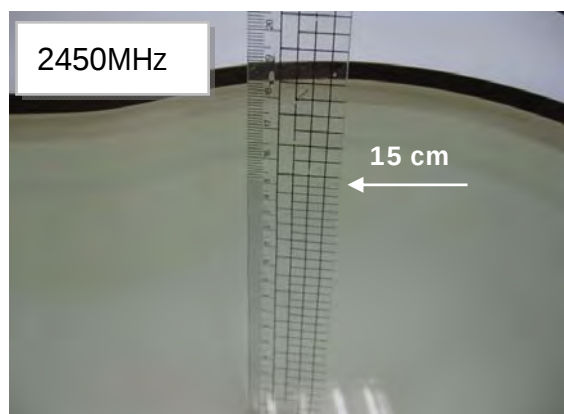

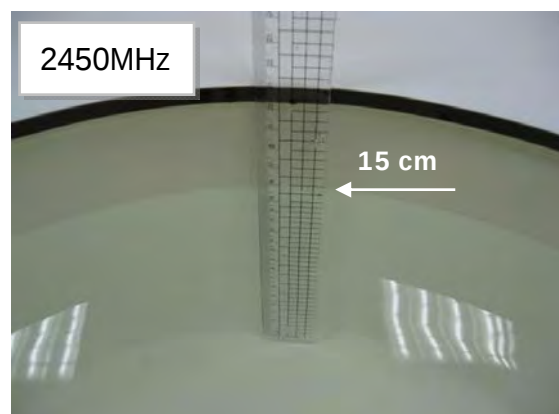

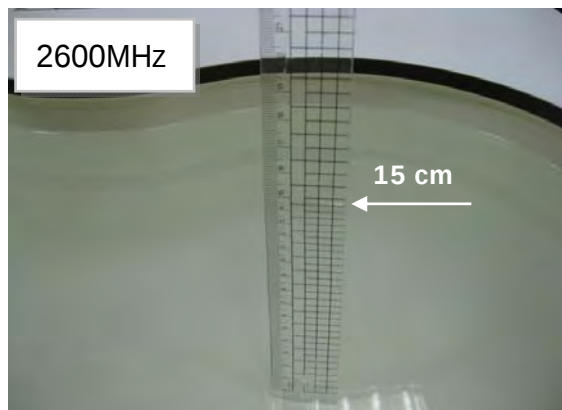

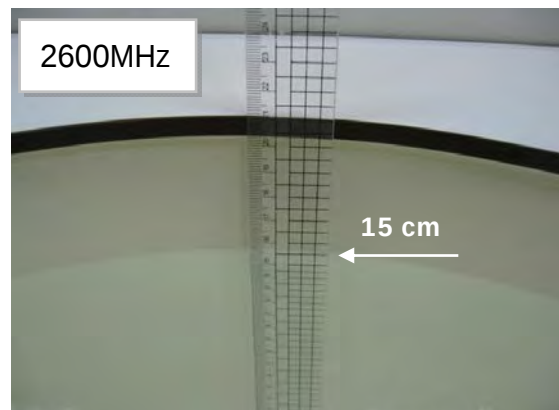

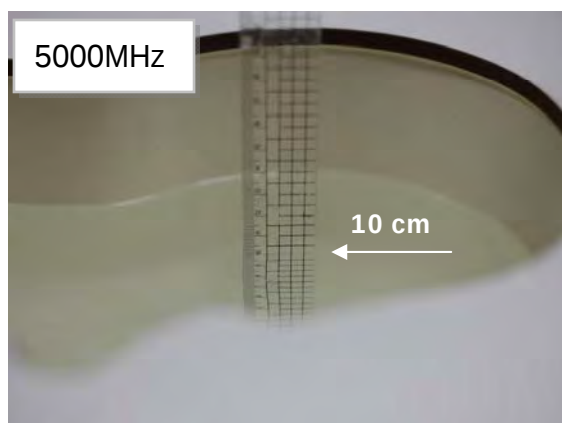

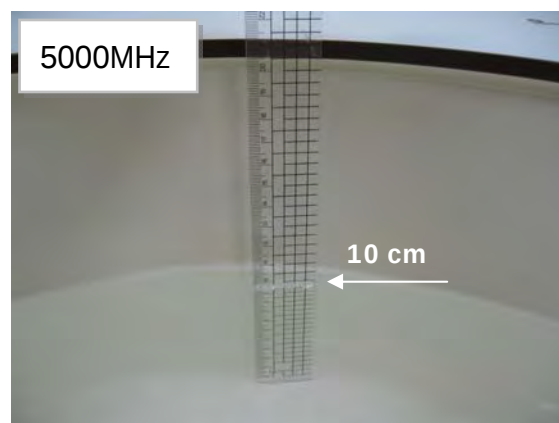

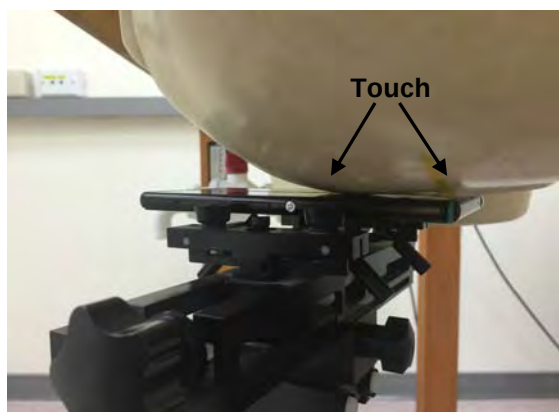


Fig.5 Left Head Section / Cheek-Touch Position

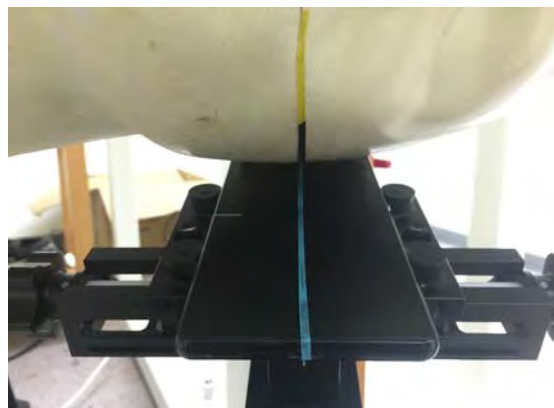
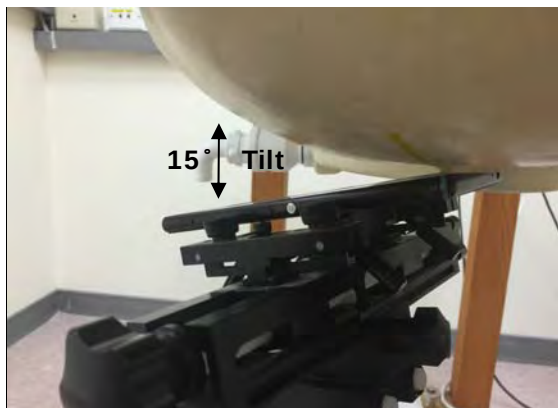


Fig.6 Left Head Section / Ear-Tilt Position(15°)

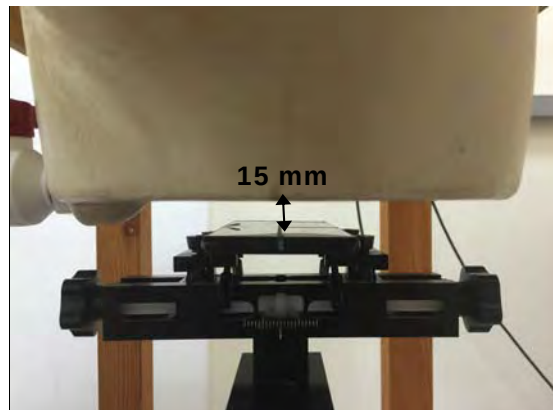


Fig.7 EUT front side to flat phantom

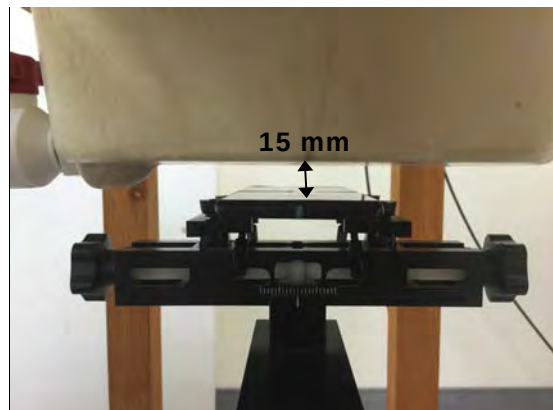


Fig.8 EUT back side to flat phantom

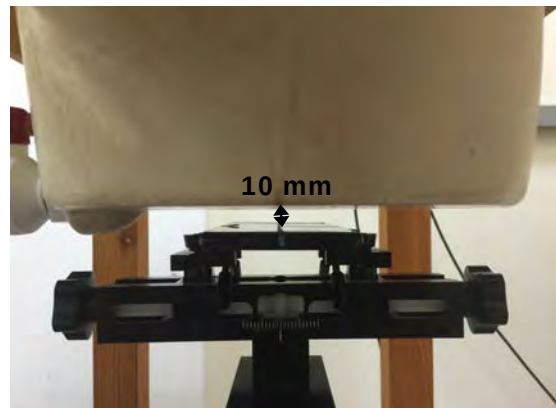


Fig.10 EUT back to flat phantom

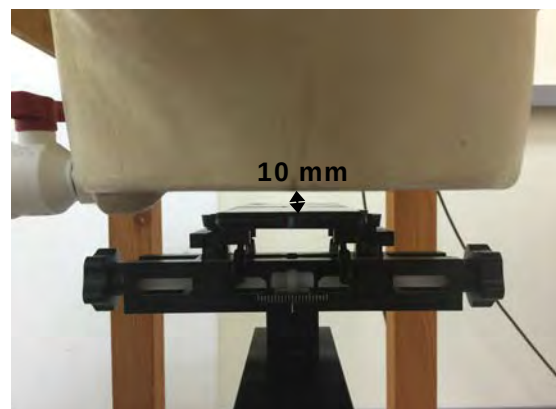


Fig.11 Back side with headset to flat phantom

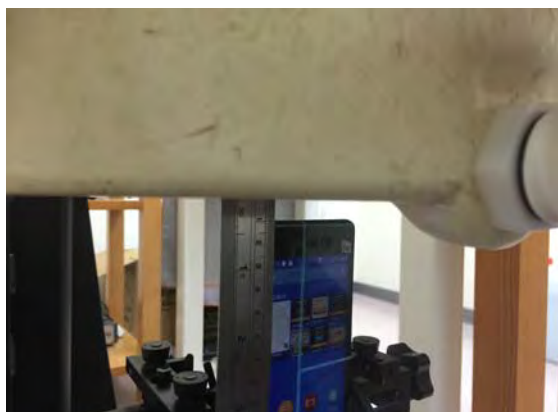
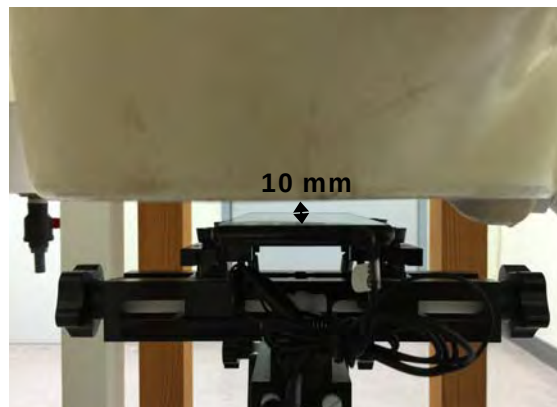


Fig.13 EUT top to flat phantom

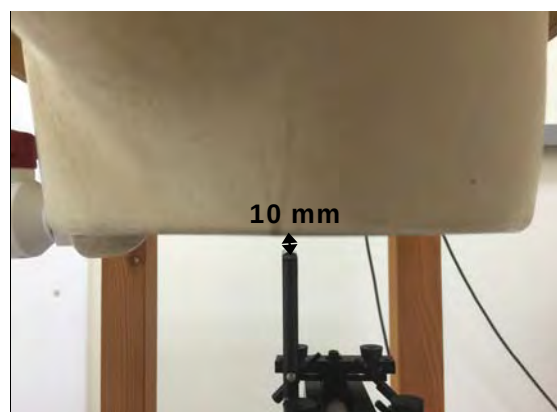
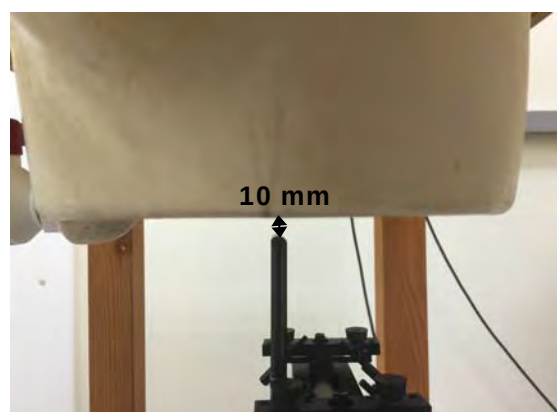


Fig.14 EUT bottom to flat phantom

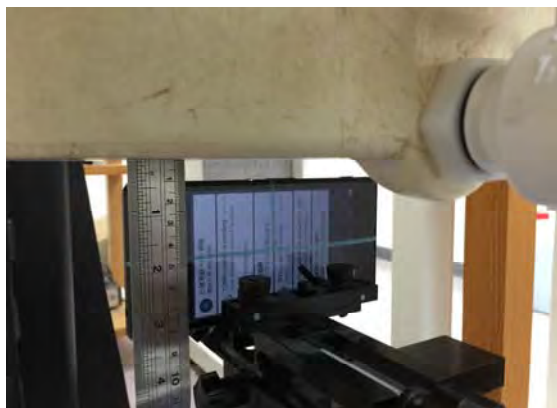


Fig.15 EUT right to flat phantom

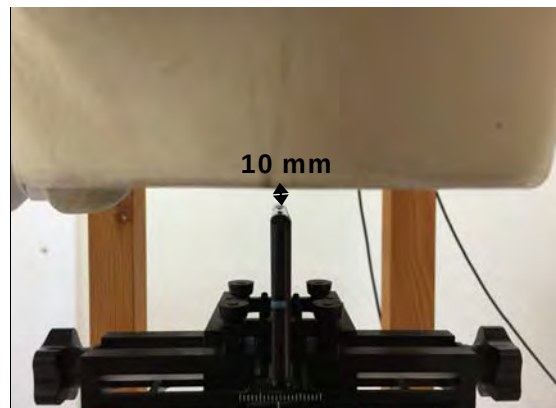
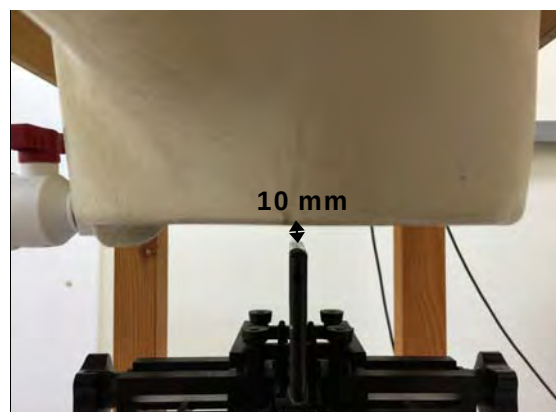


Fig.16 EUT left to flat phantom

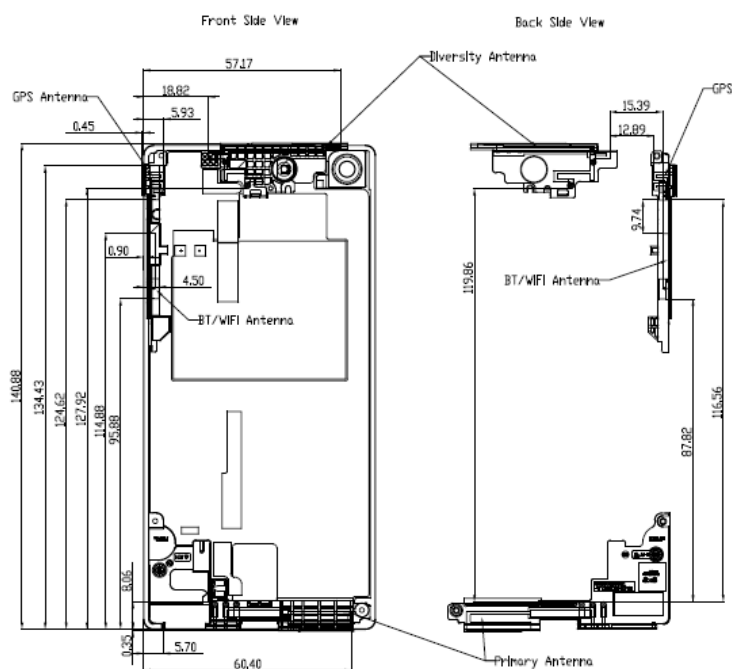


Fig.20 Antenna position of EUT

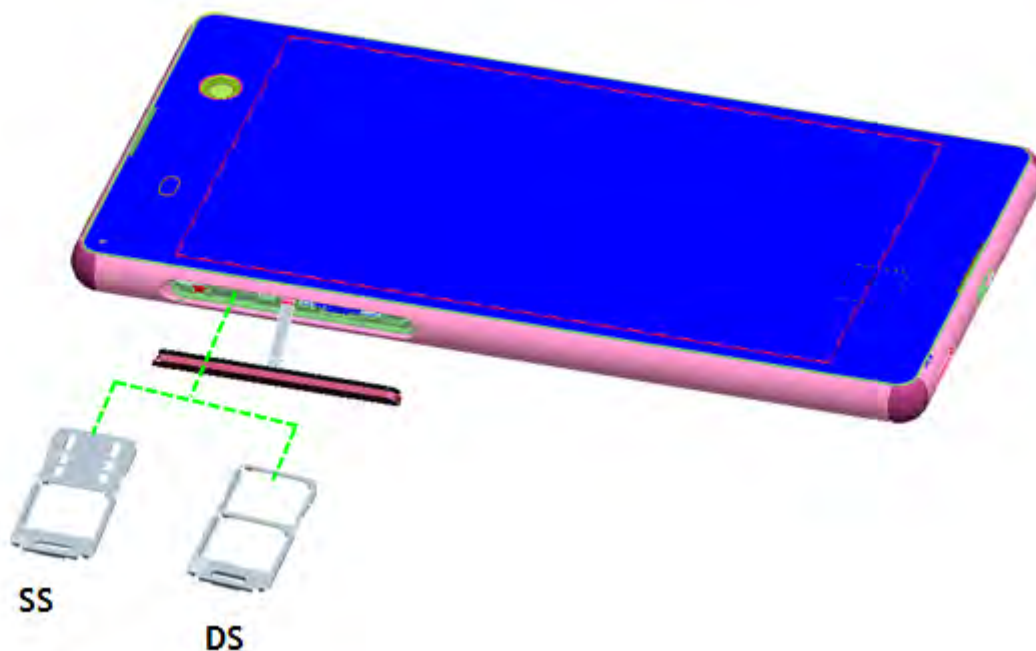


Fig.21 SIM Tray difference
