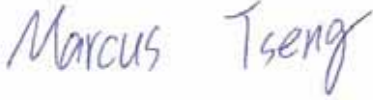
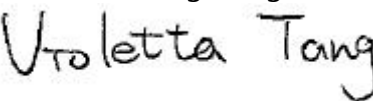
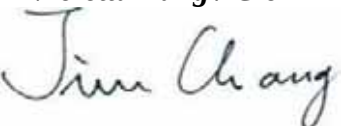

And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. Fig. 2-3 AC Power Line Conducted Emission

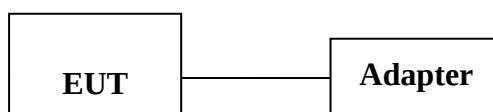

Channel Low, Mid and High with highest rated data rate were chosen as worst case for full testing. In comparison with BR and EDR mode, emission carried out by EDR is chosen as the most representative measurement to perform measurement of radiated spurious emission pursuant to Part 15C. 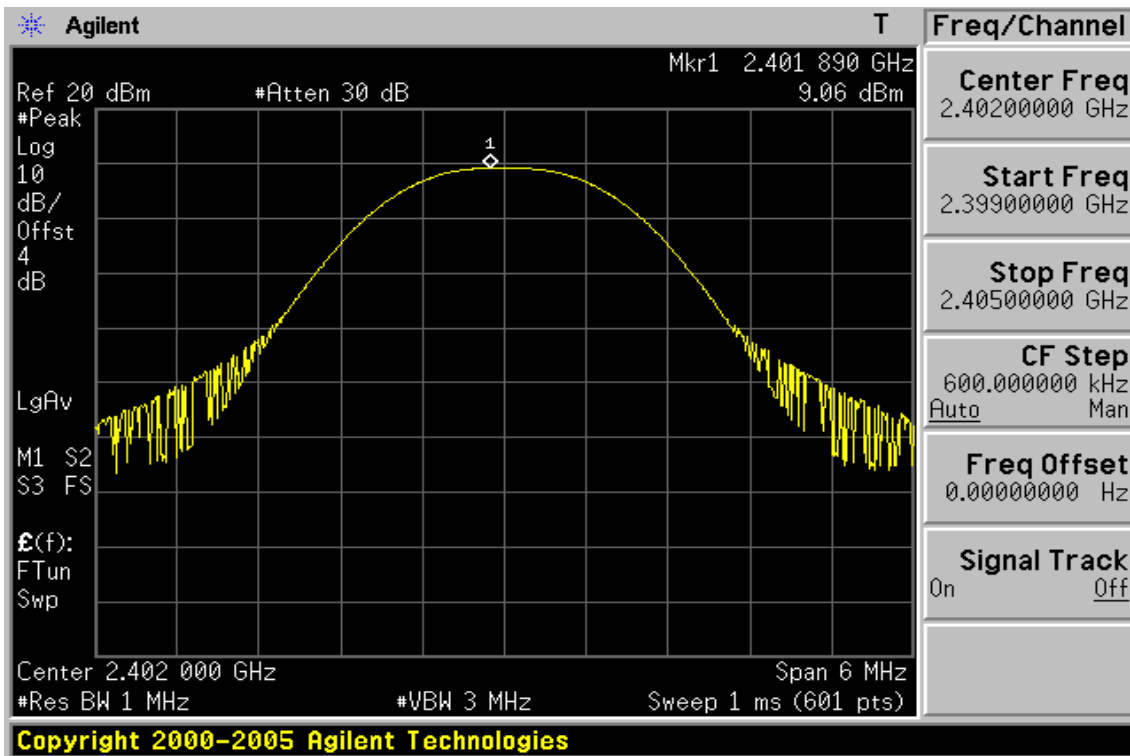

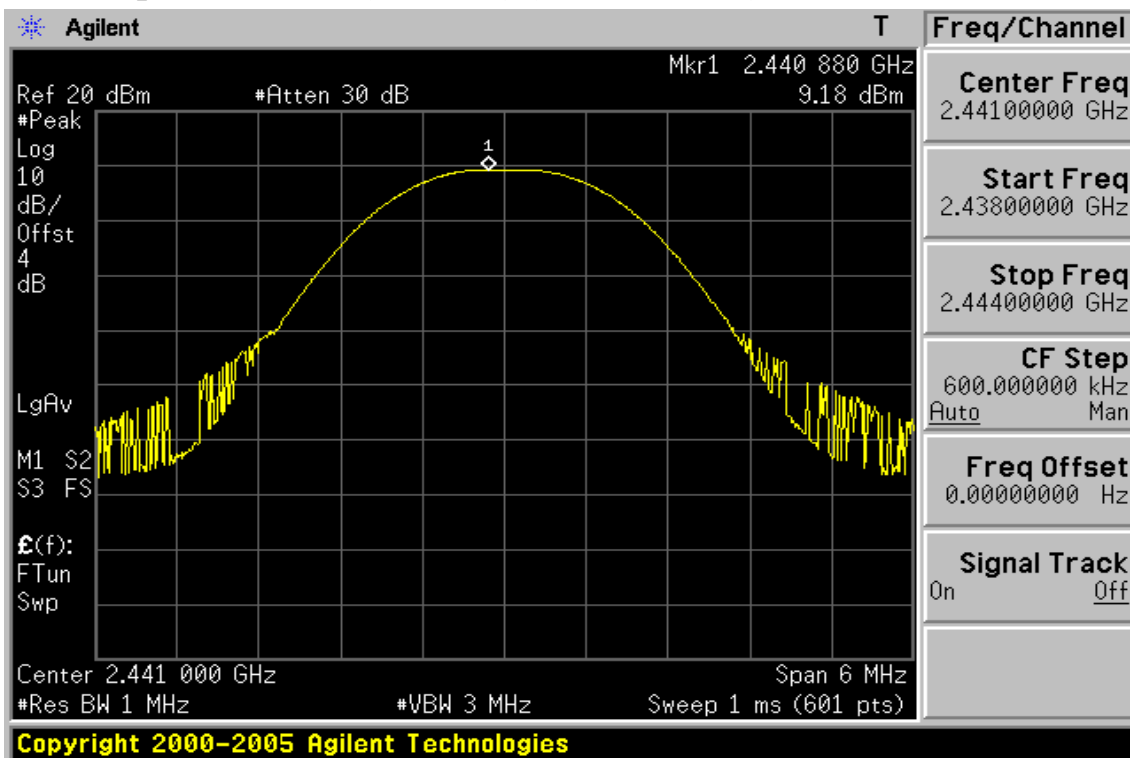

## Peak Power Output Data Plot (CH Mid) (1M BR mode)

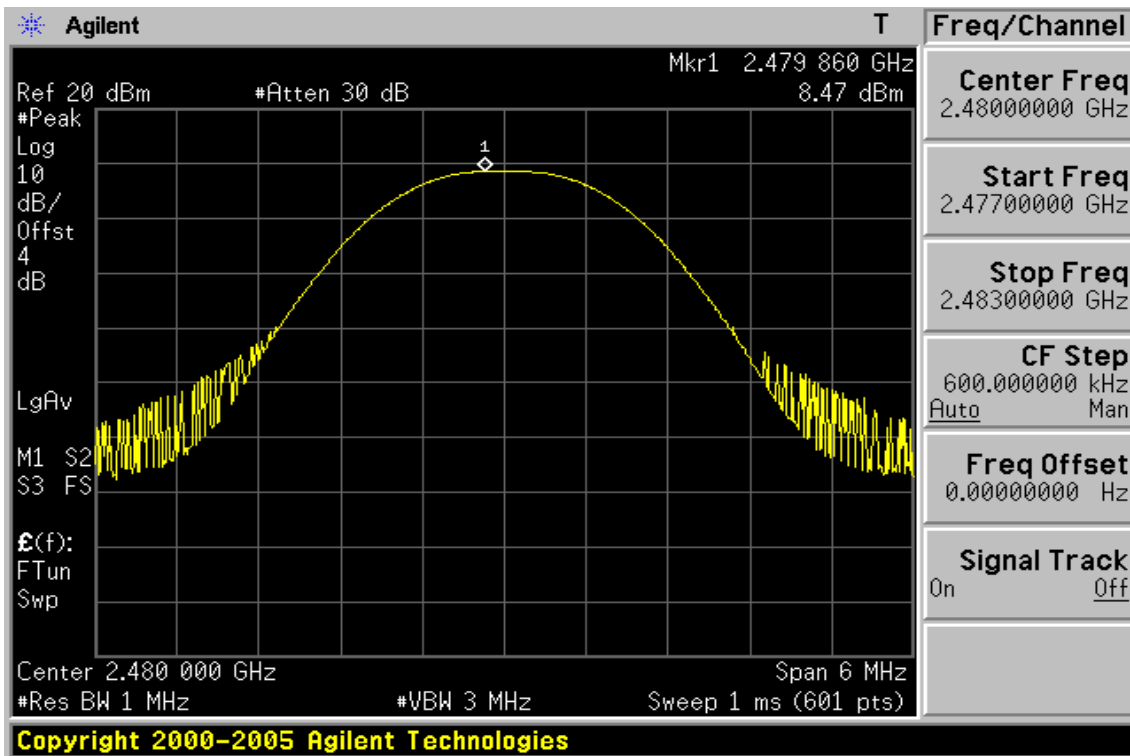

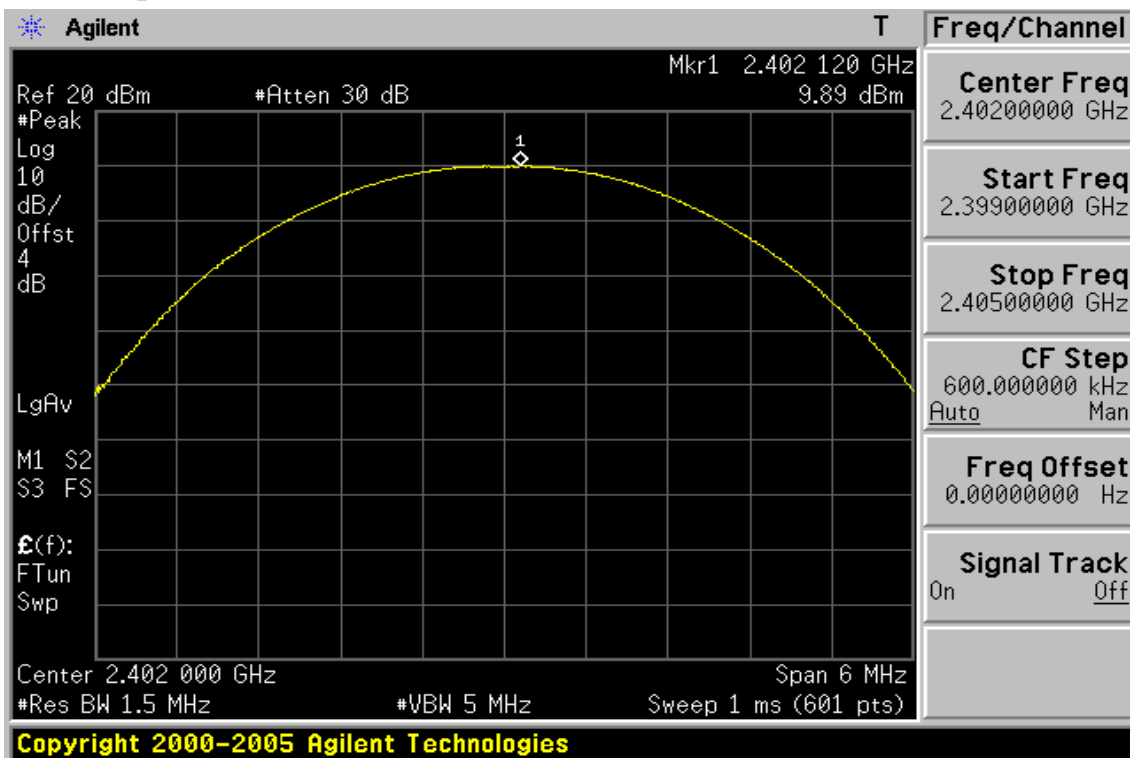

## Peak Power Output Data Plot (CH Low) (2M EDR mode)

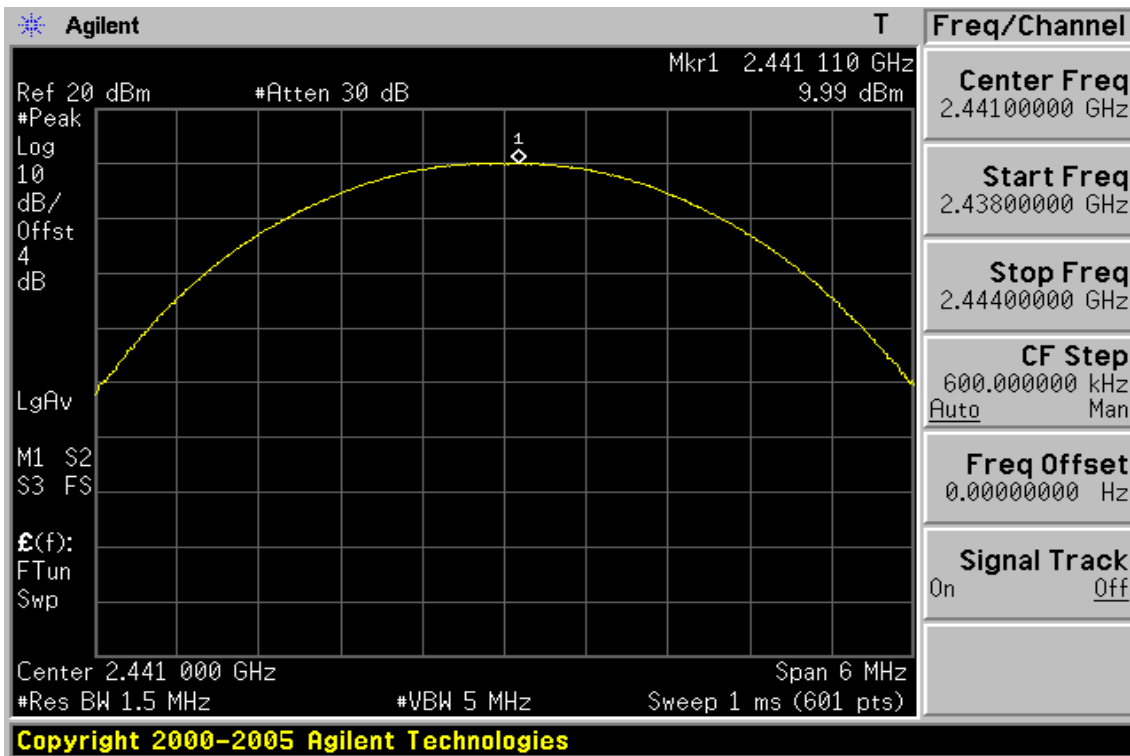

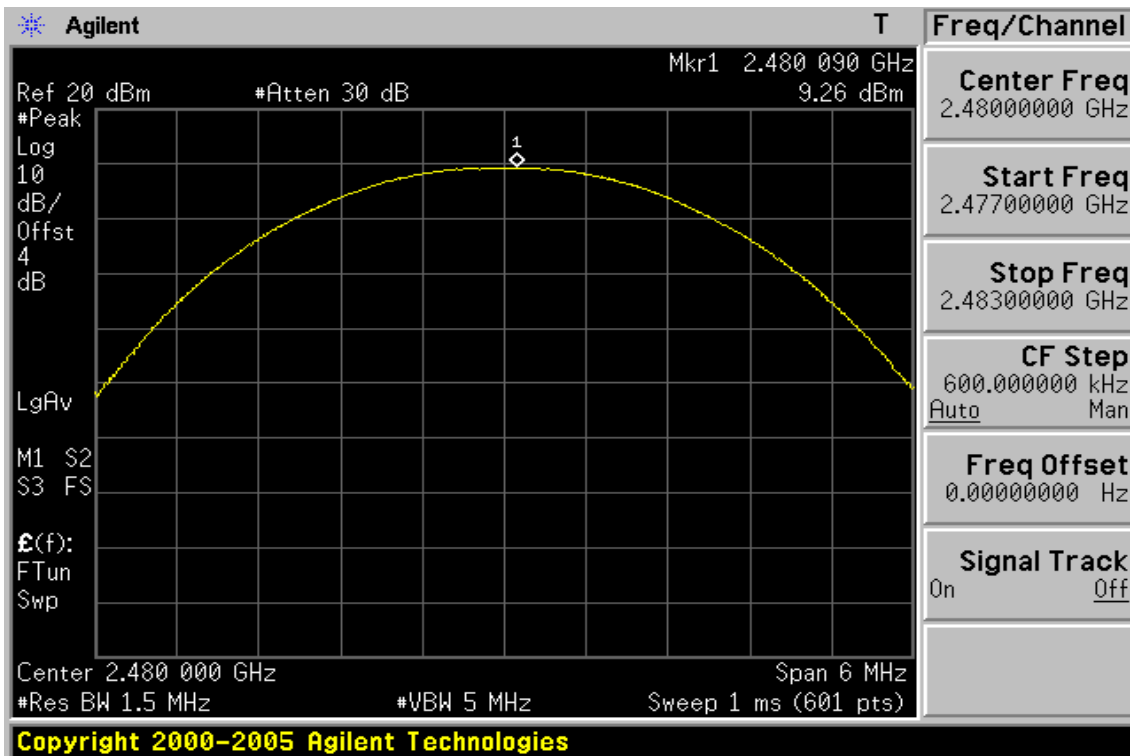

## Peak Power Output Data Plot (CH High) (2M EDR mode)

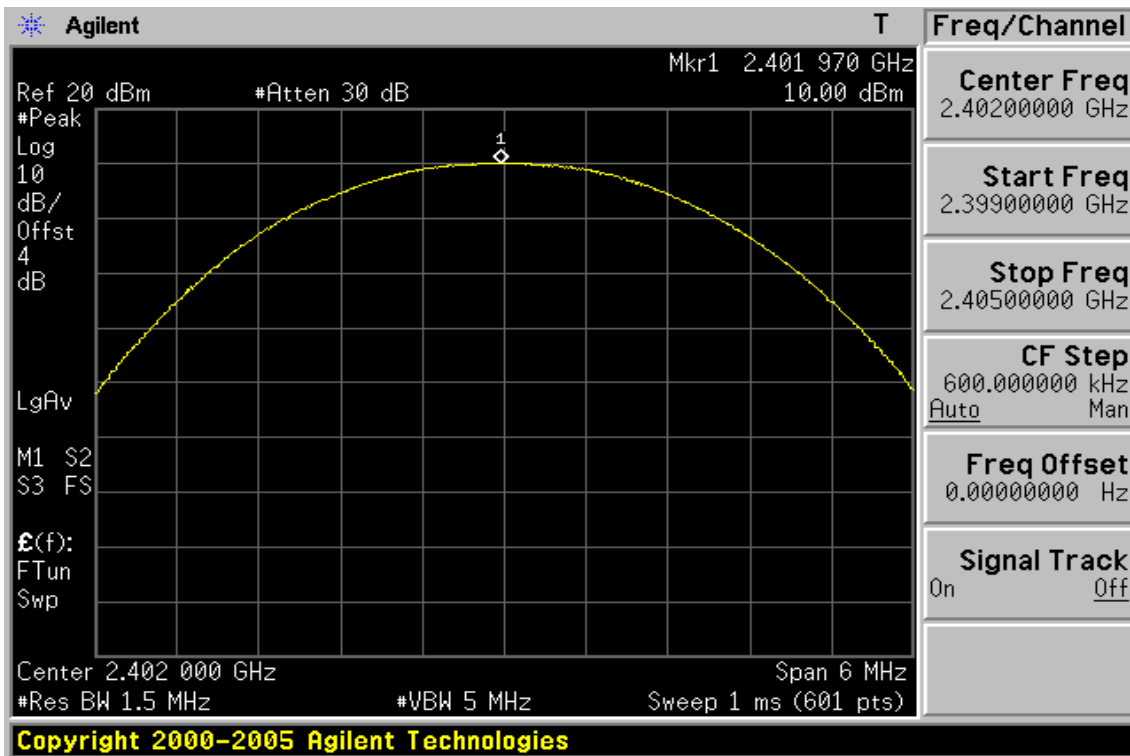

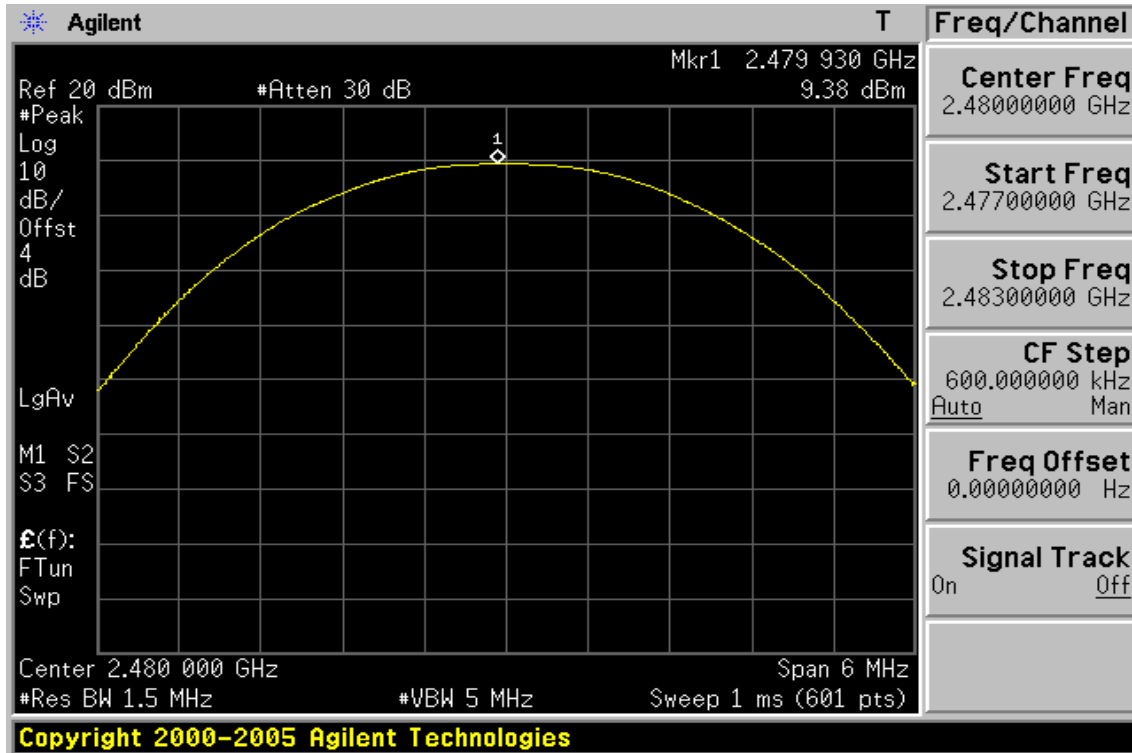

3. Sweep the frequency to determine spurious emission as seen on spectrum from span of 30MHz to 3G, 3G to 8G, 8G to 13G, 13G to 18G and 18G to 26.5GHz
4. Via Software, combine 5 spans of frequency range into two plots containing the range of 30MHz to 3GHz, and 3GHz to 26.5GHz.

### 10.1. Standard Applicable

According to §15.247(d),

Emission at antenna port:

In any 100 kHz bandwidth outside the frequency band in which the spread spectrum or digitally modulated intentional radiator is operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. If the transmitter complies with the conducted power limits based on the use of RMS averaging over a time interval, as permitted under paragraph (b)(3) of this section, the attenuation required under this paragraph shall be 30 dB instead of 20 dB.

#### Radiated Spurious Emission

Attenuation below the general limits specified in § 15.209(a) is not required. In addition, radiated emissions which fall in the restricted bands, as defined in § 15.205(a), must also comply with the radiated emission limits specified in § 15.209(a) (see § 15.205(c)).

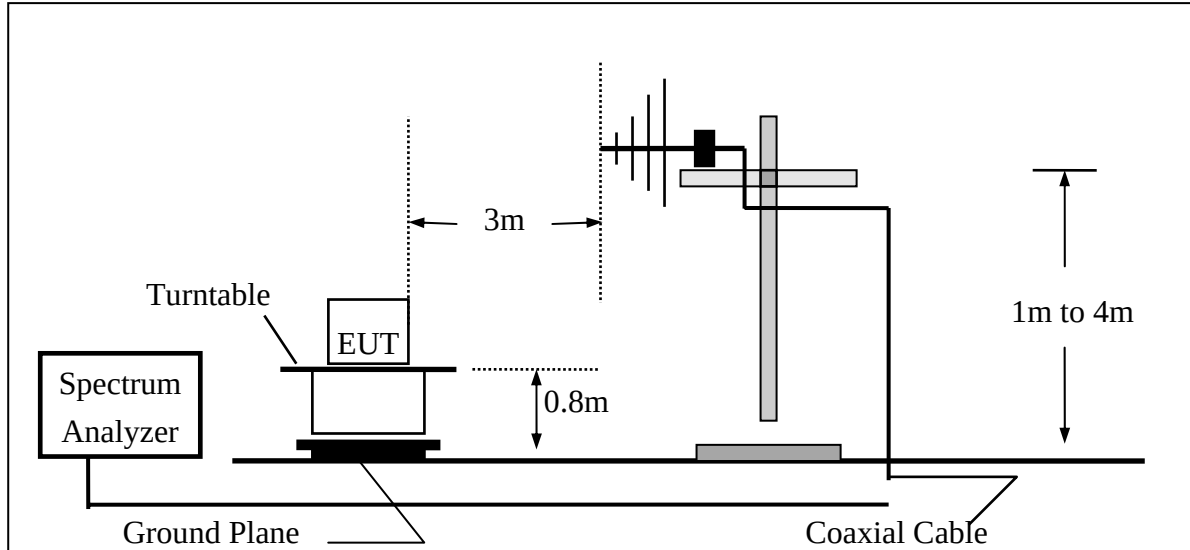

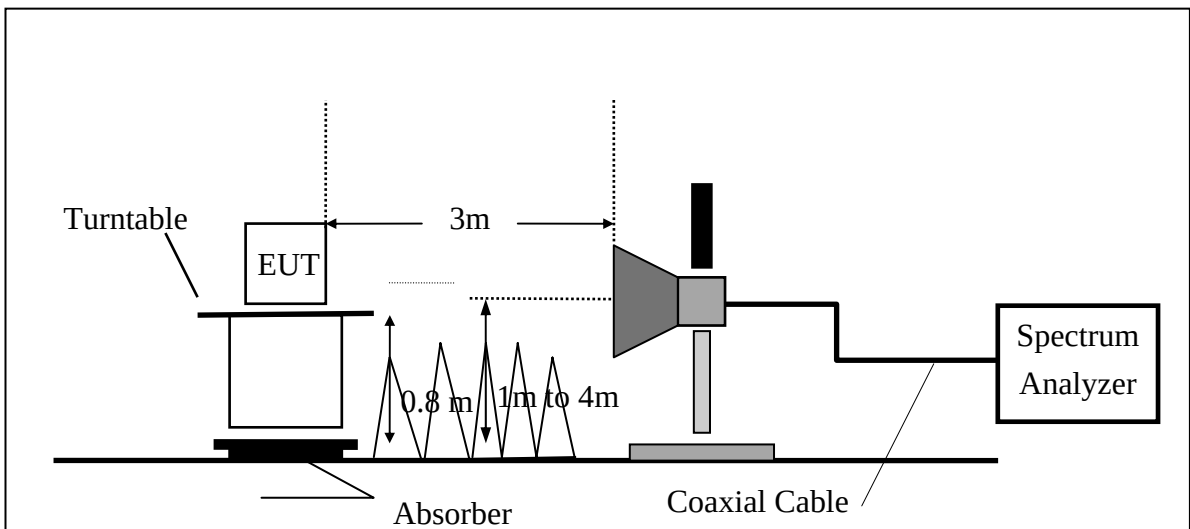

#### 10.4. Measurement Procedure:

##### Radiated Emission:

1. The EUT was placed on a turn table which is 0.8m above ground plane.
2. The turn table shall rotate 360 degrees to determine the position of maximum emission level.
3. EUT is set 3m away from the receiving antenna which varied from 1m to 4m to find out the highest emissions.
4. When measurement procedures for electric field radiated emissions above 1 GHz the EUT measurement is to be made “while keeping the antenna in the ‘cone of radiation’ from that area and pointed at the area both in azimuth and elevation, with polarization oriented for maximum response.” is still within the 3dB illumination BW of the measurement antenna.
5. Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
6. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.
7. Repeat above procedures until all frequency of the interest measured were complete.
