BATTERY WARNING:

- Do not mix alkaline, standard, or rechargeable batteries.
- Batteries are to be inserted with correct polarity.
- Clean battery and product contacts prior to battery installation.
- Do not short-circuit supply terminals.
- Only the recommended batteries or equivalent are to be used, volts and size.
- Remove batteries when product is stored for long periods of time or when batteries are exhausted.

PROBLEM SOLVING:

Battery Installation

Note: this step is only needed if replacing battery

1. Locate the battery compartment door back of Parent Unit
2. Slide battery door off
3. Remove battery
4. Insert new battery and replace battery door.

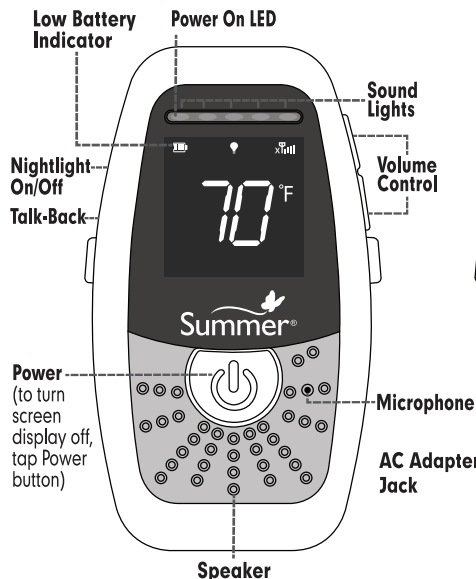

Summer Infant, Inc. Monitor Warranty Policy

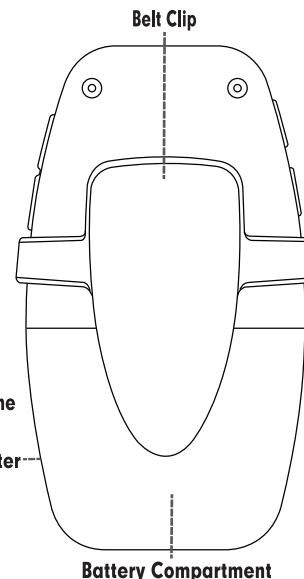

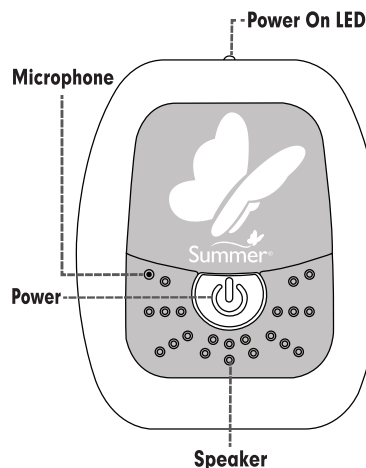
PARENT UNIT (Receiver):



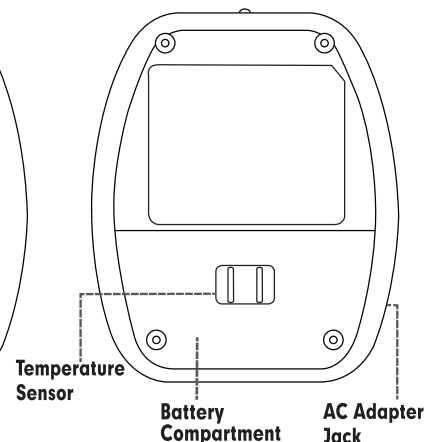
PARENT UNIT (Back View):



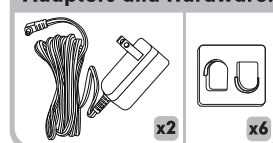
BABY UNIT (Transmitter):

Initial Setup:

To set up the system, you will need two adults. One adult should be in the nursery with the Baby Unit (transmitter) while the other is in a different room with the Parent Unit (receiver).

Note: The Parent Unit includes a rechargeable battery and it should be fully charged before using the monitor in portable mode. Charge the battery for 12-16 hours. When the unit is fully charged, the LED under the On/Off switch will remain on until it is unplugged. After the initial 12-16 hour charge, only charge the battery when the battery is low to achieve optimal battery life.

Step 1: Place the Baby Unit in the nursery near the crib, on a flat surface, and ensure the cord is more than 3-feet from the crib and out of baby's reach. Plug the AC adapter into a standard electrical outlet.

Step 2: Press the power button on the front of Baby Unit for 4-seconds to turn the unit on.

Step 3: Place the Parent Unit in the room from which you want to monitor baby. Plug the AC adapter into a standard electrical outlet.

Step 4: Press the power button on the front of the Parent Unit for 4-seconds to turn it on.

Step 5: Have the adult in the baby's room speak at different levels to adjust the volume to the desired setting. The volume can be adjusted up or down using the Volume Control buttons on the side of the Parent Unit.

Baby Unit Setup in Nursery:

Place the Baby Unit (transmitter) on a flat surface, such as a bureau or shelf (Fig A). NEVER place the Baby Unit or cords within 3-feet of the crib. Secure the cord to the wall (Fig B) using the 6 security clips included to keep the cord away from baby's reach.

Syncing Baby and Parent Unit:

Note: This digital monitor set is pre-synced with security codes for privacy reasons. However, there are instances that the Baby and Parent unit will lose it's code and may require you to re-sync it.

Step 1: Connect the Baby unit to it's power supply and make sure unit is powered OFF.

Step 2: Turn ON Parent unit.

Step 3: Press and keep holding the "VOL +" button and at the same time press the POWER button for about 4 seconds. A continuous audible BEEP and red flashing lights will occur. The Parent unit is now ready to be synced.

Step 4: Within 20 seconds, turn on the Baby unit. A single BEEP will emit from the Parent unit to signify successful syncing.

SPECIAL FEATURES:

• **Two-way Communication:** Calm baby with the sound of your voice or use as a convenient way to remind each other of something needed from the nursery. By speaking into the handheld unit your voice is projected through the unit in baby's room, so you can give comfort and reassurance, or gentle reminders, from another room.

• **Nightlight:** Create an ambient glow for baby's room with the butterfly nightlight right on the monitor. The nightlight provides a convenient way for parents to sneak a peek of baby in a dark room and the remote control from the parent handheld unit makes it easy to turn it on or off for baby's sleeping comfort.

• **Temperature Monitoring:** Monitoring the temperature in baby's room is easy with the option to display it on screen and help parents know baby is comfortable. Press and hold the nightlight button for 4-seconds to switch between Fahrenheit and Celsius.

• **Sound Lights:** The monitor lets you not only hear your baby but with sound activated lights, parents can "see" the sound level coming from baby's room. Displayed on a color bar, the color changes as the sound level changes; moving from green to amber to red as the sound level increases. These lights can be especially helpful for parents when they are in a noisy or crowded room.

• **Adjustable Volume:** Volume adjustments allow parents to monitor baby's sounds at multiple levels accommodating preferences for hearing very low level sounds to monitoring only louder sounds and cries only. The higher volume settings allows parents to hear even very low sounds coming from baby's room, such as the baby cooing while the lower volume settings monitors louder sounds and cries.

• **Sensitive Microphone:** The high sensitivity microphone allows parents to hear low level sounds coming from baby's room as well as the louder sounds and crying, giving them peace of mind know they will be able to hear baby day and night. The microphone focuses on baby's sounds while filtering background, ambient noises enabling a clear connection to the parent unit.

• **Out of Range Indicator:** If the Parent Unit is too far away from the Baby Unit, it will be "out of range" and the monitor (parent unit) will emit 4 consecutive beeps. The beeps will continue until the Parent Unit is moved back within range of the Baby Unit.

• **Low Battery Indicator:** If the Parent Unit is low on battery power, the unit will emit a beeping sound. The low battery will continue to beep until the unit is plugged in.

• **Belt Clip:** Added convenience and portability is provided with a built-in belt clip on the Parent Unit. This feature allows parents a convenient way to keep the unit with them as they move throughout the house, with up to a 650-foot range.

PROBLEM SOLVING:

No sound coming from the speaker

- Make sure both the Baby Unit and Parent Unit are plugged in and powered on.
- Make sure electrical outlets are working.
- Set volume to a higher setting.

Static

- Move the Parent Unit closer to the Baby Unit

Squealing Noise

- Move the Parent Unit and Baby Unit farther apart, the squealing sound indicates the units are too close together
- Turn down the volume on Parent Unit.

Weak reception or no reception

- Make sure both Parent Unit and Baby Unit are turned on.
- Move the Parent Unit closer to the Baby Unit.
- Make sure the battery in the Parent Unit is fully charged.
