

Section 2. Equipment Under Test (E.U.T.)

Description of EUT

The iX104 tablet Pc incorporates a Qcom Bluetooth® radio along with a wireless Intel 802.11 a/g/n network adapter and an Option NV GSM/UMTS network adapter operating in the 850 cell band or the 1900 PCS band. The network adapters will not be functional at the same time. The Bluetooth module can operate simultaneously with either of the wireless network adapters.
