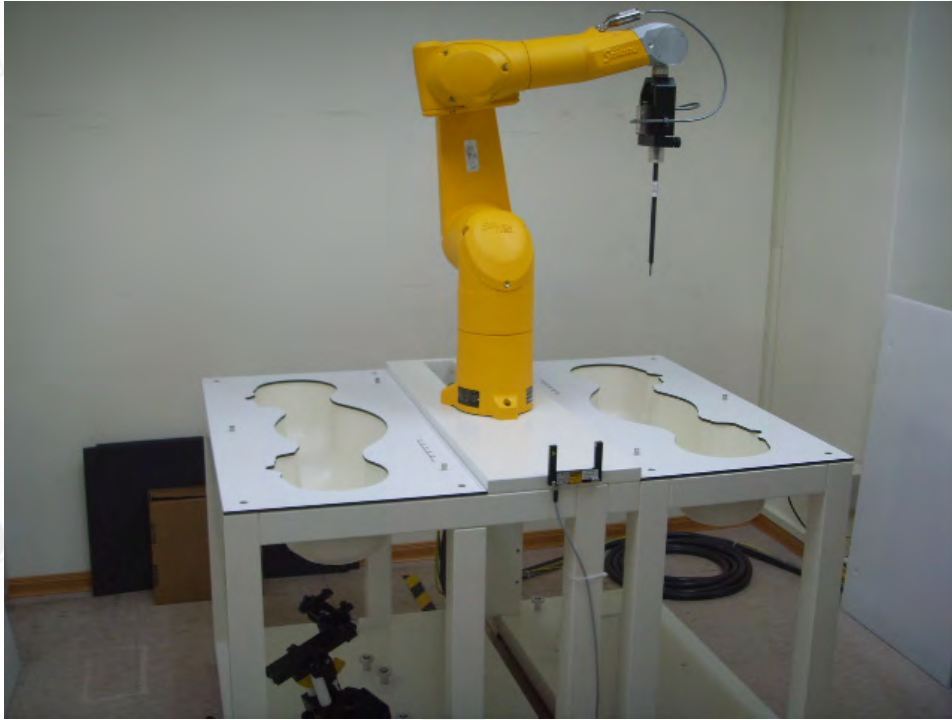


Fig.1 Photograph of the SAR measurement System

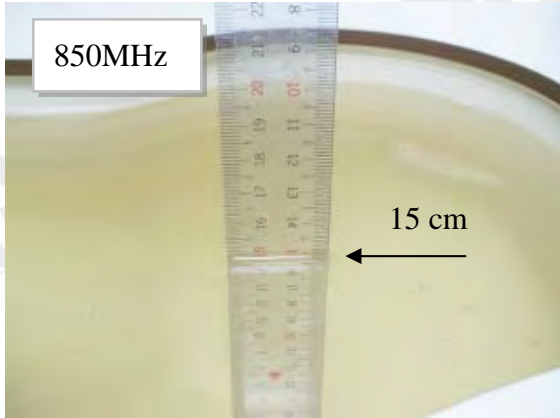


Fig.2.1 Left-head Side

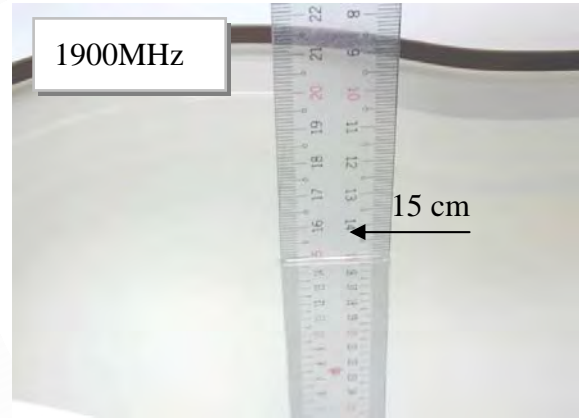


Fig.2.2 Right-head Side

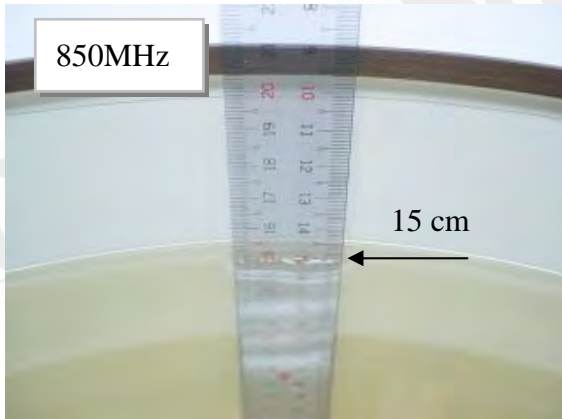


Fig.2.3 Flat (Body)

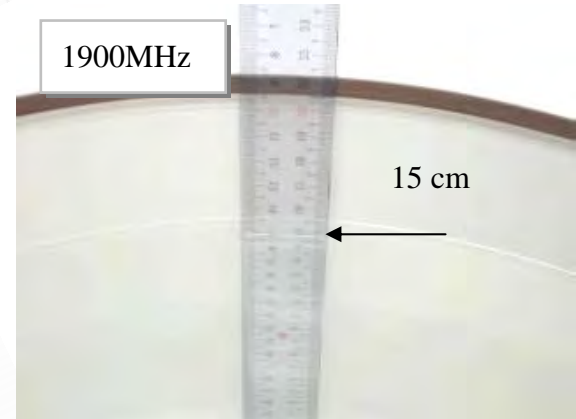


Fig.2.4 Flat (Body)

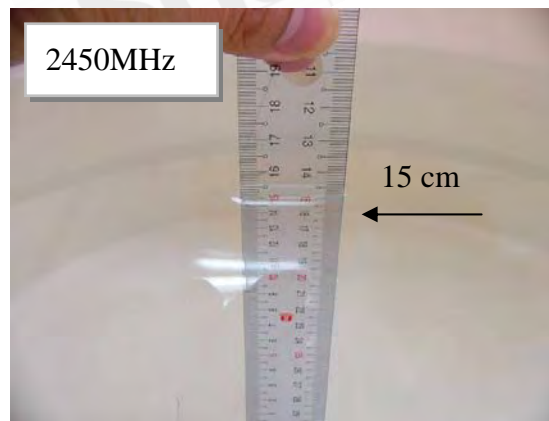


Fig.2.5 Flat (Body)

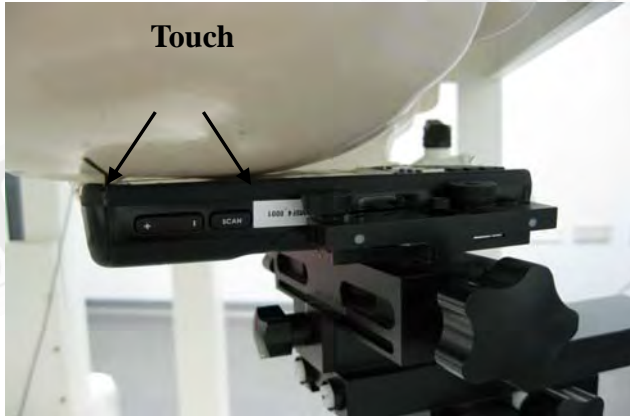


Fig.3 Right Head Section / Cheek-Touch Position

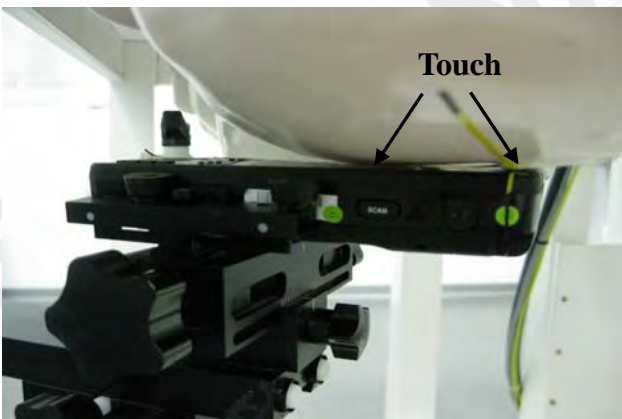


Fig.5 Left Head Section / Cheek-Touch Position

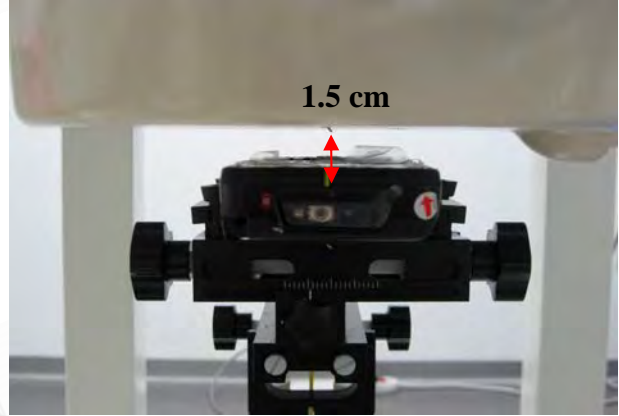


Fig.7 EUT front to flat phantom

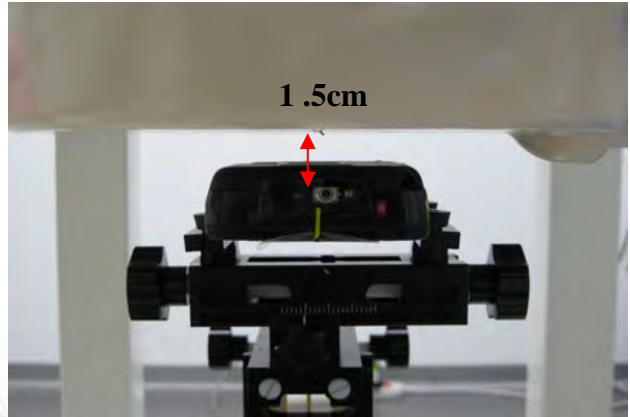


Fig.8 EUT back to flat phantom

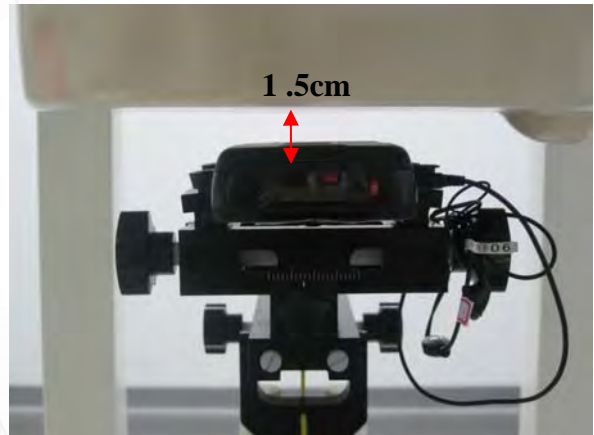


Fig.9 EUT back to flat phantom (With headset)
